Mr. Ernie Mosher of the League of Municipalities discussed general powers for county governments and creating departments of public works. Senator Gaar appointed Senator Thomas as Chairman of sub-committee to investigate this. Senator Booth is to be co-worker. This Senate Concurrent Resolution is to be ready three weeks from today.
