Chairman Norman E. Gaar called the meeting to order.

Discussion on S.B. 551. Senator Pomeroy made the motion to amend this by striking line 8, page 1, "five (5) years one (1) year" and inserting "three (3) years". Senator Robinson seconded. Vote 9-0. Carried. S.B. 551 is hereby amended. Senator Robinson made the motion to amend S.B. 551 regarding radio broadcasting. Senator Booth seconded. Vote 9-0. Carried. S.B. 551 is hereby amended. The motion to amend S.B. 551 regarding inserts was made and carried February 4, 1972. Senator Robinson will prepare these amendments for the secretary. S.B. 551 was voted favorable for passage as amended February 4, 1972.

S.B. 512 discussed. Committee asked that Mr. Baxter rework his suggested amendments and bring them back to the committee. Senator Pomeroy made the motion that S.B. 512 be amended regarding Mr. Baxters amendment on jurisdiction, to be inserted page 4, line 12 after the ending sentence. Senator Booth seconded. Vote 9-0. Carried S.B. 512 is hereby amended. Mr. Baxter to rework this. Senator Pomeroy made the motion to amend S.B. 512 by inserting on page 4, line 8, "1971 Supp." after word "K.S.A.". Senator Booth seconded. Vote 9-0. Carried. S.B. 512 is hereby amended. Discussion was held on the need to amend the age; any change was rejected. Further discussion will await the completed amendments being presented by Mr. Baxter.

Discussion was held on S.B. 602. Senator West is bothered with the usage of the word "competitive" bidding. Senator Gaar stated this bill would cover all cities including third class cities. Senator Pomeroy suggested after the word "required" on line 3, page 1, the committee insert the words "in all cases in which there is more than one supplier". Senator Gaar said the committee will have Mr. Ernie Mosher discuss this with the committee as a whole.

S.B. 508 and 509 are scheduled for hearing Thursday morning, 9:00, February 10, 1972.
