Sheriff Darr spoke to the committee on H.B. 1394 and stated that there should be some recommendations made so a referendum type vote could be held if the governor should veto this bill.

S.B. 691 discussed. Senator Thomas made the motion to report S.B. 691 adversely, with Senator Hinchey seconding. Vote 4-4, Chairman Gaar voting no, motion fails. Booth, West Hinchey & Thomas voteing aye on this motion. Senator Herd moved S.B. 691 be reported favorable for passage as amended, with Senator Robinson seconding. Vote 4-4. Chairman Gaar voting yes. Motion carried. S.B. 691 is hereby reported for favorable passage as amended.

S.B. 692 discussed. Senator Foster made the motion that S.B. 692 be reported adversely, with Senator Robinson seconding. Vote 10-0. Carried. S.B. 692 is hereby reported adversely.

S.B. 694 discussed. Senator Robinson made the motion that S.B. 694 be reported favorable for passage, with Senator Foster seconding. Vote 10-0. Carried. S.B. 694 is hereby reported favorable for passage.

S.B. 695 discussed. Senator Robinson made the motion that S.B. 695 be reported favorable for passage, with Senator Foster seconding. Vote 10-0. Carried. S.B. 695 is hereby reported favorable for passage.

S.B. 711 discussed. Senator Robinson has amendments to bring so committee will hold this until Monday.

S.B. 736 discussed. Senator Thomas made the motion that S.B. 736 be reported favorable for passage, with Senator Robinson seconding. Vote 10-0. Carried. S.B. 736 is hereby reported favorable for passage.

S.B. 655 discussed. Senator Thomas made the motion that S.B. 655 be reported favorable for passage, with Senator Herd seconding. Vote 10-0. Carried. S.B. 655 is hereby reported favorable for passage.

S.B.654 discussed. Senator Foster made the motion that S.B. 654 be reported favorable for passage, with Senator Thomas seconding. Vote 10-0. Carried. S.B. 654 is hereby reported favorable for passage.

S.B. 646 discussed. Senator Gaar will ask Senator Rogers to talk with the committee on this.

S.B. 609 discussed. Senator Thomas made the motion that S.B. 609 be reported favorable for passage, with Senator Robinson seconding. Vote 10-0. Carried. S.B. 609 is hereby reported favorable for passage.

S.B. 608 discussed. Senator Robinson made the motion to strike "for all older persons", with Senator Thomas seconding. Vote 10-0. Carried. S.B. 608 is hereby amended. Senator Thomas made the motion that S.B. 608 be reported favorable for passage as amended, with Senator Herd seconding. Vote 10-0 Carried. S.B. 608 is hereby reported favorable for passage as amended.

S.B. 678 discussed. Senator Saar made the motion to report S.B. 678 favorable for passage, with Senator Herd seconding. Vote 10-0, carried. S.B. 678 is hereby reported favorable for passage.

Mr. John Corkhill of KAPERS discussed S.B. 508 and 509 with the committee, and the Chairman suggested the committee will do further work on this.

Hearings are scheduled Tuesday and Wednesday of next week.
