Chairman Norman E. Gaar called the meeting to order.

Senator West brought the recommendations of the subcommittee for S.B. 508 and 509. Senator West made the motion that S.B. 509 be amended by a new substitute bill for 509 and that the bill be reported favorable for passage. Senator Hinchey seconding. Vote 10-0. Carried. Substitute Bill for S.B. 509 is hereby reported favorable for passage.

S.B. 508 will be tabled as per the subcommittee's recommendations.

S.B. 149 discussed. Senator Foster made the motion that S.B. 149 be reported favorable for passage, with Senator Robinson seconding. Vote 10-0. Carried. S.B. 149 is hereby reported favorable for passage.

S.B. 732 discussed. Senator Pomeroy heading a subcommittee reported suggested amendments to this bill and moved the amendments be adopted. Senator Hinchey seconding. Carried. Vote 10-0. S.B. 732 is hereby amended.

Senator Pomeroy made the motion that S.B. 732 be reported favorable for passage as amended, with Senator West seconding. Vote 10-0. Carried. S.B. 732 is hereby reported favorable for passage as amended.

S.B. 734 discussed. Senator Gaar will talk with Senator Smith on this.

S.B. 746 discussed. Senator Foster presented an amendment to this: On page 5, line 13, by striking "shall upon retirement or" and inserting in lieu thereof "who are retired on"; in line 14, by striking "whichever is later" and inserting in lieu thereof the word "shall". Senator Foster made the motion to amend S.B. 746 by this amendment, with Senator Robinson seconding. Vote 10-0. Carried. S.B. 746 is hereby amended.

Senator Pomeroy made the motion to amend S.B. 746 by deleting Section 13, and renumbering the remaining sections. ~~Vote 10-0~~ Carried. Vote 8-2. Carried. Senators Saar and Hinchey casting the No votes. S.B. 746 is hereby amended.

Senator Foster made the motion that S.B. 746 be reported favorable for passage as amended. Senator Booth seconded. Vote 10-0. Carried. S.B. 746 is hereby reported favorable for passage as amended.

S.B. 744 discussed. Senator West made the motion that S.B. 744 be reported favorable for passage with Senator Foster seconding. Vote 10-0. Carried. S.B. 744 is hereby reported favorable for passage.

S.B. 745 discussed. Senator West made the motion that S.B. 745 be reported favorable for passage with Senator Hinchey seconding. Vote 10-0. Carried. S.B. 745 is hereby reported favorable for passage.

S.B. 643 discussed. Senator West made the motion that S.B. 643 be reported favorable for passage with Senator Booth seconding. Vote 10-0. Carried. S.B. 643 is hereby reported favorable for passage.
