Hearings were held on governor appointees Mr. Ben P. Robinson to the Economic Development Commission and Mr. Eldon V. Danenhauer to the Public Employees Relation Board, Senator Thomas made the motion to approve Mr. Robinson's confirmation with Senator Booth seconding. Vote 8-0. Carried. Mr. Ben Robinson is hereby confirmed for appointment to the Economic Development Commission. Senator West made the motion to approve Mr. Danenhauer's confirmation with Senator Pomeroy seconding. Vote 8-0. Carried. Mr. Danenhauer is hereby confirmed for appointment to the Public Employees Relation Board.

Discussion on H.B. 2180. Senator Saar made the motion to report H.B. 2180 favorable for passage, with Senator Thomas seconding. Vote 8-0. Carried. H.B. 2180 is hereby reported favorable for passage.

H.B. 2172 discussed. Senator Pomeroy made the motion that H.B. 2172 be reported favorable for passage with the admonition to the Chairman to hold this on the calendar until he can see if it reconciles with the Ombudsman Bill. Senator Robinson seconding, Vote 6-2 with Senators Thomas and Ball casting the dissenting votes. Carried. H.B. 2172 is hereby reported favorable for passage.

H.B. 2142 discussed. Senator Thomas made the motion to report H.B. 2142 favorable for passage with Senator Tobinon seconding. Vote 8-0. Carried. H.B. 2142 is hereby reported favorable for passage.

H.B. 2141 discussed. Senator Pomeroy made the motion that H.B. 2141 be reported favorable for passage with Senator Robinson seconding. Vote 8-0. Carried. H.B. 2141 is hereby reported favorable for passage.

H.B. 2118 discussed. Senator Thomas made the motion to report H.B. 2118 favorable for passage with Senator Booth seconding. Vote 8-0. Carried. H.B. 2118 is hereby reported favorable for passage.

H.B. 2060 discussed. Senator Robinson made the motion to amend H.B. 2060 by striking on page 1, after the word "membership." on line 17, the words "A corporation, partnership, business trust, or association not operated for a profit, for the purposes of the definition of a Class A club shall only include such a corporation, partnership." and on page 2 by striking lines 1 through 4, and on page 2, line 31 by striking the semi colon after the word "purchases" and inserting a "period" and by striking "(Provided," and on page 3, by striking lines 1, 2, 2, "chase;) on line 4, and after the word "Provided" the word "(further)" and by striking all of "New Sec. 2" and by renumbering the sections. Senator Saar seconding, Vote 8-0. Carried. H.B. 2060 is hereby amended. Senator Hinchey made the motion that H.B. 2060 be reported favorable for passage as amended with Senator Robinson seconding. Vote 8-0. Carried. H.B. 2060 is hereby reported favorable for passage as amended.

H.B. 1996 discussed. Senator Robinson made the motion to report H.B. 1996 favorable for passage with Senator Pomeroy seconding. Vote 8-0. Carried. H.B. 1996 is hereby reported favorable for passage.
