Hearings were held on governor appointees Mr. Alan Neelly and Mr. Merle W. Staats, both appointees to the Public Employee Relation Board.

H.B. 1762 discussed. Senator Hinchey made the motion to adopt the amendments suggested by the League of Municipalities with Senator Robinson seconding. Vote 6-0. Carried. H.B. 1762 is hereby amended. Senator Hinchey made the motion to report H.B. 1762 favorable for passage as amended with Senator Booth seconding. Vote 6-0. Carried. H.B. 1762 is hereby reported favorable for passage as amended.

H.B. 1806 discussed. Senator Foster made the motion to restore the amendments in the bill saying it did not make sense to make state people finance their own travel. Senator Booth seconded. Vote 6-0. Carried. H.B. 1806 is hereby amended. Senator West made the motion to report H.B. 1806 favorable for passage as amended with Senator Booth seconding. Vote 6-0. Carried. H.B. 1806 is hereby reported favorable for passage as amended.

H.B. 1821 discussed. Senator West made the motion to report H.B. 1821 favorable for passage with Senator Hinchey seconding. Vote 6-0. Carried. H.B. 1821 is hereby reported favorable for passage.

H.B. 1825 discussed. Hold.

H.B. 1859 and 1860 discussed. Senator Pomeroy made the motion to report H.B. 1859 favorable for passage with Senator Robinson seconding. Vote 6-0. Carried. H.B. 1859 is hereby reported favorable for passage. Senator Pomeroy made the motion to report H.B. 1860 favorable for passage with Senator Robinson seconding. Vote 6-0. Carried. H.B. 1860 is hereby reported favorable for passage.

H.B. 1784 discussed. Senator Pomeroy made the motion to report H.B. 1784 favorable for passage with Senator West seconding. Vote 6-0. Carried. H.B. 1784 is hereby reported favorable for passage.

H.B. 1776 discussed. Senator Pomeroy made the motion to amend H.B. 1776 on page 1, by striking all of lines 1 to 20, inclusive; on page 2, by striking all of lines 1 to 5, inclusive; in lines 6 and 7 by renumbering sections 2 and 3 as sections 1 and 2, respectively, in line 8, by striking "statute book" and inserting "official state paper"; and in the title, line 2, by striking all after the semicolon; by striking all of line 3 and inserting in lieu thereof "and repealing K.S.A. 12-1612." Senator West seconding the motion. Vote 7-1, with Senator Thomas casting the dissenting vote. Carried. H.B. 1776 is hereby amended.

Senator Pomeroy made the motion to report H.B. 1776 favorable for passage as amended with Senator West seconding. Vote 7-0. Carried. H.B. 1776 is hereby reported favorable for passage as amended.

H.B. 2179 discussed. Senator Pomeroy made the motion to report H.B. 2179 favorable for passage with Senator West seconding. Vote 8-0. Carried. H.B. 2179 is hereby reported favorable for passage.

H.B. 1877 discussed. Senator Thomas made the motion to report H.B. 1877 adversely, saying this needs to be studied for another year. Senator Robinson seconded. Vote ~~8-0~~ 8-1 with Senator Booth casting the dissenting vote. Carried. H.B. 1877 is hereby reported adversely.

H.B. 2117 discussed. Senator Pomeroy made the motion to amend H.B. 2117 by the suggested amendments of Mr. Dale Sprague and Senator West seconded. Vote 9-0. Carried. H.B. 2117 is hereby amended.

Senator Robinson made the motion to report H.B. 2117 favorable for passage as amended with Senator Pomeroy seconding. Vote 10-0. Carried. H.B. 2117 is hereby reported favorable for passage as amended.

H.B. 1290 discussed. Senator Pomeroy presented the suggested amendments from Charles Wright and Jim Yount and made a conceptual motion that the committee broaden this to include KAPE and other unions and credit unions. Senator Pomeroy will have bill drafting work this up for the bill. Senator Robinson seconded the conceptual motion, vote 10-0. Carried. H.B. 1290 is hereby amended.

Senator Pomeroy made the motion to report H.B. 1290 favorable for passage as amended with Senator Robinson seconding. Vote 10-0. Carried. H.B. 1290 is hereby reported favorable for passage as amended.

H.B. 1729 discussed. Senator Pomeroy made the motion to report H.B. 1729 adversely with with Senator Robinson seconding. Vote 10-0. Carried. H.B. 1729 is hereby reported adversely.
