Following a call to order by Chairman Joseph C. Harder, Senator Angell moved and Senator Bogina seconded a motion to approve minutes of the Committee meetings of March 21 and March 23. The motion carried.

SB 334 - Establishment of Johnson county area vocational-technical school

When the Chairman called for discussion and/or action on SB 334, Senator Bogina said that although he felt that Johnson County has a need for a Type II area vocational-technical school, due to current economic conditions he would recommend amending the bill so as to postpone implementation until the 1984-85 school year.

Committee discussion which followed indicated that currently a study is underway regarding Type I and Type II area vocational schools and that the study, when completed, would provide the Committee with information which would give members a better insight as to the statewide needs for these vocational schools.

Senator Warren moved to amend the bill so as to delay implementation of a Type II area vocational-technical school in Johnson County until July 1, 1985. This motion was seconded by Senator Rehorn, and the amendment was adopted.

Senator Warren offered a motion to amend SB 334 by placing a moratorium on Type I vocational schools using language similar to that contained in SB 424. This motion was seconded by Senator Bogina, and the amendment was adopted.

Senator Montgomery then moved to amend SB 334 by removing the statewide moratorium on Type II area vocational-technical schools effective July 1, 1985. This was seconded by Senator Bogina, and the amendment was adopted.

Senator Bogina then moved and Senator Allen seconded the motion to recommend SB 334, as amended, favorably for passage, and the motion carried.

SB 424 - Vocational education, restriction on establishment of area vocational schools

Senator Bogina moved to recommend SB 424 favorably for passage, and this was seconded by Senator Rehorn. The motion carried.

The Chairman adjourned the meeting.
