Mr. Clarence Rupp testified in favor of SB 340, stating that if this measure is enacted, there will be an increase in the number of delegates for the district conventions. He also stated that every 12 years there will be no statewide office on the primary ballot, as the statute now reads.

Questions were asked and a general discussion was held.

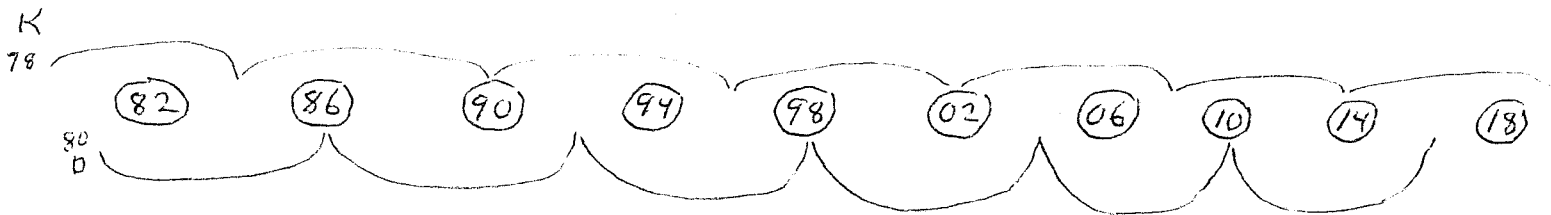
Motion was made by Senator Talkington and seconded by Senator Meyers to favorably pass SB 338. The motion was adopted.

Motion was made by Senator Talkington and seconded by Senator Johnston to adopt the minutes of February 21. The motion was adopted.

The numbers encircled above are the years when there will be a primary election for governor, attorney general and other state elective offices.

The line starting with the letter "K" shows the years when there will be a primary election for the U. S. Senate seat now held by Senator Nancy Kassebaum.

The line starting with the letter "D" shows the years when there will be a primary election for the U. S. Senate seat now held by Senator Bob Dole.

It will be noted that in the year's 1984, 1992, 1996, 2004, 2008 and 2016 the primary election in August will have only the statewide position of United States senator on the ballot.

It appears that in the year of 2012 there will be no statewide office on the primary ballot.
