MINUTES OF THE SENATE COMMITTEE ON FEDERAL AND STATE AFFAIRS

The Chairman called the committee's attention to the material submitted by the ABC Director on January 25, 1983 (refer to Attachment #1 of Minutes of January 25, 1983, "Present Rate of License Fees."), and to Number 2 of Gen. Kennedy's Memorandum (Attachment #7, Minutes of January 18, 1983).

Starting with Item No. 2, Gen. Kennedy appeared. The question posed by this item is: Is the level of fees (License & Registration) set by statute adequate? Senator Francisco moved to introduce a bill to amend the law to increase the Class "A" private club license fee from \$250 to \$500. 2d by Senator Winter. Motion carried. Senator Meyers and Senator Pomeroy asked that their "no" votes be recorded.

The committee looked at Item #3 of the January 18, memorandum and, after discussion, passed over it.

Recommendation #4 of the memorandum was considered next. The ABC distributed a memorandum (Attachment #1) re: Percentage of Food Income Versus Percentage of Alcohol and Cereal Malt Beverage Income in Reciprocating Class "B" Clubs.

Senator Winter made the conceptual motion that legislation be drafted that would serve the purpose of allowing reciprocity if there is a private club in a restaurant that for purpose of reciprocity all of the food sold by that entity be counted toward whatever percentage it is. 2d by Senator Vidricksen. Motion failed.

Senator Morris moved that a bill be introduced to reduce the percentage of gross food sales from 50% to 40%. 2d by Senator Winter. Motion carried. Senator Francisco asked that his "no" vote be recorded.

Senator Morris moved that a bill be introduced that the law be amended to allow more flexibility to the ABC to evaluate the Class "B" clubs' compliance with food percentage of gross receipts required for reciprocity agreements. 2d by Senator Francisco. Motion carried.

Senator Francisco moved conceptually that the ABC be given authority to examine the recent history of applicants which are new corporations replacing corporations that have not had sufficient food sales to qualify, and if a deception seems likely to deny the granting of a club license, and that the ABC and Revisor's Office prepare a bill to carry this out. 2d by Senator Winter. Motion carried.

Senator Gannon moved the Minutes of January 18, 1983, be approved. 2d by Senator Morris. Motion carried.

The meeting adjourned at 12:00 noon.
