MINUTES OF THE SENATE COMMITTEE ON FEDERAL AND STATE AFFAIRS.

HB2548 - Cosmetology licensure requirements.

The Chairman called the committee's attention to HB2548, which had been recommended favorably for passage as amended at yesterday's meeting. He stated that a technicality had been found concerning the care of persons in their homes or other places of residence which could be corrected by adding to the report before it is turned in. Senator Pomeroy moved that the committee reconsider its action of the day before on HB2548 and that the committee report the bill with both yesterday's and today's amendments and recommend it favorably for passage as amended. (See Attachment #1) 2d by Senator Daniels. Motion carried.

HCR5035 - Modifying regulation of alcoholic beverage control director, deliveries by manufacturers and distributors.

The Chairman stated that Tuck Duncan had requested to be heard on HCR5035. He reminded the committee that when the post audit report concerning Reg. 14-4-14 was reviewed that a sub-committee was appointed, and that the sub-committee reported back that this should be looked at by the ABC for some long-term solution. He stated that he was here merely to ask that the committee ask that the bill be re-referred or held over until "we could come up with some solid proposal" or ask to pass it over on the calendar.

General Kennedy appeared and stated that 14-4-14 is a very controversial regulation.

Senator Pomeroy moved that the committee ask that the bill be passed over. The Chairman asked if that were the desire of the committee. The committee indicated that it was. The Chairman said that he would talk with Senator Talkington.

Senator Pomeroy distributed a bill that he would propose to have introduced. He explained that this was a clean-up of SB7. It simply provides to make clear in the 5-year transition period the continuation statements and the continuation statement will be signed by the Secretary of State. Senator Pomeroy moved that the bill be introduced. 2d by Senator Francisco. Motion carried.

The meeting adjourned at 9:50 a.m.

REPORTS OF STANDING COMMITTEES

MR. PRESIDENT:

Your Committee on Federal and State Affairs

Recommends that House Bill No. 2548 (As Amended by House Committee)

"AN ACT relating to cosmetology; concerning regulation and licensure relating thereto; amending K.S.A. 65-1901 and 65-1902 and K.S.A. 1982 Supp. 65-1903, 65-1904, 65-1904b and 65-1905 and repealing the existing sections; also repealing K.S.A. 65-1911."

Be amended:

On page 4, in line 148, by striking "or" and inserting "(3) any person who is a registered physical therapist; or"; in line 149, by striking "(3)" and inserting "(4)"; following line 151, by inserting the following:

"(c) Nothing in this act shall be construed as prohibiting care of persons who are elderly or handicapped in their home or other place of residence, as long as the person rendering such care is not in substantial degree practicing the profession of cosmetology.";

And the bill be passed as amended.
