Representative Robert D. Miller, sponsor of House Bill 2074, appeared before the committee to present some background information on this bill. He explained that the amendment would replace the Chief Justice on the Commission with an additional lay citizen to be appointed by the governor, allow selection of the academic library member from any of the Regents institution libraries and would place the State Librarian as a non-voting member and Secretary of the Commission. He stated that the Board of Regents concurs with the change made in the academic member representation and that the Chief Justice was aware of the change. (Exhibit A) Representative Miller urged favorable consideration of House Bill 2074.

Jamie Schwartz presented testimony on House Bill 2242 pointing out the three things that the amendments would accomplish. He explained that passage of this bill would allow the department to reduce the number of divisions by one and division directors by two but retain the powers and duties currently being performed, as well as the necessary staff capacity. (Exhibit B) There was some discussion and Mr. Schwartz answered questions from the committee.

A motion was made by Senator Francisco to pass Senate Bill 2242 favorably out of committee. This was seconded by Senator Roitz. Motion carried.

Duane Johnson addressed the committee on House Bill 2093 and gave background information on it. He pointed out that this bill was necessary to insure the State Library's compliance with federal audit requirements and that this bill would have no fiscal effect as it will not cause change in the budget or program of the services from the State Library. (Exhibit C)


After brief discussion Senator Francisco made a motion to pass Senate Bill 2093 favorably out of committee. Senator Gaar seconded this. Motion carried.

Discussion then turned to House Bill 2074. <u>Senator Gaar made a motion to strike the words "from a list of three candidates recommended by the federation" from lines 37 and 38. Senator Mulich seconded this.</u> After some deliberation <u>Senator Gaar amended his motion to include the words "who shall be appointed by the governor" from line 37. The motion carried as amended.</u>

<u>Senator Gaar then made the motion that Senate Bill 38 and 39 be not passed.</u> <u>Senator Mulich seconded this. Motion carried.</u>

Senator Mulich made the motion to approve the minutes. It was seconded by Senator Francisco. Motion carried.

The committee was adjourned at 2:19 p.m.

#### Background information on House Bill No. 2074

Representative Robert D. Miller, Sponsor

- 1. H.B. No. 2074 would amend K.S.A. 75-2546 which defines the membership of the Kansas State Library Advisory Commission.
- 2. The proposed amendment would a) replace the Chief Justice on the Commission with an additional lay citizen to be appointed by the Governor, b) allow selection of the academic library member from any of the Regents institution libraries, rather than from only the University of Kansas or Kansas State University, and c) would place the State Librarian as a non-voting member and Secretary of the Commission.
- 3. The membership on the Commission of the Chief Justice has not been a necessity since 1975, when the Law Library was moved to the Judicial Center. The Chief Justice has not been able to attend Commission meetings regularly, making a quorum sometimes difficult to achieve.
- 4. H.B. 2074 has been introduced with the awareness and consent of the Chief Justice.
- 5. The Board of Regents concurs with the change made in the academic member representation.
- Letters from the Office of the Chief Justice and the Board of Regents are attached.

Testimony to the Senate Committee
On Governmental Organization
House Bill 2242

presented by Charles J. Schwartz Secretary Kansas Department of Economic Development

March 16, 1983

House Bill 2242, as amended, accomplishes three things:

- To remove from the statutory responsibilities of KDED requirement to analyze freight rates;
- 2) To remove division status of the research and publications section, delete the division director position, but to retain the functions of this division with the Secretary to be delegated within the department as he deems appropriate; and
- 3) To abolish the office of the director of housing.

  The powers and duties of the director are retained by the department.
- K.S.A. 74-5005(p) provides KDED with responsibility "to analyze transportation and freight rates to determine if rates involving Kansas products, shippers or consignees are detrimental to the economic interests of the state, and promote efforts to correct inequities."

Kansas at one time was a leading producer of wheat flour, shipping to all parts of the U.S. However, a combination of Interstate Commerce Commission Regulations and advancing technology in transportation brought about changes which made it less expensive to ship wheat and more expensive to ship flour. The result was the steady loss of markets for flour and the closing of many flour mills. (In 1960 there were still 42 operating mills — in 1982 only 16 were left.)

In 1962, a Governor's Economic Development Committee recommended a new Department of Economic Development. Among the many charges given this agency was the task of originating questions pertaining to the inequities in freight tariffs and active promotion of corrective measures.

The Department carried a line item budgeted amount for several years to prepare Freight Rate Studies. The funds were used on at least two occasions to retain expert legal services to represent the state in ICC hearings concerning freight rates on flour. The last case was at least ten years ago. No budget request for such funding has been made since, nor has any activity occurred in the department in this area.

The Kansas Corporation Commission has responsibility in this area and it is also included under the purview of the Department of Agriculture.

The request to diminish division status of the research and publications function is made to enable organization of this function under the supervision of the Industrial Development division.

Most of the work of this section is directly supportive of industrial development activities and this reorganization would allow better coordination of these functions and be administratively cost effective by eliminating the need for a division director.

Responsibilities for Kansas! Magazine and the KDED Report have previously been transferred to the Travel and Tourism division leaving only the research and analysis and industrial development publications functions with the division.

This request is consistent with the Governor's FY 1984 budget recommendation.

The bill, as amended by the House committee, abolishes the office of the director of housing. The powers and duties performed by the director would be retained by the department.

The housing program currently administers the HUD Section 8 housing assistance grant and provides limited technical assistance to local housing authorities. These functions would continue to be performed by the staff provided for in the FY 84 budget recommendation under the supervision of the administration section of the department.

The housing program would be retained because of the federal contract requirements associated with federal funding in support of seven housing projects. These contractual obligations will extend for 20 years. The abolishment of the office of the director of housing would achieve administrative cost savings without substantial loss to the housing program.

Passage of House Bill 2242 would allow the department to reduce the number of divisions by one and division directors by two but retain the powers and duties currently being performed, as well as the necessary staff capacity.

### Background information concerning House Bill No. 2093

- 1. Talking Book and other information services for the blind and other handicapped readers have been provided through the Kansas State Library since 1970, when these responsibilities were transferred from the State Department of Social and Rehabilitation Services. Authorization for this service by SRS was provided in K.S.A. 76-158d.
- 2. The State Librarian is authorized by statute to provide extension library services, K.S.A. 1981 Supp. 75-2534 and 75-2537, but there is no specific mention of services for the blind or of authority to contract with the Library of Congress for that library's assistance in the provision of Talking Book services as there is in K.S.A. 76-158d.
- 3. The National Library for the Blind, within the Library of Congress, provides Talking Book materials and professional assistance to state libraries, under contract and without charge, to encourage provision of complete information service to the blind and physically handicapped.
- 4. To insure the State Library's compliance with federal audit requirements, the new authorizations included by H.B. 2093 are necessary.
- 5. H.B. 2093 has no fiscal effect. The new authorizations will not cause change in the budget or program of services from the State Library.

onle AN ACT relating to the Kansas state library; providing for library services for the blind and other handicapped readers; amending K.S.A. 1982 Supp. 75-2534 and 75-2537 and repealing the existing sections; also repealing K.S.A. 76-158d.

0022 Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 1982 Supp. 75-2534 is hereby amended to 0024 read as follows: 75-2534. (a) There shall be a state library which 0025 shall be designated as the Kansas state library which shall be 0026 located in Topeka. The state library shall consist of books, 0027 pamphlets, papers, pictures, maps, charts and documents of 0028 every description now belonging thereto, together with such 0029 others as may be acquired by gift, purchase, exchange or other-0030 wise. The state library shall provide library and informational 0031 services to the judicial, legislative and executive branches of the 0032 state government and said library shall also provide extension 0033 services to all of the residents of the state. For the benefit of 0034 blind readers of Kansas, the state library may make available 0035 books and other reading matter in Braille, talking books or any 0036 other medium of reading used by the blind. To this end, the state 0037 library is authorized to provide library services for the blind 0038 and other handicapped persons through contract, agreement or 0039 otherwise with the library of congress or any regional library 0040 thereof. The chief officer of the state library shall be the state 0041 librarian.

0042 (b) The provisions of the Kansas sunset law apply to the 0043 office of the state librarian and the Kansas state library provided 0044 for by this section, and such office and library are subject to 0045 abolition thereunder.

Sec. 2. K.S.A. 1982 Supp. 75-2537 is hereby amended to read one as follows: 75-2537. The state librarian shall have the complete management of the state library, including all extension library services. He or she or reader services for the blind and other handicapped persons. The state librarian shall employ a director of reference and such other employees as are required to administer the laws providing for the state library and reference services. Except as otherwise provided in this act, all employees of the state librarian shall be within the classified service under the Kansas civil service act.

0056 Sec. 3. K.S.A. 76-158d and K.S.A. 1982 Supp. 75-2534 and 0057 75-2537 are hereby repealed.

OD58 Sec. 4. This act shall take effect and be in force from and OD59 after its publication in the statute book.

# As Recommended by House Committee on Ways and Means

#### Brief of Bill\*

H.B. 2093 would amend current statutes to clarify the authority of the State Library to provide, through contract or agreement with the Library of Congress, services to the blind and other handicapped readers.

#### Background

The Talking Book Program, authorized under K.S.A. 76-158(d), was administratively transferred from the Division of Services for the Blind of the Department of Social and Rehabilitation Services to the State Library in 1970. The State Librarian is currently authorized to provide extension services through K.S.A. 75-2534 and 75-2537; however, the statutes are unclear regarding authorization for the State Library to contract with the Library of Congress to make the Talking Book Program available to handicapped readers in Kansas. The amendment has no fiscal impact and may be relevant for the audit of the State Library's federal programs anticipated to occur within the next year.
