The meeting of the House Governmental Organization Committee was called to order at 9:11 a.m. by Rep. Stephen R. Cloud, Chairman. The minutes of the February 23 meeting were approved. The February 27 minutes were distributed.

Rep. Murphy gave the Subcommittee "B" Report on HB 2751 and HB 2752. The following recommendations were made: HB 2751, the bill that would extend the Kansas Sunset Law until July 1, 1992, should be recommended favorably. HB 2752, which contains technical amendments relating to the Kansas Sunset Law, should be recommended favorably. Avis Swartzman, Revisor, added that this would clean up a couple of sections in the statutes dealing with DISC. Rep. Murphy moved the adoption of the Subcommittee "B" Report.

Rep. Sprague gave a second to the motion. The motion carried. Rep. Smith moved that HB 2751 be voted favorable for passage. Rep. Louis gave a second to the motion. The motion carried. Rep. Sughrue moved that HB 2752 be voted favorable for passage. Rep. Matlack gave a second to the motion. The motion carried.

The committee turned to HB 2849, which establishes a separate license for electrolysis technicians. Balloon copies were handed out to Committee members while Rep. Sprague explained the definition of electrolysis technician, electrolysis and epilation. An electrolysis technician shall be required to have practiced as an apprentice in a licensed school for not less than 350 clock hours or in a licensed beauty shop for not less than 700 clock hours. It was discussed whether or not to include a grandfather clause. It was decided that one was not needed in the bill. After further discussion, Rep. Sprague moved that HB 2849 be amended with the amendments contained in the balloon. Rep. Murphy gave a second to the motion. The motion carried. Rep. Sprague moved that HB 2849 be passed as amended. Rep. Harder gave a second to the motion. The motion carried.

The Chairman told the Committee that HB 2619 had been put on the Calendar for a public hearing so anyone could come forth that wished to be heard with regard to any of the boards, committees or commissions contained in the bill. Craig Grant, Kansas National Education Association, asked to speak to lines 42 to 47 of the bill. The boards contained in these lines serve a purpose and he stated that they should not be eliminated. Mr. Grant was referring to the professional teaching standards advisory board; the school administrator professional standards advisory board and the professional teaching practices commission. The Chairman asked Mr. Grant if he was aware that the subcommittee "C" recommendations were to combine the first two and retain the last board. Mr. Grant replied that he was and that he was in favor of this with equal representation of teachers and administrators.

Bill Curtis, Kansas Association of School Boards, also recommended the boards be continued in existence.

John Peterson, Kansas Association of Private Career Schools, spoke in favor of retention of the boards.

The Chairman thanked these conferees and stated that this constituted the public hearing on HB 2619.

RE: The Kansas Sunset Law

Pursuant to its review of the Kansas Sunset Law, the Subcommittee makes the following recommendations:

- 1. H.B. 2751, which would extend the Kansas Sunset Law until July 1, 1992, should be recommended favorably.
- 2. H.B. 2752, which contains technical amendments relating to the Kansas Sunset Law, should be recommended favorably. The bill would correct technical errors and resolve conflicts which occurred in 1981 when the Sunset Law was last amended. The technical changes relate to an inaccurate cross-reference, two amendments made in 1981 to the statutes relating to the Division of Information Systems and Computing which should have been reconciled, and the failure to delete all references to the abolition of the Board of Embalming when the policy decision was made in 1981 to remove the Board from the provisions of the Sunset Law.
