Senator Pomeroy moved that the Minutes of March 1, 1984, be approved. 2d by Senator Morris. Motion carried.

The Chairman recognized Duane Johnson, who appeared to request the introduction of proposed legislation concerning library boards. His request is 3RS2533, and is a part of these Minutes as Attachment #1. Senator Pomeroy moved that the proposal be introduced. 2d by Senator Parrish. Motion carried.

The Chairman directed the Committee's attention to HB2887, concerning the development of the Missouri River for barge traffic. He said Representative Joan Adam had asked that this be introduced in the Senate. Senator Pomeroy moved that the proposed legislation be introduced as a senate bill. 2d by Senator Morris. Motion carried. A copy of the HB2887 is Attachment #2 of these Minutes. It will be introduced as a senate bill.

Thomas J. Kennedy was introduced by the Chairman. A copy of his Memorandum of March 8, 1984, re: Proposal to suspend driver's license for underage consumption of alcoholic liquor, is a part of these Minutes as Attachment #3. Director Kennedy stated that the ABC is neither a proponent nor an opponent of this proposal. The Memorandum deals in more detail about the purpose of the proposed legislation, which is to increase the penalty for any minor who is convicted on a charge of purchasing, possessing or consuming alcoholic liquor and to assure that the burden of the penalty falls directly upon the minor.

Director Kennedy appeared next concerning Identification Cards for Minors. His Memorandum dated February 7, 1984, concerns this proposed legislation. It is Attachment #4 of these Minutes. His written statement concludes with: "Strongly recommend consideration of this proposal. Recommend consideration be given to some form of identification to assist licensees in identifying minors." Chairman stated that Associated Students of Kansas are in general support.

Senator Roitz made a conceptual motion that would permit the state to issue driver's licenses to minors with a different color background for the photo on the license. 2d by Senator Parrish. Motion carried.

Concerning Item #3, the proposal to suspend driver's license for underage consumption of alcoholic liquor, Senator Winter said that he would like to see a proposal arrived at today. He stated that last year the Committee had discussed increasing the penalties and he thinks that approach needs to be taken to look at this matter. Director Kennedy said that that was in HB2504. Senator Winter made the motion to take out the section concerning the increased penalties, as proposed in the original HB2504 and introduce that as a bill. Senator Winter stated that the second part of the motion is to provide that another reason for suspension of a driver's license would be for a minor who is convicted on a charge of buying or consuming alcoholic liquor. 2d by Senator Pomeroy. Motion carried. Proposals to be introduced.

The Chairman called the Committee's attention to SB803, relating to a repository for information concerning missing or unidentified deceased persons. The Chairman introduced Tom Kelly, who spoke in favor of SB803. Director Kelly said that this had been generated by Judge Mike Elwell. The thrust for the file came from Colorado a few years ago. He said that the Colorado Bureau of Investigation began a computerized body file in 1981, along with the Federal Bureau of Investigation. It was a pilot project at that time. He stated that the KBI has found it was helpful in cases which they have had. He said that there is a central repository at the present time at the National Crime Information Center in Washington, D.C. He stated that under the NCI system there are four basic criteria utilized: 1. child; 2. involuntarily taken; 3. mentally ill; and 4. anyone who may appear to be in danger. The main thing about the file is that it is the source by which to identify unidentified bodies, and without it the KBI is hard-put to identify people they find. The KBI does a lot of investigations which are different from homicide investigations, and a central registry would be of great assistance in obtaining identifications. Director Kelly stated that the thrust of the bill is good. Senator Morris moved that SB803 be reported favorably, and that it be sent back to the Judiciary Committee for further study. 2d by Senator Pomeroy. Motion carried.

The Chairman called the Committee's attention to the letter of February 23, to Senator Talkington, from Tom Kelly of the Kansas Bureau of Investigation. The letter had been distributed to the Committee at the Meeting of March 1, 1984. It concerns the Kansas law enforcement agencies access to the computerized criminal history records of the Federal Bureau of Investigation. The Chairman asked if the letter answered all of the Committee's questions, and he also asked Tom Kelly if the KBI and the Highway Patrol were working together on this. Mr. Kelly stated that they are working to try to resolve it. He further stated that HB3088 has been introduced in the House and it gives the Kansas Highway Patrol the National Law Enforcement Teletype System, and if the bill were to pass it would take care of the problem here. Director Kelly said that he did not object to the bill but that he could not answer for the Kansas Highway Patrol. Staff is to check with Colonel Bert Cantwell of the Highway Patrol and report back to the Chairman.

The Committee then considered a proposed bill concerning the State Board of Regents and state educational institutions. Senator Parrish said that it would permit the board of regents to have a negotiating committee to negotiate contracts to provide collection services for state educational institutions on a multi-year basis and that the staff of the board of regents has no problem with the draft of the proposed legislation. Senator Parrish moved that the proposed legislation be introduced. 2d by Senator Roitz. Motion carried. Draft is part of these Minutes as Attachment #5.

Senator Vidricksen was recognized concerning a Memorandum from Tom Kennedy, dated February 22, 1984. It concerns percentage of food income versus percentage of gross receipts income less food income in reciprocating Class "B" clubs, and is a part of these Minutes as Attachment #6. Senator Morris moved that the Committee introduce legislation to clarify what was the original intent of the Legislature and that was that of the food and beverage sales that 50% needs to be in "food." 2d by Senator Winter. Motion carried.

The Chairman announced that the next regularly scheduled meeting of the Committee is for Tuesday March 13, 1984.

The meeting was adjourned at noon.

AN ACT concerning libraries; relating to the powers and duties of library boards; amending K.S.A. 12-1225 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 12-1225 is hereby amended to read as follows: 12-1225. Library boards shall have the following powers and duties: (a) To make and adopt rules and regulations for the administration of the library;

(b) with the approval of the governing body of the municipality, to purchase or lease a site or sites and to lease or erect a building or buildings for the use of the library;

(c) to acquire by purchase, gift or exchange, books, magazines, papers, printed materials, slides, pictures, films, projection equipment, phonograph records and other material and equipment deemed necessary by the board for the maintenance and extension of modern library service;

(d) to employ a librarian and such other employees as the board shall ~~deem~~ deems necessary and to remove them and to fix their compensation;

(e) to establish and maintain a library or libraries and traveling library service within the municipality or within any other municipality with which service contract arrangements have been made;

(f) to contract with other libraries established under the provisions of this act or with the governing body of a municipality not maintaining a public library for the furnishing of library service to the inhabitants of such municipality to the extent and upon such terms as may be agreed upon, and to contract with any school board to furnish library service to any school

library or to use the library facilities of the public school to supplement the facilities of the public library;

(g) to receive, accept and administer any money appropriated or granted to it by the state or the federal government or any agency thereof for the purpose of aiding or providing library service;

(h) to receive and accept any gift or donation to the library and administer the same in accordance with any provisions thereof. If no provisions are specified, the board shall have the power to hold, invest or reinvest the gift and any dividends, interest, rent or income derived from the gift in the manner the board deems will best serve the interests of the library;

(i) to make annual reports to the state librarian and the governing body of the municipality on or before January 31st 31 of each year for the preceding calendar year, showing receipts and disbursements from all funds under its control, and showing such statistical information relating to library materials acquired and on hand, number of library users, library services available, and other information of general interest as ~~said~~ the governing body may-require requires;

(j) as to money received from sources other than a tax levy for library purposes, in its discretion, to place such money in a separate fund or funds, or to place the money in the fund to which the tax levy money is credited unless the grantor or donor ~~shall-direct~~ directs how and for what purpose the money shall be handled and spent.

Sec. 2. K.S.A. 12-1225 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the statute book.

HOUSE BILL No. 2887

By Representatives Adam, Bussman, Campbell, Dempsey, Fox, Hamm, Justice, Love, Murphy, Peterson, Sutter and Vancrum

0017 AN ACT relating to the development of the Missouri River for
0018 barge traffic; enacting an interstate compact for this purpose;
0019 concerning the purpose, membership and duties and respon-
0020 sibilities of member states; and providing for withdrawal from
0021 membership by member states.

0022 *Be it enacted by the Legislature of the State of Kansas:*

0023 Section 1. A compact for the development of the Missouri
0024 River for barge traffic is hereby enacted and entered into with
0025 states legally joining therein through the adoption of this com-
0026 pact in the form substantially as follows:

0027 COMPACT BETWEEN IOWA, KANSAS, MISSOURI AND NEBRASKA FOR
0028 THE DEVELOPMENT OF THE MISSOURI RIVER FOR BARGE TRAF-
0029 FIC

Article I

0030 The purposes of this compact are to provide for planning for the most efficient
0031 use of the waters of the Missouri River, to increase the amount of barge traffic on
0032 that segment of the Missouri River below Sioux City, to take necessary steps to
0033 develop the Missouri River and its banks to handle more barge traffic than is
0034 presently handled, to encourage barge use on that segment of the Missouri for
0035 transporting bulk goods, especially farm commodities, to insure that the intended
0036 increase in barge traffic does not impose unacceptable damage on the Missouri
0037 River in all its various uses, including agriculture, wildlife management, and
0038 recreational opportunities, to consider the effects of diversion of the waters of the
0039 Missouri River on navigation, and to promote joint action between the compact
0040 parties to accomplish these purposes. The purposes of the compact do not
0041 include lobbying activities against user fees for barge traffic and such activities
0042 under this compact are prohibited.

Article II

0044 It is the responsibility of the four states to accomplish the purposes in Article I
0045 through the official in each state charged with the duty of administering the
0046 public waters and to collect and correlate through those officials the data
0047 necessary for the proper administration of the compact. Those officials may, by
0048 unanimous action, adopt rules and regulations to accomplish the purposes of this
0049 compact.
0050

Article III

0051 The states of Iowa, Missouri, Kansas, and Nebraska agree that within a
0052 reasonable time they shall fulfill the obligations of this compact and that each
0053 shall authorize the proper official or agency in its state to take the necessary steps
0054

0055 to promote barge use and develop the Missouri River as it flows between and
0056 within the compact states for additional barge traffic.

0057

Article IV

0058 This compact does not limit the powers granted in any other act to enter into
0059 interstate or other agreements relating to the Missouri River flowing between
0060 and within the compact states, alter the relations between the respective internal
0061 responsibilities of the government of a party state and its subdivisions, or impair
0062 or affect any rights, powers, or jurisdiction of the United States, or those acting by
0063 or under its authority, in, over, and to those waters of the Missouri River.
0064 Adoption of this compact by its legislature shall not require the signatory states to
0065 adopt any legislation or to appropriate funds for its implementation.

0066

Article V

0067 Other states having an interest in the promotion of barge traffic on the Missouri
0068 River may join in this compact by unanimous consent of the member states.
0069 Any member state may withdraw at any time by appropriate action of its
0070 legislature.

0071 Sec. 2. This act shall take effect and be in force from and
0072 after its publication in the Kansas register.

DATE: March 8, 1984

PURPOSE

The purpose of the proposed legislation is to increase the penalty for any minor who is convicted on a charge of purchasing, possessing or consuming alcoholic liquor and to assure that the burden of the penalty falls directly upon the minor.

PERSPECTIVE

The use and abuse of alcoholic liquor seems to be increasing among minors both nationwide and in Kansas. Alcoholic liquor seems to be on the rise as the intoxicant of choice among young people because it is socially acceptable, inexpensive, easily obtained, and perceived as relatively safe.

Current statutes designed to prohibit the selling, buying and consumption of alcoholic liquor by minors do not appear to be very effective. Minors who are arrested for buying or possessing alcoholic liquor seem to be getting off with light penalties, usually fines, that are too often paid by their parents. It seems to be all too easy for any minor who wants it to be able to get hold of alcoholic liquor. Even the most conscientious seller of alcoholic liquor can be deceived by any one of several altered or fake ID's that are all too readily available.

As an alternative approach, the State of New Jersey has recently enacted a law that mandates a one-year suspension for the driver's license of any minor who is convicted on a charge of buying or consuming alcoholic liquor. (See attached newspaper article, Attachment 1). This is seen as a very effective deterrent in that it affects the minors themselves rather than being something that dad or mom can pay and it is a very stiff penalty. For those very reasons such a penalty is being considered here today.

COMMENTS AND/OR RECOMMENDATIONS


The Alcoholic Beverage Control Division recognizes, along with everyone else, the seriousness of this problem. The Division is of the opinion that penalties prescribed for specific illegal acts are policy matters that should be determined by the Legislature. The Division is neither a proponent nor an opponent of this proposal.

However, there are several considerations that we have noticed that we would like to point out to this committee.

1. Such a proposed penalty is probably legal. A driver's license has generally been viewed as a privilege, not a right. As such, the state has fairly broad discretion to grant it, restrict it or withdraw it.

2. This proposal would be a radical departure from current legislative policy. Under current Kansas law, a driver's license may be suspended for a variety of reasons, (See Attachment 2, reproduced from the Index to the Kansas Statutes Annotated), all of which seem to be directly related to operating a motor vehicle. Suspending a driver's license for being a minor and buying or consuming alcoholic liquor is not directly related to operating a motor vehicle.

3. This proposal would be a drastic, even a radical increase in the penalty for being a minor consuming alcoholic liquor.

Youths buying liquor face loss of licenses

New Jersey is ready to punish underage buyers of alcoholic beverages where officials hope it will hurt the most — in the driver's license.

Governor Kean yesterday signed into law a bill mandating a one-year license suspension for anyone under 21 convicted of buying liquor. The measure, sponsored by Assemblyman Joseph D. Patero, D-Middlesex, and merged with an identical measure sponsored by state Sen. C. Louis Bassano, R-Union, took effect immediately.

If the convicted youth is under 17 and too young to have a license, he or she will have to wait an additional year before becoming eligible to apply. A 15-year-old convicted of buying liquor, for example, could not apply for a driver's license until age 18.

The new penalties also apply to underage persons caught drinking at a party, in a park, sitting in a car, or elsewhere, Bassano said.

"The growing incidence of teen-agers' purchasing alcohol illegally must be stopped," Kean said. "For many a loss of driving privileges or a delay in obtaining

a driver's license is a punishment more severe than a fine."

The new penalty is mandatory. Until now, someone convicted of buying liquor could have been fined up to \$100.

But, Bassano said, "no matter what the monetary fine was, Mom and Dad would be paying the fine. In this case, Mom and Dad can't do anything." The penalty of a suspended driver's license was chosen, he said, because it was something "that young people hold most sacred."

"I have a 17-year-old son. I know what my son's license means to him," Bassano said. Given the choices under the new law, he said, he was certain his son would choose to protect his driving privilege.

Kean also said he expects the bill to help police fight drunken driving.

Riley Regan, director of the state Division on Alcoholism, called the bill severe and said he expected it to "change a lot of attitudes very quickly."

At least some of those affected by the new law are sympathetic to overall efforts to curb drunken driving but say it is unfair to suspend a license for alcohol offenses that might not be related to driving.

"Driver's license?" Joy Bontempo, 20, of Garfield asked incredulously when informed of the new law in an interview at the Bergen Mall in Paramus. "Even if you were [drinking] in a park?

"I know a couple of people who were killed drunk driving. I can see if we're drinking and driving at the same time." But she said the loss of a license for simply buying or consuming liquor didn't make sense.

Darren Tipton, 14, of Paramus said the new law is unlikely to discourage underage drinking. He also objected to linking the loss of license to an alcohol offense that doesn't involve a car.

"If you get caught drinking on the street, why should you get your license taken away?" Tipton asked.

"Oh, now that's ridiculous," Adrienne Pellegrini, 20, of Staten Island said. "That's parental drama. That's how parents punish children — for things that have nothing to do with it."

Ms. Pellegrini thought for a moment, then added: "But sometimes you just gotta do what works, and I guess a license is pretty important to kids."

Bassano, however, is not concerned that young people might oppose the measure. He said the law was intended as an extension of the 1982 law that raised the drinking age from 19 to 21. Increasing the legal age has already produced a decline in drunken-driving fatalities in the 17-21 age bracket, he said.

"I'd rather have kids mad at me," Bassano said, "than have them not be alive to be mad at me."

Regan of the Division of Alcoholism

and aides to Kean insisted that the measure doesn't infringe on constitutional rights of youths convicted of buying liquor.

"There would be a constitutional problem if there was a legal right inherent in the Constitution to a driver's license," Regan said. But there is no such right, so the bill signed yesterday is constitutional, he argued.

Paul Wolcott, a spokesman for Kean, also argued that a driver's license is a privilege, not a right, and can be suspended by the state if it has a good reason.

Wolcott contended that there is an established link between driving privileges and criminal charges or convictions. He said, for example, that police officers often impound a car if a sizable amount of marijuana is found in the trunk.

He also said that the bill simply added a new deterrent to the state's criminal code, which he likened to a system of deterrents and rewards for certain types of behavior. With young people, he said, one of the strongest deterrents that can be used is suspension of driving privileges.

Clifford W. Snedeker, director of the state Division of Motor Vehicles, said last night that notices of convictions for underage purchases of alcoholic beverages will be sent to his division, which will then suspend licenses. In the case of someone who hasn't yet received a license, a special file will be created in the person's name, and the person will be ineligible for a license until age 18.

Frank Askin, national general counsel for the American Civil Liberties Union, last night said he hadn't had time to con-

sider the new law and declined to comment on its possible constitutional implications.

Kean yesterday also signed a drunken-driving measure that would increase the wholesale liquor tax from 6.5 percent to 7.3 percent.

The change, which requires approval of additional legislation before it can take effect, is expected to raise \$10 million in the current fiscal year. The money is to be used to pay for a network of rehabilitation centers for drunken drivers, for extra police for drunken-driving patrols, and for educational programs.

The increase won't take effect, however, until the legislature passes a bill creating the fund that will be used to administer the new programs. And even if the legislature passes the bill quickly and sends it to Kean, as expected, aides to Kean said they're uncertain if the tax increase will take effect.

The reason is that the bill providing for the tax increase was passed during the 1982-83 legislative session, which officially ended at noon Jan. 10. The bill creating the new fund will have to be approved during the 1984-85 legislative session now underway.

Kean aides say it appears that both measures may have to be approved in the same session of the legislature. If that is the case, the tax increase would have to be introduced and approved again in the legislature.

Little opposition to the tax increase would be expected, but the increase in the wholesale liquor tax could be delayed for weeks or months by the legislative process.

RE: Identification Cards for Minors

DATE: February 7, 1984

The sale of alcoholic liquor to minors by retail liquor store licensees or their employees continues to be a real problem not only in Kansas but across the entire United States. In 1978, an effort was made to help with identification of people making purchases of alcoholic liquors by having the photography required on the Kansas Driver's License and the Kansas Identification Card. This helped but it did not solve the problem. We still have minors, people under 21 years of age, borrowing their older sister's, older brother's, borrowing others ID's, using false ID's or altering their own ID's all for the purpose of purchasing alcoholic liquor to include strong beer. The ABC Division and other law enforcement agencies have frequently encountered false or altered ID's that are impossible to spot on a cursory examination.

In FY 1983, we had 65 citations issued to retailers for sale to minors. These were the ones apprehended. How many made purchases and were not caught is anyone's guess.

Other states have been faced with the same problem and have tried various ideas, some with success.

Two ideas that have been used are:


First, change the background color on the driver's license photo from blue to maybe red for minors. Here the retailer or his employees would immediately note that the person making the purchase is a minor or that the ID was issued when the person was a minor and needs to be checked more closely. A big advantage of just changing the background color on the ID card is that you continue to get a front view of the person. Each driver's license or state ID card is renewable every four (4) years, commencing with age 16. Therefore, if the individual received a card when they were 16 or 17 years old, the driver's license ID would be a deterrent for at least 4 years.

Second, require all minors to have a profile picture rather than a regular frontal picture. A potential disadvantage of this procedure is that you lose some of the purpose of the photo if the profile isn't exactly right.

Either of these ideas would be an improvement over our present system. Attached hereto are examples of each. To accomplish either action, K.S.A. 8-243 (Driver's License Identification Card) and K.S.A. 8-1324 (Non-driver's License ID Card) need to be amended to grant the state the authority to take photographs of minors wishing to purchase driver's license or state identification card different from that required for adults.

Strongly recommend consideration of this proposal. Recommend consideration be given to some form of identification to assist licensees in identifying minors.

Draft Bill No. ____

An Act relating to collection services for the State Board of Regents and state educational institutions:

Section 1. Authorizing certain procedures for the procurement of collection services for such agencies.

(a) As used in this section "negotiating committee" means a committee to negotiate as provided in this act, and consisting of the executive officer of the state board of regents ~~selected~~ or a person designated by the executive officer, and two representatives of the state educational institutions as designated by the state board of regents.

(b) The state board of regents may convene a negotiating committee to obtain collection services. The negotiating committee is authorized to negotiate contracts with one or more qualified parties to provide collection services for the state educational institutions and such contracts may be entered on a multi-year basis.

(c) Prior to negotiating for collection services, the committee shall advertise for proposals, negotiate with firms submitting proposals and select among those submitting such proposals the party or parties to contract with for the purposes of collection services.

(d) Contracts entered into pursuant to this section shall not be subject to the provisions of K.S.A. 75-3738 to 75-3740a, inclusive, and any amendments thereto.

Section 2. This act shall take effect and be in force from and after its publication in the Kansas register.

income less Food Income in Reciprocating Class "B" Clubs.

DATE: February 22, 1984

Gross receipts affidavits have been received and approved for the Class "B" Private Clubs listed below, thus permitting them to reciprocate with each other. For a club to be eligible to participate in reciprocals, 50% of the Gross Receipts of the club must be from the sale of food.

Definitions of Gross Receipts and Food Income are as follows:

"Gross Receipts" includes sales of any type made on the licensed premises of a Class "B" private club. These sales include:

- a. Food
- b. Alcoholic liquors
- c. Cereal Malt Beverages
- d. Membership Fees
- e. Cover Charges
- f. Vending Machine Concessions
- g. Video Games
- h. Any other sales made on the licensed premises

"Food Income" means the gross receipts from the sale of food on the licensed club premises only. Receipts from the sale of food in an adjacent or public dining area may not be included. Receipts from the sale of food in the licensed club which are generated during hours that the club is open to the public pursuant to Letter of Approval from the director, may be included.

For yearly comparisons the following legend is provided:

- ** indicates 1982 calendar year percentage
- *** indicates 1983 calendar year


