SB822 - relating to persons applying to take CPA examinations.

The Chairman called the Committee's attention to SB822 which had been heard on March 23. Senator Morris moved to report SB822 adversely. 2d by Senator Roitz. Motion carried. Senators Pomeroy and Vidricksen asked to be recorded as voting "no."

HB2813 - relating to cost of land survey.

The Chairman asked if the Committee wished to take any action on HB28113. No motions were made concerning the bill.

SB860 - relating to cosmetologists and licensure.

Copies of "Seminars held that were on the calendar in the Offices of the Board of Cosmetology for 1983" were distributed to the Committee from the Kansas State Board of Cosmetology. They had been requested by Senator Morris. There was discussion of the bill and the material, but no action was taken by the Committee. The "Seminars held" material is a part of these Minutes as Attachment #1.

Law Enforcement Training Review.

Russell Mills reported that he had spoken yesterday with Maynard Brazeal, Director of the Law Enforcement Training Center. He will be sending a letter summarizing questions asked by this Committee. Mr. Brazeal appears to be quite happy with the 1982 law and the 1983 amendments. He stated to Mr. Mills that the Central Registry now was implemented and was a very good program in that it allows them to enforce the training program in knowing what officers have completed the training.

Concerning courses that have been offered in outlying areas: one was conducted in Hays and one in southeast Kansas; one was scheduled for Garden City but had to be re-scheduled due to a blizzard. Mr. Mills also said that the community colleges are getting strongly into the law enforcement training program. Mr. Mills also stated that in answer to the question from Committee, about departments that are potentially violating training standards, that Mr. Brazeal said there are about 5% of the small departments that are intentionally in violation of the law.

Senator Morris requested that Mr. Mills request more information from the League of Municipalities concerning the departments. Senator Daniels requested more information concerning training, which Mr. Mills will obtain.

Senator Morris moved that the Minutes of the Meetings of March 23 and 26, 1984, be approved. 2d by Senator Roitz. Motion carried.
