MINUTES OF THE SENATE COMMITTEE ON FEDERAL AND STATE AFFAIRS

The Chairman welcomed the Committee and Staff.

A briefing of the bills in Committee was given by Staff. The following bills were reviewed which had been held over: SB46, drinking age and other regulation of alcoholic beverages; SB253, Sunday sales of cereal malt beverages at conventions and concerts; SB271, retail liquor store license qualifications; SB292, guide dog access to rental housing and housing for sale; SB364, prohibiting the sale, credit or exchange of tobacco products; SB389, alcoholic beverages; clubs, wholesaling of wine by cereal malt beverage people; HB2424, certified public accountant examination; qualifications for admission. Three senate concurrent resolutions which have been held over are: SCR1614, county option of dog racing and pari-mutuel wagering; SCR1626, constitutional amendment for prohibition of liquor; and SCR1627, state treasurer and insurance commissioner being constitutional officers.

Bills that were drafted as a result of interim committee study, and which are in Committee, are: SB409, concerning farm wineries; SB410, dealing with a commission to review correctional facilities; SB416, amending K.S.A. 79-41a04; liquor fund; SB417, concerning taxes on alcoholic beverages; SB418, also dealing with taxes on alcoholic beverages.

Senator Morris moved that the Committee recommend that SB46, drinking age and other regulations, be not passed. 2d by Senator Arasmith. Motion carried.

Senator Morris pointed out that the Governor has appointed a Governor's Liquor Law Review Commission; Senator Morris is a member. This Commission has divided into three subcommittees: on-premise consumption; off-premise consumption; and wholesales. The subcommittees will report to the Commission on January 27. The Commission will make its report to the 1987 Legislature.

The Chairman was authorized by the Committee to speak to Representative Robert H. Miller, Chairman of House Federal and State Affairs Committee, to see what action they will be taking on liquor matters.

Senator Walker moved that the Committee recommend that SB271, concerning retail liquor store licenses and qualifications, be not passed. 2d by Senator Morris. Motion carried.

Senator Walker moved that SB364, which prohibits the sale on credit of tobacco products, be recommended by the Committee not to pass. 2d by Senator Arasmith. Motion carried.

SB389 deals alcoholic beverages, clubs, wholesaling of wine by cereal malt beverage wholesalers. Senator Morris moved that the Committee recommend that the bill be not passed. 2d by Senator Daniels. Motion carried.

SB411, dealing with the transient merchants licensing act, will be heard by this Committee tomorrow. This clarifies and broadens the exemptions. (SB412, a companion bill, would exempt from property taxation and inventory. It is in the Assessment and Taxation Committee.)

T. C. Anderson appeared before the Committee to express the support of the Kansas Society of Certified Accountants for HB2424. The bill deals with the CPA examination. Senator Morris made the motion that the Committee recommend that HB2424 be placed on the consent calendar. 2d by Senator Daniels. Motion carried.

The meeting was adjourned at noon.
