MINUTES OF THE SENATE COMMITTEE ON FEDERAL AND STATE AFFAIRS

Senator Martin moved that the Minutes of the Meeting of February 20, 1986, be approved. Seconded by Senator Strick. Motion carried.

The Chairman introduced Mr. Don Stumbaugh, Director, Crime Victims Reparations Board. Mr. Stumbaugh distributed copies of proposed legislation concerning moneys recovered by subrogation to be credited to the crime victims reparations fund. (Attachment 1) He also gave the Committee copies of the Seventh Annual Report, 1985, of the Crime Victims Reparations Board. (Attachment 2) It includes program information, the application process, statistical analysis and applicant information. Senator Arasmith moved that the proposed legislation (Attachment 1) be introduced. Seconded by Senator Vidricksen. Motion carried.

Mr. Stumbaugh then proceeded to a letter which had been distributed (Attachment 3) from the Iowa Department of Public Safety. The letter concerns the State of Iowa's Crime Victim Reparation Program and specifically about the ability to compensate victims of DWI/DUI. He also distributed copies of proposed legislation concerning authorization of payment of reparations to victims of DWI/DUI incidents for uninsured losses. Mr. Stumbaugh also requested that this be introduced. Senator Martin moved that the proposed legislation be introduced. 2d by Senator Strick. Motion carried. (The proposed legislation is Attachment 4.)

Senator Arasmith announced that the Subcommittee Meeting scheduled for Monday morning has been cancelled. This is the Subcommittee appointed by the Chairman to study the proposed Kansas criminal justice commission.

The meeting was adjourned.

AN ACT CONCERNING: authorization of payment of reparations to victims of
DWI/DUI incidents for uninsured losses.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF KANSAS:

1 Section 1. K.S.A. 74-7301 is hereby amended to read as follows:

2 74-7301. Definitions. As used in this act, the following words and
3 phrases shall have the meanings respectively ascribed to them herein:

4 (a) "Allowance expense" means reasonable charges incurred for
5 reasonably needed products, services and accomodations, including those for
6 medical care, rehabilitation, rehabilitative occupational training and
7 other remedial treatment and care. Such term includes a total charge not
8 in excess of seven hundred fifty dollars (\$750) for expenses in any way
9 related to funeral, cremation or burial; but such term shall not include
10 that portion of a charge for a room in a hospital, clinic, convalescent or
11 related services, in excess of a reasonable and customary charge for
12 semi-private accommodations, unless other accommodations are medically
13 required.

14 (b) "Board" means the crime victims reparations board established under
15 K.S.A. 1978 Supp. 74-7303.

16 (c) "Claimant" means any of the following persons claiming reparations
17 under this act: A victim; a dependent of a deceased victim; a third person
18 other than a collateral source, or an authorized person acting on behalf of
19 any of them.

20 (d) "Collateral source" means a source of benefits or advantages for
21 economic loss otherwise reparable under this act which the victim or
22 claimant has received, or which is readily available to the victim or
23 claimant, from:

24 (1) The offender;

25 (2) the government of the United States or any agency thereof, a state
26 or any of its political subdivisions or an instrumentality or two (2) or
27 more states, unless the law providing for the benefits or advantages makes
28 them excess or secondary to benefits under this act;

29 (3) social security, medicare and medicaid;

- 1 (4) state-required temporary non-occupational disability insurance;
2 (5) workmen's compensation;
3 (6) wage continuation programs of any employer;
4 (7) proceeds of a contract of insurance payable to the victim for loss
5 which the victim sustained because of the criminally injurious conduct; or
6 (8) a contract providing prepaid hospital and other health care
7 services or benefits for disability.

8 (e) "Criminally injurious conduct" means conduct that (1) occurs or is
9 attempted in this state, (2) poses a substantial threat or personal injury
10 or death and (3) either is punishable by fine, imprisonment or death or
11 would be so punishable but for the fact that the person engaging in the
12 conduct lacked capacity to commit the crime under the laws of this state;
13 but such term shall not include conduct arising out of the ownership,
14 maintenance or use of a motor vehicle, except **for violations of K.S.A.**
15 **8-1567** or when such conduct was intended to cause personal injury or death.

16 (f) "Dependent" means a natural person wholly or partially dependent
17 upon the victim for care or support, and includes a child of the victim
18 born after the victim's death.

19 (g) "Dependent's economic loss" means loss after decedent's death of
20 contribution of things of economic value to the decedent's dependents, not
21 including services they would have received from the decedent if he or she
22 had not suffered the fatal injury, less expenses of the dependents avoided
23 by reason of decedent's death.

24 (h) "Dependent's replacement services loss" means loss reasonably
25 incurred by dependents after decedent's death in obtaining ordinary and
26 necessary services in lieu of those the decedent would have performed for
27 their benefit if the decedent had not suffered the fatal injury, less
28 expenses of the dependents avoided by reason of decedent's death and not
29 subtracted in calculating dependent's economic loss.

30 (i) "Economic loss" means economic detriment consisting only of
31 allowable expense, work loss, replacement services loss and, if injury
32 causes death, dependent's economic loss and dependent's replacement service
33 loss. Noneconomic detriment is loss although caused by pain and suffering
34 or physical impairment.

35 (j) "Noneconomic detriment" means pain, suffering, inconvenience,
36 physical impairment and non-pecuniary damage.

1 (k) "Replacement services loss" means expenses reasonably incurred in
2 obtaining ordinary and necessary services in lieu of those the injured
3 person would have performed, not for income, but for the benefit of self or
4 family, if such person had not been injured.

5 (1) "Work loss" means loss of income from work the injured person would
6 have performed if such person had not been injured, and expenses reasonably
7 incurred by such person in obtaining services in lieu of those he or she
8 would have performed for income, reduced by any income from substitute work
9 actually performed by such person or by income such person would have
10 earned in available appropriate substitute work that he or she was capable
11 of performing but unreasonably failed to undertake.

12 (m) "Victim" means a person who suffers personal injury or death as a
13 result of (1) criminally injurious conduct, (2) the good faith effort of
14 any person to prevent criminally injurious conduct or (3) the good faith
15 effort of any person to apprehend a person suspected of engaging in
16 criminally injurious conduct.

17

18 Section 2. K.S.A. 74-7301 is hereby repealed.

19 Section 3. This act shall take effect and be in force from and after its
20 publication in the statute book.

As required by K.S.A. 74-7316, the Crime Victims Reparations Board has prepared the following annual report covering the period from July 1, 1984 to June 30, 1985.

I. PROGRAM INFORMATION

K.S.A. 74-7301 - 7318, establishing a Crime Victims Reparations Board was adopted by the 1978 Legislature, and became effective July 1, 1978. The statute was passed to provide victims of violent crime compensation for loss of earnings and out-of-pocket loss for injuries sustained as a direct result of a crime committed against their person. Out-of-pocket loss is defined as reasonable medical care, counseling, or other care necessary as a result of the injury. The statute provides a maximum payment of \$10,000, including a \$750 maximum award for funeral expenses. Any collateral source receipts, which are defined as medical insurance, Social Security, Worker's Compensation, and Unemployment Compensation, are deducted from any award the Board allows.

In 1982 the Legislature assigned administration of the Rape Prevention and Crisis Intervention Services portion of the federal Preventive Health and Health Services Block Grant to the Crime Victims Reparations Board. The Crime Victims Reparations Board has received \$30,816 each fiscal year since FY 1983.

In FY 1985, a total of \$29,087.38 was granted to local programs, statewide. The funds were used to establish sexual assault prevention programs for children and adults and to create or maintain rape crisis intervention hotlines. Fifteen programs received grants from this fund. (See Table 3)

K.S.A. 1984 Supp. 74-7325 established the Protection From Abuse Fund for the purpose of creating funds for programs providing services to victims of domestic abuse. The funding source established in this legislation is a \$8 fee assessment added to marriage license fees received in each county throughout the state. Monies deposited in the Protection from Abuse Fund are administered by the Crime Victims Reparations Board in the form of grants-in-aid.

In FY 85 a total of \$173,636.25 was deposited in the Protection From Abuse Fund and a total of \$128,063.00 was granted to local programs statewide. The funds were used to assist funding the administration and operation of the following services within domestic abuse programs:

- (a) 24-hour crisis intervention;
- (b) shelter or safehouse facilities;
- (c) assistance and referral for victims; and
- (d) emergency transportation.

Fourteen programs received grants from this fund in FY 85. (See Table 4)

The Crime Victims Reparations Board is appointed by the Governor and consists of three members: Michael Glover, Chairperson; Alma Sanford Carter, Member; and LaTelletta D. Lipscomb, Member.

There are three fulltime staff: the Executive Director, an Investigator, and a Secretary.

II. THE APPLICATION PROCESS

The office receives numerous inquiries about eligibility for reparations. However, some inquiries are not processed by opening a file because it can be determined that the victim was not eligible under the statute. Many of ineligible inquiries concern automobile and property crimes which are excluded by the statute.

Upon receipt of a Declaration of Eligibility and Application, it is necessary to determine minimal eligibility. Therefore, compliance with the following statutory requirements must be in evidence before processing the application:

- 1) The crime was committed in Kansas.
- 2) The crime was reported to proper authorities within seventy-two hours.
- 3) The claim was filed within the one year limit set by law.

If the claim does not meet the above standards, it is determined to be ineligible and the claimant is notified.

If the claim meets these initial tests, it is necessary to:

- 1) acknowledge receipt of the Declaration of Eligibility and forward an Application and Authorization form for them to sign and return. The authorization is necessary so that the Board has access to medical, hospital and employment records material to the claim;
- 2) obtain a description of the incident from law enforcement reports to determine if any provocation by the victim is indicated and, if so, to contact any witnesses to the incident for their statements;
- 3) acknowledge receipt of the claim and request any additional documentation which the claimant did not attach;
- 4) check with the respective District or County Attorney's office to determine if proceedings against the offender are eminent and if so to ask that restitution may be considered at the time of sentencing;
- 5) verify the victim's relationship, if any, to the alleged offender;
- 6) consider other collateral sources reported as received by the claimant as a result of the incident; for example, Social Security, Worker's Compensation, private insurance, etc.

Upon receipt of the requested information, further investigation is necessary to verify:

- 1) the employment of the victim and/or the claimant;
- 2) the income reported and documentation, if the victim is/was self-employed;
- 3) the outstanding balances of hospital and doctor bills and their relevance to the claim; and
- 4) conduct a personal interview with the claimant regarding the information contained in the claim, and the involvement of the claimant in the circumstances surrounding the incident.

When the claim is complete, the file is copied and submitted to the Board for their review and determination. They, in turn, may:

- a) find the claim cannot be determined due to lack of documentation or information which the Board feels necessary to make a decision;
- b) find a claim eligible under the statute for the award requested and advise a warrant be issued;
- c) find a claim eligible under the statute for a lesser amount than requested and advise that the claimant be so notified indicating that a hearing may be requested;
- d) find the claim cannot be determined due to conflicting data therein and advise a hearing is required prior to a final decision; or
- e) find the claim ineligible under the statutes and advise that the claimant be so notified indicating that a hearing may be requested.

The Staff carries out the Board's decisions by:

- a) making additional contacts in order to obtain further documentation;
- b) writing a letter to the claimant enclosing the Decision and Order and the Assignments, requesting the claimant to execute the documents, noting the claimant's right to request a hearing in the event the award is less than was requested by the claimant;
- c) requesting warrants, if an award is determined and after a signed consent has been received;
- d) scheduling a hearing if the Board finds conflicting data in a claim or is in doubt about any part of the claim;
- e) notifying the claimant, by letter, if the claim is denied stating the reason for denial and advising the claimant of the opportunity to request a hearing. The request for a hearing is to be received in the Board office within thirty days after date of notification.

In order to schedule a hearing, all parties are notified of the date and location fifteen days prior to the date set. The Board sits as the hearing officer and renders its decision as expeditiously as possible pending request for additional data.

The Board is subrogated to the cause of the action of the applicant against the person responsible for the injury or death of the victim and also against the offender for the amount of damages sustained by the applicant.

III. STATISTICAL ANALYSIS

The Crime Victims Reparations Board has experienced a dramatic increase in claim filings every year since FY 1982. Claim filings have increased almost 30% each year, and while the average award per claim has fluctuated somewhat, the ratio of claims filed to awards paid has remained fairly constant at nearly 60%. Attorneys fees, as specified by statute, are paid only for assistance provided to the victim in preparation of a claim at the rate of \$45 per hour.

It is important to note that the increase described above has occurred in the absence of any systematic information dissemination to publicize the reparations program. One explanation of this phenomena is that increased awareness among victims and service providers has expanded the public information network, resulting in more claim filings. Due to increasing awareness among law enforcement agencies, domestic violence programs who serve many victims eligible for reparations, and the public in general, a continued increase is projected.

Dear Mr. Stumbaugh:

I am enclosing some information concerning the State of Iowa's Crime Victim Reparation Program and specifically about the ability to compensate victims of DWI/DUI.

Chapter 912 of the Iowa Code covers the Iowa Crime Victim Reparation Program. Section 912.1(4) defines a crime as including violations of Section 321.281 which is our statute covering operating while under the influence of alcohol or a drug or while having an alcohol concentration of 13/100 or more. This section further provides that a plea or verdict of guilty of a charge under Section 321.281 or a license revocation under 321.B.13 or 321.B.16 shall be considered by the Department as evidence of a violation of Section 321.281 for the purposes of the Chapter. For your information I have enclosed Sections 321.281, 321.B.13 and 321.B.16 for your review. Also enclosed is a copy of Chapter 17 of the Iowa Administrative Code which is the Administrative Rules covering the Crime Victim Reparation Program. Under Section 680-17.3(3) we have expanded on the definition of a crime to include several items that would evidence violation of Iowa Code Section 321.281.

Please note that in 5 we have provided for a very broad standard that can be used by the Department.

We have found that the inclusion of the provision for compensating victims of drunk drivers is a very useful addition to the Crime Victim Reparation Program. Since our program does not compensate victims who are

otherwise covered by insurance the uninsured motorists provisions of the victims' insurance as well as the insurance of the intoxicated driver can be used to compensate the victim. Our statute also provides for subrogation in case there is a law suit against the operator to cover the medical expenses of the victim.

We have not found a great number of cases involving this particular statute, however, in the cases that we have had we have found the provisions of this Section to be a very beneficial addition to the program.

AN ACT CONCERNING: authorization of payment of reparations to victims of

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF KANSAS:

1 Section 1. K.S.A. 74-7301 is hereby amended to read as follows:

2 74-7301. Definitions. As used in this act, the following words and
3 phrases shall have the meanings respectively ascribed to them herein:

4 (a) "Allowance expense" means reasonable charges incurred for
5 reasonably needed products, services and accomodations, including those for
6 medical care, rehabilitation, rehabilitative occupational training and
7 other remedial treatment and care. Such term includes a total charge not
8 in excess of seven hundred fifty dollars (\$750) for expenses in any way
9 related to funeral, cremation or burial; but such term shall not include
10 that portion of a charge for a room in a hospital, clinic, convalescent or
11 related services, in excess of a reasonable and customary charge for
12 semi-private accommodations, unless other accommodations are medically
13 required.

14 (b) "Board" means the crime victims reparations board established under
15 K.S.A. 1978 Supp. 74-7303.

16 (c) "Claimant" means any of the following persons claiming reparations
17 under this act: A victim; a dependent of a deceased victim; a third person
18 other than a collateral source, or an authorized person acting on behalf of
19 any of them.

20 (d) "Collateral source" means a source of benefits or advantages for
21 economic loss otherwise reparable under this act which the victim or
22 claimant has received, or which is readily available to the victim or
23 claimant, from:

24 (1) The offender;

25 (2) the government of the United States or any agency thereof, a state
26 or any of its political subdivisions or an instrumentality or two (2) or
27 more states, unless the law providing for the benefits or advantages makes
28 them excess or secondary to benefits under this act;

29 (3) social security, medicare and medicaid

1 (4) state-required temporary non-occupational disability insurance;

2 (5) workmen's compensation;

3 (6) wage continuation programs of any employer;

4 (7) proceeds of a contract of insurance payable to the victim for loss
5 which the victim sustained because of the criminally injurious conduct; or

6 (8) a contract providing prepaid hospital and other health care
7 services or benefits for disability.

8 (e) "Criminally injurious conduct" means conduct that (1) occurs or is
9 attempted in this state, (2) poses a substantial threat or personal injury
10 or death and (3) either is punishable by fine, imprisonment or death or
11 would be so punishable but for the fact that the person engaging in the
12 conduct lacked capacity to commit the crime under the laws of this state;
13 but such term shall not include conduct arising out of the ownership,
14 maintenance or use of a motor vehicle, **except for violations of K.S.A.**
15 **8-1567** or when such conduct was intended to cause personal injury or death.

16 (f) "Dependent" means a natural person wholly or partially dependent
17 upon the victim for care or support, and includes a child of the victim
18 born after the victim's death.

19 (g) "Dependent's economic loss" means loss after decedent's death of
20 contribution of things of economic value to the decedent's dependents, not
21 including services they would have received from the decedent if he or she
22 had not suffered the fatal injury, less expenses of the dependents avoided

24 (h) "Dependent's replacement services loss" means loss reasonably
25 incurred by dependents after decedent's death in obtaining ordinary and
26 necessary services in lieu of those the decedent would have performed for
27 their benefit if the decedent had not suffered the fatal injury, less
28 expenses of the dependents avoided by reason of decedent's death and not
29 subtracted in calculating dependent's economic loss.

30 (i) "Economic loss" means economic detriment consisting only of
31 allowable expense, work loss, replacement services loss and, if injury
32 causes death, dependent's economic loss and dependent's replacement service
33 loss. Noneconomic detriment is loss although caused by pain and suffering
34 or physical impairment.

35 (j) "Noneconomic detriment" means pain, suffering, inconvenience,
36 physical impairment and non-pecuniary damage.

1 (k) "Replacement services loss" means expenses reasonably incurred in
2 obtaining ordinary and necessary services in lieu of those the injured
3 person would have performed, not for income, but for the benefit of self or
4 family, if such person had not been injured.

5 (1) "Work loss" means loss of income from work the injured person would
6 have performed if such person had not been injured, and expenses reasonably
7 incurred by such person in obtaining services in lieu of those he or she
8 would have performed for income, reduced by any income from substitute work
9 actually performed by such person or by income such person would have
10 earned in available appropriate substitute work that he or she was capable
11 of performing but unreasonably failed to undertake.

12 (m) "Victim" means a person who suffers personal injury or death as a
13 result of (1) criminally injurious conduct, (2) the good faith effort of
14 any person to prevent criminally injurious conduct or (3) the good faith
15 effort of any person to apprehend a person suspected of engaging in
16 criminally injurious conduct.

18 Section 2. K.S.A. 74-7301 is hereby repealed.

19 Section 3. This act shall take effect and be in force from and after its

(c) As used in this section, "racing" means the use of one or more vehicles in an attempt to out-gain, out-distance or prevent another vehicle from passing, to arrive at a given destination ahead of another vehicle or vehicles, or to test the physical stamina or endurance of drivers over long distance driving routes.

(d) Violation of this section is a misdemeanor.

SERIOUS TRAFFIC OFFENSES

8-1566. Reckless driving, penalties. (a) Any person who drives any vehicle in willful or wanton disregard for the safety of persons or property is guilty of reckless driving.

(b) Violation of this section is a misdemeanor. Upon a first conviction of a violation of this section, a person shall be sentenced to not less than five days nor more than 90 days imprisonment or fined not less than \$25 nor more than \$500, or both such fine and imprisonment. On a second or subsequent conviction of a violation of this section, a person shall be sentenced to not less than 10 days nor more than six months imprisonment, or fined not less than \$50 nor more than \$500 or both such fine and imprisonment.

8-1567. Driving under influence of al-

cohol or drugs. (a) No person shall operate or attempt to operate any vehicle within this state while:

(1) The alcohol concentration in the person's blood or breath, at the time or within two hours after the person operated or attempted to operate the vehicle, is .10 or more;

(2) under the influence of alcohol;

(3) under the influence of any drug or combination of drugs to a degree that renders the person incapable of safely driving a vehicle; or

(4) under the influence of a combination of alcohol and any drug or drugs to a degree that renders the person incapable of safely driving a vehicle.

(b) No person shall operate or attempt to operate any vehicle within this state if the person is a habitual user of any narcotic, hypnotic, somnifacient or stimulating drug.

(c) If a person is charged with a violation of this section involving drugs, the fact that the person is or has been entitled to use the drug under the laws of this state shall not constitute a defense against the charge.

(d) Violation of this section is a misdemeanor. Upon a first conviction of a violation of this section, a person shall be sentenced to not less than 48 consecutive hours' nor more than six months' imprisonment, or in the court's discretion 100 hours of public service, and fined not less than \$200 nor more than \$500. The person convicted must serve at least 48 consecutive hours' imprisonment or 100 hours of public service either before or as a condition of any grant of probation or suspension, reduction of sentence or parole. In addition, the court shall enter an order which (1) suspends the person's driver's license for a period of one year or, in lieu thereof, suspends the person's driver's license for 21 days or until the person completes any educational and treatment programs required by the court, whichever is longer, and thereafter places restrictions on the person's driver's license, as provided in K.S.A. 1984 Supp. 8-292 and amendments thereto, for the remainder of the one-year period; and (2) requires that the person enroll in and successfully complete an alcohol and drug safety action program or a treatment program as provided in K.S.A. 8-1008 and amendments thereto, or both the education and treatment programs.

of this section, a person shall be sentenced to not less than 90 days' nor more than one year's imprisonment and fined not less than \$500 nor more than \$1,000. The person convicted must serve at least five consecutive days' imprisonment before the person is granted probation, suspension or reduction of sentence or parole or is otherwise released. As a condition of any grant of probation, suspension of sentence or parole or of any other release, the person shall be required to enter into and complete a treatment program for alcohol and drug abuse as provided in K.S.A. 8-1008 and amendments thereto. In addition, the court shall enter an order which suspends the driver's license of the convicted person for a period of one year or, in lieu thereof, suspends the person's driver's license for 120 days or until the person completes the treatment program approved by the court, whichever is longer, and thereafter places restrictions on the person's driver's license, as provided in K.S.A. 1984 Supp. 8-292 and amendments thereto, for the remainder of the one-year period.

(f) On the third or subsequent conviction of a violation of this section, a person shall be sentenced to not less than 90 days' nor more than one year's imprisonment and fined not less than \$1,000 nor more than \$2,500. The person convicted shall not be eligible for release on probation, suspension or reduction of sentence or parole until the person has served at least 90 days' imprisonment. The court may also require as a condition of parole that such person enter into and complete a treatment program for alcohol and drug abuse as provided by K.S.A. 8-1008 and amendments thereto. In addition, the court shall revoke the driver's license of the convicted person for the period of time specified for the revocation of a driver's license under subsection (k) and in accordance with the procedure for revoking a driver's license under subsection (l).

(g) The court may establish the terms and time for payment of any fines, fees, assessments and costs imposed pursuant to this section. Any assessment and costs shall be required to be paid not later than 90 days after imposed, and any remainder of the fine shall be paid prior to the final release of the defendant by the court.

(h) In lieu of payment of a fine imposed

pursuant to this section, the court may order that the person perform community service specified by the court. The person shall receive a credit on the fine imposed in an amount equal to \$5 for each full hour spent by the person in the specified community service. The community service ordered by the court shall be required to be performed not later than one year after the fine is imposed or by an earlier date specified by the court. If by the required date the person performs an insufficient amount of community service to reduce to zero the portion of the fine required to be paid by the person, the remaining balance of the fine shall become due on that date.

(i) The court shall report every conviction of a violation of this section and every diversion agreement entered into in lieu of further criminal proceedings or a complaint alleging a violation of this section to the division. Prior to sentencing under the provisions of this section, the court shall request and shall receive from the division a record of all prior convictions obtained against such person for any violations of any of the motor vehicle laws of this state.

(j) For the purpose of determining whether a conviction is a first, second, third or subsequent conviction in sentencing under this section:

(1) "Conviction" includes being convicted of a violation of this section or entering into a diversion agreement in lieu of further criminal proceedings on a complaint alleging a violation of this section;

(2) "conviction" includes being convicted of a violation of a law of another state or an ordinance of any municipality which prohibits the acts that this section prohibits or entering into a diversion agreement in lieu of further criminal proceedings in a case alleging a violation of such a law or ordinance;

(3) only convictions occurring in the immediately preceding five years, including prior to the effective date of this act, shall be taken into account, but the court may consider other prior convictions in determining the sentence to be imposed within the limits provided for a first, second, third or subsequent offender, whichever is applicable; and

(4) it is irrelevant whether an offense occurred before or after conviction for a previous offense.
