

MINUTES OF THE SENATE COMMITTEE ON WAYS AND MEANS

INTRODUCTION OF BILL

Senator Bogina indicated that the Governor's Residence Advisory Commission had requested introduction of a bill to add, as a member of that commission, the president of the Friends of Cedar Crest Association.

Motion was made by Senator Gannon and seconded by Senator Talkington to introduce the requested bill. The motion carried by voice vote.

Mr. Wolgast distributed Attachments A and B for the committee's review. He reminded the committee that his presentation is a result of a request from this group during the 1985 session of the Legislature.

Mr. Wolgast explained that Title IIA includes large job training programs going directly to service delivery areas to train disadvantaged persons. He stressed that his Department has worked with those areas, urging them to develop programs for various correctional institutions of the state. They have been reluctant to do so. Now, some of the areas have taken the initiative, according to Mr. Wolgast. He said that Western Kansas has started a program with the Hutchinson Reformatory to help with placement of individuals when they leave the institution.

Mr. Wolgast continued by noting that eight percent (8%) of total JTPA funds must go to the Department of Education to provide training and resources in any area that is felt to be ignored by other programs. He noted that Attachment B shows the use of those funds.

According to Mr. Wolgast, there will be training for 60 inmates under the Carl Perkins Vocational Education Act of 1984 with funds provided under that act. He said the Department of Corrections is contracting with the Kansas City Area Vocational Training School to provide the training. Mr. Wolgast indicated he has had fine support from the Department of Education. He said they are assisting in tracking the funds expended under the JTPA program.

Senator Bogina asked about Attachment B, questioning the funding of the "Match" column. Mr. Wolgast replied that funding under JTPA must be matched 100% at the local level. He said that some school districts provide funding, or they may provide teachers for the program.

Answering a question from Senator Kerr, Mr. Wolgast said these funds will be new dollars to the Department of Corrections. He said funds were already obligated last spring, so there was not a lot of money available for the Department of Corrections. He added that the Department of Corrections program is only beginning.

Mr. Wolgast answered a question from Senator Gannon by explaining that any public agency can submit a program for JTPA funds and the Department of Education and the Department of Human Resources oversee the program.

He indicated that the program being discussed will be reduced by the Gramm-Rudman-Hollings Act.

Senator Bogina asked if any other states had used these funds for the Department of Corrections, and Mr. Wolgast answered that he is not aware of any. He noted, however, that offenders are a targeted group, as are school dropouts.

Senator Werts asked about progress on a Job Training Center which was to have been started in Manhattan. Mr. Wolgast said that he understands that the Department of Labor is to look at those states not having a Job Corps Training Center. He added that the funding has been substantially reduced so he is not sure what the status of the Manhattan Center will be.

The Chairman asked for comment from the Department of Corrections. Mr. Davies said that the Department of Corrections has a horticultural and building maintenance program at Kansas State Penitentiary and that is being expanded to Kansas State Institution at Lansing. He said that the horticultural program helped the women in the institution to find jobs in greenhouses, etc. It is also helpful because women can be placed in building maintenance in the Leavenworth area. Mr. Davies said his Department is looking at other programs at KSIL, but remodeling is needed in order to determine what type of programs to instigate.

There were questions about the building and remodeling programs in progress within the Department of Corrections. Mr. Davies said he is pleased with the manner in which the work is progressing.

Referring to the JTPA program within the Department of Corrections, Senator Gaines asked Mr. Davies if he definitely feels the job program is the proper move. He answered that it is a good program, particularly if people can be found who are able to work with inmates.

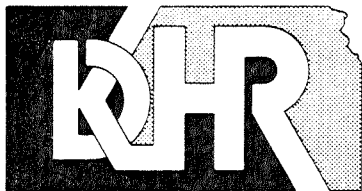
APPROVAL OF MINUTES

Job Training Partnership Act (JTPA) Funding for
Correctional Training Program at
Kansas State Penitentiary and
Kansas Correctional Institute at Lansing

The Kansas Department of Human Resources and the Kansas Department of Education, in conjunction with the Kansas Department of Corrections, will be providing training opportunities and services to the prison population at Kansas State Penitentiary and Kansas Correctional Institute. Funding will be provided by JTPA through Title IIA under the eight percent (8%) education set-aside (\$62,000) and the Carl Perkins Vocational Education Act of 1984 (\$13,500). The project, which should be operational by January, 1986, will train sixty inmates for jobs in building maintenance and horticulture.

Funding for the program in Fiscal Year 1987 will be provided from the same resources with Department of Education contributing \$54,900 and Department of Human Resources \$28,330.

AN ACT CONCERNING: Supplementary grants for certain counties.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF KANSAS:

- 1 That K.S.A. 75-52,109 be amended to read as follows:
- 2 (a) On and after July 1, 1984, a county or group of cooperating
- 3 counties participating under the community corrections act shall be
- 4 eligible for supplementary grant funds, in addition to those deter-
- 5 mined under K.S.A. 75-52,101 and amendments thereto, if:
- 6 (1) The population of the county or group of cooperating coun-
- 7 ties is within the range of 15,000 to 100,000; and
- 8 (2) The chargeback commitment rate per 1,000 population for
- 9 those committed to the custody of the secretary of corrections, but
- 10 not granted probation within 120 days after sentencing, is higher
- 11 than the state rate as determined from department of corrections
- 12 records for a two-year period ending six months prior to implemen-
