MINUTES OF THE HOUSE COMMITTEE ON ECONOMIC DEVELOPMENT

The meeting was called to order by Rep. Phil Kline at
Chairperson

12:15pm a.m./p.m. on Thursday, April 30, 1987 in room 423S of the Capitol.

All members were present except: Representatives Barkis, Dyck, Foster, Goossen, Hassler, Love, Mainey and Teagarden (All Excused)

Conferees appearing before the committee:

Chairman Kline called the meeting to order and opened it to discussion of S.B. 73. Rep. Miller moved to strike, in line 0512, all of the words after the word "obligation" to the end of line 0514. Rep. Leach seconded and the motion carried. Rep. Leach moved to strike all of lines 0515-0516 and 0517. Rep. Campbell seconded and the motion carried. Rep. Miller moved to strike the words "for purpose of personal gain" in line 0497. Rep. Chronister seconded the motion. After committee discussion, Rep. Miller withdrew the motion and made a new motion to insert the word "financial" between the words "any" and "interest" in line 0498, so that it would read "any financial interest." Rep. Chronister seconded and the motion carried.

Rep. Chronister moved that language be inserted in the bill, such as that amended to S.B. 407 yesterday, that would exclude Sunflower utility in Finney County from the restrictions in the bill in lines 0257-0261. Rep. Leach seconded and the motion carried.

Rep. Miller moved, and Rep. Chronister seconded, to change the words in line 0495 from "shall be met and provided by" to "shall be paid." The motion carried.

Rep. Miller stated that the definition of the word "construct", paragraph (g), lines 0050-0056, needed to be written in plainer language. He moved to change the language in this paragraph by deleting all the words after the comma in line 0051 to the end of the word "advertising" in line 0053, and to delete the words "under the circumstances existing at the time" in lines 0054-0055. Rep. Aylward seconded and the motion carried.

Rep. Miller moved to delete the words "sanitary, decent and safe" in line 0072. Rep. Aylward seconded the motion and it carried. Rep. Miller moved, and Rep. Leach seconded, to change section (f), lines 0154-0157, by citing the Kansas statute regarding expenses and mileage so as to be consistent with other legislation concerning reimbursement of board members. The motion carried.

Rep. Chronister moved to pass Substitute for S.B. 73 as amended. Rep. Weimer seconded and the motion carried.

The meeting was adjourned at 1:00pm. No further meeting of the committee is scheduled at this time.
