The next meeting will be Tuesday, January 27, 1987, at 9:00 a.m.

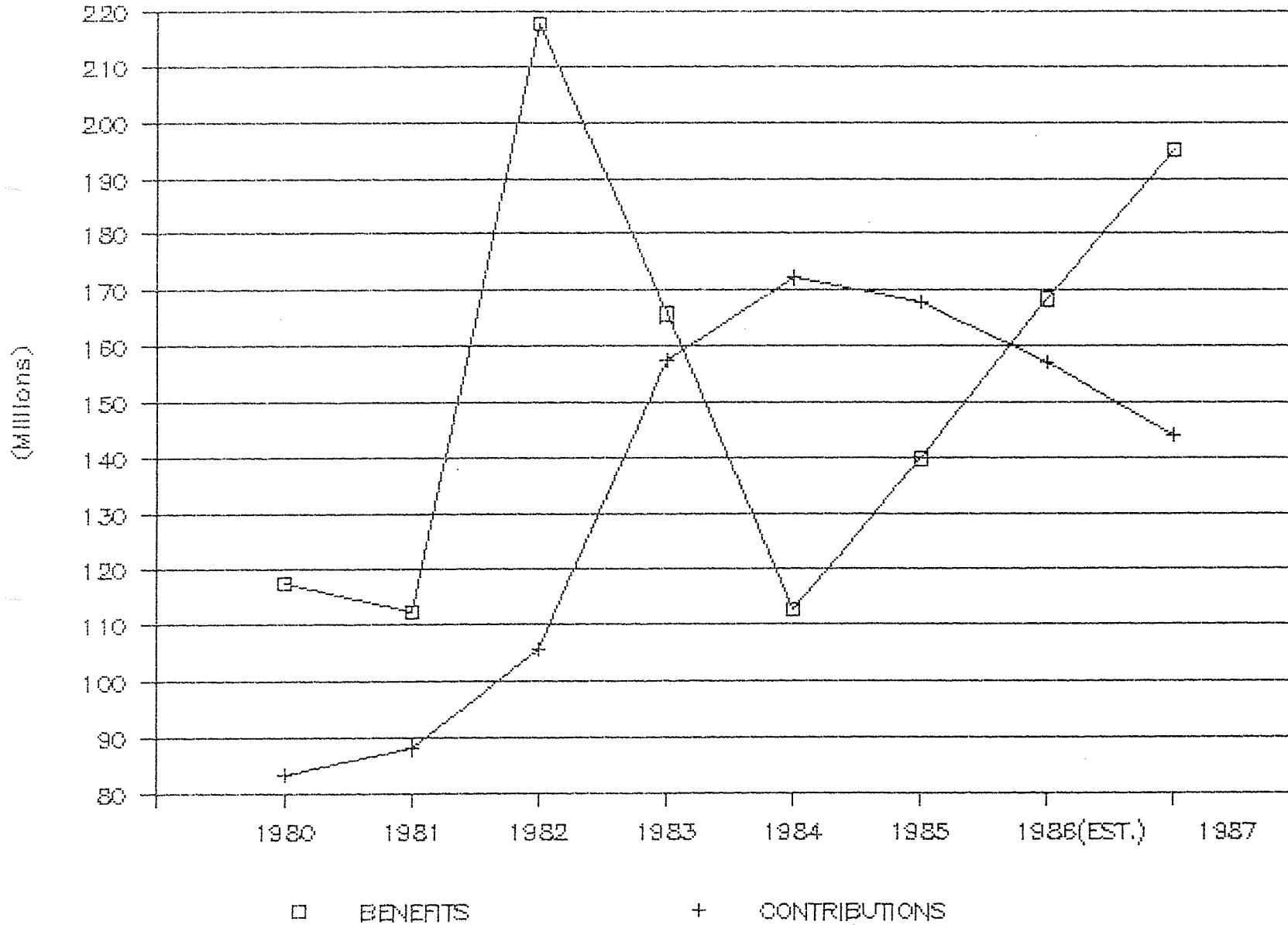
