The Chairman welcomed Representative Norman Justice, who appeared as a proponent of HCR 5014, concerning urging increased levels of activity to bring a rapid end to the racial apartheid system in South Africa. He said the matter had been approved by the National Conference of State Legislators (NCSL) last August in New Orleans. He said it passed the House of Representatives here with no problem. Senator Anderson moved it be reported favorably for passage. Seconded by Senator Strick. The motion carried.

SB 178, concerning English language being designated the official state language. Senator Strick moved to report the bill unfavorably. Seconded by Senator Hoferer. The motion carried.

S.B. 357, concerning alcoholic beverages and penalties for minors, was the next bill considered by the Committee. Senator Anderson moved that the bill be reported adversely. Seconded by Senator Strick. The motion carried.

SB 361, dealing with one-strength beer was considered next. Senator Morris moved to report the bill unfavorably. Seconded by Senator Anderson. The motion carried.

SB 363, concerning elimination of exclusive franchises of alcoholic beverage distributors, was next for consideration. Senator Bond moved it be reported adversely. Seconded by Senator Anderson. The motion carried.

Senator Morris moved that the Chairman be requested to draft a letter requesting that an interim study be made on the matter of the liquor franchise system to the Legislative Coordinating Council. Seconded by Senator Bond. The motion carried.

SB 398, which dealt with permitting brand and price advertising of liquor, was next. Senator Bond moved it be reported adversely. Seconded by Senator Hoferer. The motion carried.

A bill concerning seminars and samplings conducted by alcoholic beverage manufacturers and wholesalers, SB 399, was next for consideration. Senator Morris moved that the bill be reported adversely. Seconded by Senator Bond. The motion carried.

SB 400, dealing with regulation of alcoholic beverage suppliers, was recommended to be reported adversely. The motion was made by Senator Morris, and seconded by Senator Bond. The motion carried.

SB 401, concerning alcoholic beverage salesperson's permits, was the next bill for the Committee's consideration. Senator Morris moved that the bill be reported adversely. Seconded by Senator Bond. The motion carried.

SB 402, concerning licensing of microbreweries, was next for consideration. Senator Bond moved that the bill be reported adversely, seconded by Senator Morris. The motion carried.

SB 403, concerning public drinking establishments, was next. Senator Bond moved it be reported adversely. Seconded by Senator Morris. The motion carried.

The matter of licensure to carry concealed firearms was the subject of SB 38. Senator Strick moved that the bill be reported adversely. Seconded by Senator Anderson. The motion carried.

SCR 1606, deals with a constitutional amendment for the legislature to regulate the operation of lotteries by bona fide nonprofit organizations. Senator Morris moved that it be reported adversely. Seconded by Senator Anderson. The motion carried.

SCR 1608, dealt with a constitutional amendment providing for the voter initiative. Senator Hoferer moved to report it adversely. Seconded by Senator Morris. The motion carried.

HB 2546, concerns the secretary of corrections. The Chairman handed out a memorandum which had been prepared by Legislative Research today (Attachment #1). He had asked staff to prepare this for the Committee to reflect upon and think about in terms of what it might wish to do about this matter. There are strong feelings on both sides. There was Committee discussion. The Chairman asked the Committee to study the alternatives. When the Committee returns for the veto session be prepared to come with suggestions.

Following other announcements by the Chairman, the meeting was adjourned.
