Representative Campbell, Chairman of the House Agriculture and Small Business Committee, called the joint committee meeting of the Senate and House Agriculture Committees to order. Chairman Campbell welcomed the committee members and the congressmen. The Chairman turned the meeting over to Representative Glickman and Representative Roberts to discuss agricultural issues on the national level.

The congressmen discussed how all agricultural issues are affected by the budget for agricultural programs and the work to reduce budgets to help with the national deficit. The congressmen stated they felt no big changes were upcoming in the present farm program. The need was expressed for studying agricultural issues on a world wide basis and for international agreements to help the agricultural situation for all. The congressmen commented that new agricultural markets are sought and told of a new newspaper ink that is being made from soy beans. The congressmen encouraged the committees to give them Kansas input and thanked them for past support.

The Chairman thanked Congressmen Glickman and Roberts and adjourned the committees at 10:15 a.m.
