The meeting was called to order by Chairman Miller on April 29, 1989, at 3:30 p.m.

Representative Moomaw told the committee that he thought that #13 in the Comparison Memo should include language to include two co-ops who exceed the \$10 million gross sales of petroleum products (Beloit and Garden City).

Representative Moomaw made a motion, seconded by Speaker Braden, to go back to the House version dealing with eligibility for reimbursement (gross sales of petroleum products in an amount of \$20 million or less during his next preceding taxable year.

Gary Hulett, Health & Environment, said the department's concern is in satisfying criteria of the federal act. He felt that the \$10 million would be sufficient for self insurance criteria. He suggested that the proper language might be : Sec. 19 (12) line 31 - the owner and operator submits to the secretary proof, satisfactory to the secretary, that such owner and operator are unable to satisfy the criteria for self-insurance under the federal act and have less than \$10 million net worth involved in the sale of petroleum products.

Representative Spaniol expressed concern that if you deviate from current language in the bill, the bill will not be following along with federal requirements.

Representative Reardon expressed concern that this might inadvertently exempt more than is the committee's intent and therefore, he would vote "no".

A vote was taken on Representatives Moomaw's motion. The motion lost.

There was discussion on the vote that was taken at the morning meeting concerning municipal use fees. Speaker Braden expressed concern that the committee did not understand that the change in this item was from a sales tax to volume of water sold. Committee members told Speaker Braden that this was explained in the morning committee session and felt this was what they had voted for.

Speaker Braden read a letter from Anderson, Conlee & Associates stating that the 1 cent per gallon charge on fuel proposed in SB94 for the Storage Tank Trust Fund would have a severe impact on fueling operations at Ryan Aviation as well as at United Beechcraft. Decisions to "tanker up" are often made on less than a half a cent differential. The letter asked for an exemption for jet fuel in SB398 as passed by the Senate.

Speaker Braden made a motion, seconded by Representative Reardon, to reconsider the action of the committee at the morning session and to exclude jet fuel from the environmental assurance fee assessment. The motion carried.

Speaker Braden asked the committee to reconsider their action concerning the effective date for collecting fees. Speaker Braden expressed concern that the Senate might decide this bill is not needed this year.

Representative Spaniol explained that the reason for delay was so an interim committee could review this subject and get the bugs out before the State enters into contracts. He expressed concern that the same problems could arise that have arisen with the pension bill and the contracts therein. Moving the date up could be a \$100 million mistake. He also said that he would have to vote against the bill if this delay were not in the bill.

There was discussion on the contract issue and it was decided this issue needs a comprehensive study this summer.

Representative Reardon made a motion, seconded by Speaker Braden, to reconsider SB398. The motion carried.

Speaker Braden made a motion, seconded by Representative Barkis to withdraw his motion to report SB398 favorably for passage as amended. The motion carried.

Speaker Braden made a motion, seconded by Representative Barkis, to to adopt the committee amendments to the bill. The motion carried.

Speaker Braden made a motion, seconded by Representative Barkis, to report SB398 favorably as amended. The motion carried.
