MINUTES OF THE HOUSE COMMITTEE ON EDUCATION

The meeting was called to order by Chairman Don E. Crumbaker at

The meeting was called to order by Chairman Crumbaker.

The chairman announced a presentation of Agriculture in the Classroom and recognized Ms. Mardelle Pringle.

Ms. Pringle introduced Mr. Joe Lieber and Ms. Barbara Moyer, both members of the Kansas Foundation for Agriculture in the Classroom. Ms. Pringle gave background of the purposes and goals of the Foundation.

Ms. Becky Koch shared specific instances of materials that could be integrated into the classroom curriculum to improve agricultural literacy. Ms. Koch pointed out the enthusiasm generated among teachers and students as well through the Agriculture in the Classroom program.

The chairman expressed appreciation for the presentation of the Ag in the Classroom Program.

Chairman Crumbaker drew attention to HB 2152, regarding student tuition rates at community colleges. Chairman Crumbaker offered an amendment to HB 2152 which would phase in the raise in tuition a dollar a year and enable the community colleges to adjust their scholarship plans. (Attachment 1) Representative Empson moved acceptance of the amendment. Seconded by Representative R. D. Miller. Motion carried. Representative Empson moved to pass HB 2152 favorably as amended. Second by Representative Williams. Motion passed.

HB 2484, concerning the motorcycle safety fund in community colleges, was brought before the committee for discussion.

Representative Empson moved HB 2484 be passed favorably by the committee. Seconded by Representative Amos.

Representative Harder moved to conceptually amend HB 2484 to insure no credit hours would be allowed from these motorcycle safety courses. Seconded by Representative Amos. Motion carried. Representative Branson moved HB 2484 be passed as amended. Seconded by Representative Reardon. Motion carried.

HB 2464, concerning school districts participation in disaster relief programs, was brought before the committee for consideration by the chairman.

Representative Amos moved to pass HB 2464 favorably. Seconded by Representative Williams. Representative Empson moved to amend HB 2464 by adding the line "and having demonstrable plan for transportation and distribution". Seconded by Representative Pottorff. Motion to amend passed. Representative Amos moved that HB 2464 be passed

as amended. Seconded by Representative Harder. Motion carried.

Chairman Crumbaker recognized Representative Hurt. Representative Hurt offered an amendment (Attachment 2) to HB 2215, concerning providing milk snacks for pupils in school districts and nonpublic schools. The amendment would make the act permissive, not mandatory, and state reimbursement would be for those students who are on free or reduced-price meals. Representative Reardon seconded the amendment. After a period of discussion Representative Empson moved to table HB 2215. Seconded by Representative Williams. A division vote was called for and the motion lost 12 - 10. A vote was taken on the amendment and the amendment was adopted. Representative Hurt moved the passage of HB 2215 favorably as amended. Seconded by Representative Bowden. After a division vote was called the motion passed with 12 yes votes.

Representative Bowden asked for the committee to consider HB 2490, concerning the Kansas student community service act.

Representative Bowden moved to amend HB 2490 by striking (1) on line 45 and renumbering by making (2) number (1) and (3) becoming number (2). Seconded by Representative Williams.

The amendment carried. Representative Bowden offered another amendment to HB 2490 (Attachment 3) which would insure 50 percent of moneys going into at risk programs. Seconded by Representative Williams. Motion carried. Representative Bowden moved to pass HB 2490 as amended. Representative David Miller seconded. Motion carried.

The meeting was adjourned at 4:50 p.m.

On page 1, in line 25, after "amount"; by inserting ": For the 1990 fiscal year, not less than \$15 per credit hour; for the 1991 fiscal year, not less than \$16 per credit hour; for the 1992 fiscal year, not less than \$17 per credit hour; for the 1993 fiscal year, not less than \$18 per credit hour; for the 1994 fiscal year and for each fiscal year thereafter,"; in line 27, by striking "The" and inserting "Subject to the provisions of K.S.A. 71-302, and amendments thereto, the"; in line 29, after "than", by inserting "\$55 per credit hour or an amount not less than"; in line 31, after "(1)", by inserting ", whichever is the greater amount"

Proposed Amendment to House Bill No. 2215

On page 1, in line 30, by striking "any preschool program, kindergarten or"; in line 42, by striking "shall" and inserting "may"; in line 43, after "board", by inserting ", upon request of a parent or guardian of such pupil,";

On page 2, in line 45, by striking "so"; in line 46, by striking all before the period; also in line 46, after the period, by inserting the following three sentences: "Pupils who qualify for free meals under the national school lunch act shall be provided milk snacks free of charge. Pupils who qualify for reduced-price meals under the national school lunch act may be charged a price, for each milk snack provided, which does not exceed an amount equal to one-half the cost incurred by the board for provision of the milk snack. Pupils who do not qualify for free or reduced-price meals may be charged a price, for each milk snack provided, which does not exceed an amount equal to the cost incurred by the board for provision of the milk snack.";

Also on page 2, in line 47, by striking "Each" and inserting "In each school year, each"; also in line 47, after "board", by inserting "which has provided milk snacks for pupils"; in line 48, by striking all after "to"; in line 49, by striking all before the comma and inserting "the cost incurred for milk snacks provided during the school year to pupils who qualify for free meals, plus an amount equal to one-half the cost incurred for milk snacks provided during the school year to pupils who qualify for reduced-price meals"; in line 53, after "board", by inserting "which is entitled to state moneys under this act"; in line 54, by striking "under this act"; in line 56, after "board", by inserting "which receives state moneys under this act"; in line 80, after "district", by inserting "which is entitled to state moneys under this act";

On page 3, in line 81, by striking ", which" and inserting ". The milk snack";

In the title, in line 17, by striking "requiring" and inserting "authorizing"

Proposed Amendment to House Bill No. 2490

On page 2, in line 73, by striking all after "programs"; in line 74, by striking all before the semicolon; following line 74, by inserting a new paragraph as follows:

"(4) allocate and distribute moneys appropriated for administration and operation of programs to institutions so that at least 50% of such moneys are allocated and distributed for programs designed for the assistance of students who are at risk of failing at or dropping out of school, or for the assistance of students in completing requirements for graduation from high school and preparation for postsecondary education or training, or for assistance in adult basic education or literacy programs;"

Also on page 2, in line 75, by striking "(4)" and inserting "(5)"; in line 78, by striking "(5)" and inserting "(6)";

On page 4, in line 136, by striking "Subject to the provisions of subsection (d), eligible" and inserting "Eligible"; by striking all of lines 144 through 151
