MINUTES OF THE SENATE COMMITTEE ON EDUCATION

Conferees appearing before the committee:

SB 52 - An act affecting the composition of the Coordinating Council on Early Childhood Development.

Following a call to order, Chairman Joseph C. Harder referred the Committee's attention to SB 52. Senator Frahm distributed copies of a proposed amendment to SB 52 (Attachment 1) which, she said, materialized following discussions between the Governor's office and the State Department of Education. The revisor explained the changes to the Committee.

Senator Allen moved, and Senator Frahm seconded the motion that the proposed amendment to SB 52, as described to the Committee, be adopted. Senator Frahm seconded the motion, and the amendment was adopted.

Senator Parrish made a conceptual motion to amend SB 52 so as to include representation of the minority party in the membership of the Coordinating Council. Senator Steineger seconded the motion.

Senator Langworthy made a substitute motion to amend SB 52 by including in the membership of the Coordinating Council one member each from the House and the Senate, representing both political parties, to be appointed by the Legislative Coordinating Council. Senator Frahm seconded the motion, and the amendment was adopted.

Senator Frahm moved, and Senator Langworthy seconded the motion that SB 52, as amended, be recommended favorably for passage. The motion carried.

SB 12 - Establishes the Kansas Ethnic Minority Scholarship Program

The revisor submitted copies of a proposed amendment to SB 12, Attachment 2, as requested by Ms. Clantha McCurdy, Director of Financial Aid, and Mr. Ted Ayres, General Counsel, Board of Regents, and explained the amendment to the Committee. Responding to a question, the revisor replied that the amendment is intended to make the bill less discriminatory.

Senator Parrish moved that the proposed amendment, as requested by the State Board of Regents, be adopted. Senator Karr seconded the motion, and the amendment was adopted. Senator Allen moved that SB 12, as amended, be recommended favorably for passage. Senator Frahm seconded the motion, and the motion carried.

SB 118 - An act concerning accredited elementary schools; requiring the teaching thereby of certain subjects; amending K.S.A. 72-1101 and repealing the existing section.

Following Committee discussion, Senator Montgomery moved, and Senator Karr seconded the motion that SB 118 be tabled until next year. The motion carried. A Committee recommendation was that SB 118 be reviewed by an interim committee.

On page 1, following line 26, by inserting a new provision as follows:

"(1) The governor or a representative of the governor;"

Also on page 1, in line 27, by striking "(1) Three" and inserting "(2) Two"; in line 28, by striking all after "services"; in line 29, by striking all before "and"; in line 33, by striking "(2)" and inserting "(3)"; in line 37, by striking "(3)" and inserting "(4)"; in line 39, by striking "(4)" and inserting "(5)"; in line 43, by striking "(5)" and inserting "(6)"; also in line 43, by striking "are" and inserting "shall be"; in line 45, by striking "are" and inserting "shall be"; in line 46, by striking "are" and inserting "shall be";
