Jim Gregory, Beech Aircraft Corporation said there is a balance of \$5.8 billion in the trust fund and release of these funds by the federal governmentwould serve to enhance the nation's airport and airway system capacity and make for safer skies. George M. Boyd, KDOT, said they support this resolution and Kansas has a pressing need to revitalize, repair, and maintain our several public-use airports. A copy of his statement is attached. (Attachment 2).

REMARKS BY JIM GREGORY REGARDING SCR 1612 KANSAS SENATE TRANSPORTATION AND UTILITIES COMMITTEE

Thank you Mr. Chairman, members of the committee. My name is Jim Gregory of Beech Aircraft, Kansas' second largest private sector employer. We have 6,100 employees in Wichita, Salina and Andover.

We thank you for the opportunity to appear today in support of Senate Concurrent Resolution No. 1612.

Those of us in the aviation industry have been encouraging Congress and the Administration for many years, to use the ever growing balance in Federal Aviation Trust Fund for the purposes for which the money was collected.

Currently there is an unobligated balance of \$5.8 billion languishing in the trust fund, captive to Washington maneuvers on deficit booking. Anything that the Kansas Legislature could do to encourage our friends in Washington to free this large sum would be welcomed by the industry.

Beechcraft has real estate interests on more than 30 airports throughout the country. Our aircraft are used on virtually every airport which receives Federal funding and are flown every day in airspace managed by the Federal Government.

Of primary concern to general aviation manufacturers and those who fly our airplanes, is access to the national air transportation system. Release of these funds for use in the proper manner could serve to enhance the nation's airport and airway system capacity and make for safer skies.

SUBJECT: Testimony on Senate Concurrent Resolution No. 1612

Mr. Chairman, Ladies and Gentlemen of the Committee, we of the Kansas Department of Transportation (KDOT) would regard passage of Senate Concurrent Resolution No. 1612 as an expression of an urgent requirement to improve the airports of the United States and Kansas.

The federal trust fund surplus is approximately six billion dollars as of this date. Kansas, among the several United States, has a pressing need to revitalize, repair, and maintain our several public-use airports. The present allocation of federal trust fund money is insufficient to maintain the present national and state airport systems. The longer this is allowed to continue the more overall money will be required to bring the system back to a serviceable condition. We recommend passage of Senate Concurrent Resolution 1612.

Wichita Airport Authority Remarks by Cathy Holdeman SCR 612 Committee on Transportation and Utilities

Mr. Chairman, I am Cathy Holdeman representing The Wichita Airport Authority of the City of Wichita.

The Wichita Airport Authority very much supports the language and intent of SCR 1612 regarding the urging of the United States Congress to use the monies in the Federal Aviation Trust Fund for the purposes for which they were collected.

As of the end of the Federal Fiscal Year 1988, the balance in the Aviation Trust Fund was \$5.8 Billion. These monies were collected for the purpose of maintaining and expanding our nation's airports. Even though the fund is now supporting 75% of all Federal Aviation Administration expenditures, the U. S. Government continues to tax the aviation industry, creating the large surplus. The large surplus is now being used to make the Federal deficit look smaller.

At a time when the airport system in the United States is in a crisis stage, the Kansas Delegation to Washington, D. C. must be urged to vote to release the funds for their intended purpose.

The 1990 Airport Improvement Program authorization level is \$1.8 Billion. However, Congress continues to appropriate below the authorization level as demonstrated by the 1989 appropriation of \$1.3 Billion.

Approximately \$5 Million is collected annually by the Federal Government through the 8% ticket tax from passengers using Wichita Mid-Continent Airport. However, The Wichita Airport Authority is entitled to be returned only \$2 Million per year under the program. It is projected that Wichita Mid-Continent Airport will require at least \$5 Million from the Trust Fund each year for the next five years in order to adequately continue rebuilding the 38 year old airport facility. Releasing the Aviation Trust fund for its intended purpose would go a long way toward meeting the needs of The Wichita Airport Authority, Kansas airports, and our nation's air transportation system.

The Wichita Airport Authority recommends the passage of SCR 1612.

SENATE BILL No. 141

AN ACT concerning crimes and punishments; relating to cross-titling of motor vehicles.

Be it enacted by the Legislature of the State of Kansas:

Section 1.1 (a) It shall be unlawful to have cross-titled a fitle to any purchaser of any vehicle or mobile home. Cross-titling means either selling or causing to be sold, exchanged or transferred any vehicle or mobile home and not showing a complete chain of title on the papers necessary for the issuance of title for the purchaser.

(b) Cross-titling of a title is a-class B misdemeanor.
Sec. 2. This act shall take effect and be in force from and after its publication in the statute book.

(a) It shall be unlawful to transfer ownership to any vehicle or mobile home and fail to show oneself on the transferred certificate of title.
