MINUTES OF THE SENATE COMMITTEE ON GOVERNMENTAL ORGANIZATION

The meeting was called to order by Senator Lana Oleen at

Discussion on:

SB 427 - Housing & housing related programs

Chairman Oleen reviewed background of the development of SB 427, which was proposed after an interim study of SB 253, the housing bill introduced in the 1989 session.

Paul West explained the differing amounts of resources and personnel in the fiscal notes for SRS and the Department of Commerce. The Department of Commerce did not have any indication of the timing of revenue streams of the federal department when forming their fiscal note, so initially funding was requested from the General Fund for the housing program. Current staff of SRS would probably be inadequate to handle current load due to regulatory push being sought for auditing programs. Chairman Oleen stated inquiry has indicated the programs on housing now in place, have not missed revenue sources from federal grants and also feels the weatherization programs should not be included in the responsibilities of the proposed Department of Housing as these are funded separately and deal with existing homes.

Chairman Oleen introduced a list of suggested members for an Advisory Committee to be formed, charging them to give input for a state housing plan and report to the Legislature by march, 1991. (Attachment 1)

It was further recommended the proposed legislation take effect with publication in the Kansas Register.

The composition of the suggested Advisory Committee, compensation to the members, meeting schedules and expected duties and powers were discussed by the Committee. Concern was expressed as to the necessity for an Advisory Committee and to their participation in preparing a state housing plan. Chairman Oleen proposed changes in the language of the bill which were discussed by Committee.

A motion was made by Senator Bogina to strike "government" on page 1, line 35 and insert Department of Housing & Urban Development; in line 36 strike "and Housing Related Acts and"; seconded by Senator Doyen. Motion carried.

A motion was made by Senator Bogina to insert "which include a Director of Housing" on page 2, line 14 after Commerce; seconded by Senator Vidricksen. Motion carried.

A Subcommittee was appointed to study the purpose, responsibilities and criteria of the proposed Advisory Committee to the Housing Office. Members are as follows: Senators Bogina, Francisco, Kanan and Vidricksen. The Subcommittee will report to the full Committee before further discussion or action is taken on SB 427.
