MINUTES OF THE SENATE COMMITTEE ON JUDICIARY

The meeting was called to order by Chairperson Senator Wint Winter Jr. at
10:05 a.m. on March 21, 1991 in room 514-S of the Capitol.

The Chairman opened the meeting by announcing the hearings for the sentencing guideline measures would be for looking at the specifics of the bills and discussion of the policy issues.

SB 381 - sentencing commission duties and functions.

SB 382 - enacting a presumptive sentencing guidelines system.

Chairman Winter noted that the primary duty of the Sentencing Commission was to take data, analyze and formulate a grid for use in projections of prison populations. Early projections were key to the concepts developed. The Commission developed the proposed guidelines (SB 382) based on data from 1989. Meanwhile, the Department of Corrections, based on the efforts of an outside entity through an National Institute of Corrections (NIC) grant, conducted an extensive examination of information and have just recently submitted their report.

The DOC study projections, using new material and new methods, does not verify the KSC projections. The report does not reflect a flaw in the KSC analysis, only that information and tools for analyzing were different. It is necessary that the KSC staff and DOC experts reconcile the differences in the two projections. We are fairly confident there can be a reconciliation but will need time for that to be done. Therefore, we should not act on the guidelines unless we have solid figures to base judgments on. The KSC may be able to respond and make updated recommendations, reporting back to this committee.

The Chairman suggested letting KSC and DOC complete a reconciliation of reports and, if time permits in this year's session, the Senate could work the bill and act on it, sending it to the House before adjournment. The Chairman felt that the time factor prohibits completing action on the bill this year.

Steven Davies, Secretary of the Kansas Department of Corrections, reported the DOC report was received on March 13, 1991 and he is meeting with the preparer from California now, trying to complete the work on reconciling the figures as soon as possible. He added that the Attorney General had been working on making sure beginning figures were as accurate as possible. Hopefully, the reconciliation of figures would be completed in a week.

Attorney General Robert Stephen addressed the Committee with his support of SB 381. He expressed his opinion that it is necessary to reconcile the impacts of the two reports. He added that the KSC is abolished in July 1991, and it is important for the sake of continuity to continue the Commission if the guidelines are to be adopted. If new KSC members have to revisit the same process as before, need some way to keep KSC cohesiveness to retain mechanism and achievements of previous work. Secretary Davies added his support to SB 381 and submitted additional information regarding a Behavior Attitude Adjustment Time amendment to SB 382.

Ben Coates, Kansas Sentencing Commission, speaking in support of SB 382, expressed his feeling of encouragement after reviewing the assumptions the DOC report began with. He felt wrong figures were used to begin work on the report and has been working with the DOC to reconcile the differences. He stated if the Committee's policy changes to SB 382 are major, there will be some adjustments to the guidelines.

Mr. Coates continued in explanation and support of SB 381. He suggested amending the bill since it was written on the assumption that the guidelines (SB 381) would be in place before original expiration of commission. Amending would continue their authority to carry out the tasks assigned by the governor or legislature.

The Committee discussed whether to continue/extend the Commission's authority and scope.

Senator Gaines moved to conceptually amend SB 381 making changes as necessary for the functions of the Kansas Sentencing Commission to equal the entity now known as the Criminal Justice Coordinating Council, renaming it the Criminal Justice Coordinating Commission. Senator Bond seconded the motion. The motion to amend carried.

Senator Rock moved to conceptually amend SB 381 to continue the present appointees in place on the KSC for two additional years, first new appointments to be in 1993; replace the four legislator ex officio members with four voting members from the public at large, requiring at least two of the new appointees to be from minority groups appointed by the Governor. Senator Feleciano seconded the motion. The motion to further amend carried.

Senator Bond moved to further amend SB 381 to leave language on page one that is now stricken, allowing the Commission to continue to develop the guidelines as necessary until the task is completed and finalized, and to change the effective date of the bill to publication in the Kansas Register. Senator Gaines seconded the motion. The motion to further amend carried.

Senator Gaines moved to recommend SB 381 favorable for passage as amended. Senator Rock seconded the motion. The motion carried.

The meeting was adjourned.

New Section 22 of SB 382 establishes the concept of Behavior Attitude Adjustment Time (BAAT). As set forth in the bill, the concept is one of "bad time" where time is added to the base sentence for instances of negative behavior. The maximum amount of time which could be added to the sentence would be limited to 20 percent of the base sentence. The bill authorizes the Secretary of Corrections to adopt rules and regulations regarding Behavior Attitude Adjustment Time.

The concept proposed in SB 382 differs from that suggested by the Department of Corrections. Attached hereto is a copy of the proposal presented by me to the Sentencing Commission. As you will note in reviewing this proposal, I recommended formulating a system whereby the base sentence will be enhanced by 25 percent. The inmate will then be afforded the opportunity to earn BAAT credits back to the base sentence. The inmate may not be released earlier than the term provided by the base sentence and may not serve longer than 25% more than the base sentence.

The difference in the two concepts is one of philosophy. I believe it is important for purposes of management and control of correctional facilities to provide inmates with an incentive for good behavior. That is an approach widely used in corrections as 44 of the 50 states have a good time system. Of the states with sentencing guidelines, only one (Pennsylvania) does not have a good time system. However, a legislative committee in Pennsylvania studying recent inmate riots in that state has recommended that a good time system be implemented.

The Department of Corrections already has in place a system to punish inmates who act out in a negative way. That system provides for penalties such as disciplinary segregation, loss of good time credits, fines, and loss of privileges. If the current concept of earned credits is converted into a form of punishment as well, only alternatives with negative consequences will remain. From a management and control aspect, I believe it is preferable to have both a punishment and an incentive option available.

BAAT credits could be earned in increments throughout the term of the sentence. For serious rule violations, credits already earned could be forfeited. I believe this system is a more effective management and control system than the one set forth in SB 382.

Attached hereto are amendments to SB 382 which would be necessary as a result of the Department's proposal. I strongly urge the Legislature to give this matter careful consideration.

TRUTH IN SENTENCING

The State of Kansas currently has an indeterminate sentencing system. Under the present system, the sentencing judge imposes a minimum term of incarceration and a maximum term of incarceration.

A guiding principle endorsed by the Sentencing Commission is truth in sentencing. Simply stated, truth in sentencing means the amount of time an offender must serve is known to all concerned from the individual offender to the general public as a whole.

The current system of indeterminate sentencing is in direct conflict with the truth in sentencing principle in several ways; including:

1. The range of sentence (e.g. 5-20 years) is so large that it gives an unclear message to the individual offender and general public as to how much time must be served.
2. The message becomes even more unclear when, in reality, many offenders are released even before the minimum (short-end) sentence is served.
3. The uncertainty created makes it virtually impossible to predict or plan prison bed space needs and community (parole) supervision needs.

To overcome the problems inherent with an indeterminate sentencing system, a determinate ^{or} of "flat time" system is frequently regarded as the best alternative. While a determinate sentencing system enables the time an inmate must serve to be better regulated, a determinate sentencing system provides virtually no mechanism by which inmate behavior may be regulated. From the perspective of the Kansas Department of Corrections, regulation of inmate behavior is at least equally as important as the regulation of time.

Moving from a system of indeterminate sentencing to a system of determinate sentencing is regarded by the Kansas Department of Corrections as a very significant step. While the goal of truth in sentencing is highly desirable, the Department of Corrections believes that it should be implemented in a manner which considers the impact on the management of correctional facilities. Implementation without a management control is viewed as solving one problem while creating another. We believe that an approach which considers both objectives is more desirable and should be adopted. The proposal suggested by the Kansas Department of Corrections hinges on: 1) significantly reducing the range of the indeterminate sentence; 2) carefully delineating the range of sentence imposed in the sentencing order; and 3) elimination of the Parole Board as the releasing authority.

REDUCE THE RANGE OF SENTENCE

Under the present system the range between the minimum and maximum sentence can vary up to as much as 400% of the minimum (e.g. 5-20 years).

The Department of Corrections proposes that this range be limited to either 25% or 33 1/3%. Under this proposal the sentencing grid, determined by the Sentencing Commission, would establish the minimum (base) amount of time the offender must serve. The base sentence, however, would be enhanced by an established percent (i.e. 25% or 33 1/3%). The enhanced sentence is the time the offender could serve.

Offenders would enter the prison system assuming that the maximum (enhanced) sentence would be served. However, by earning Behavior - Attitude Adjustment Time (BAAT), the offender's actual time served could be reduced to the minimum (base) sentence. BAAT would be determined and administered by the Kansas Department of Corrections in accordance with standard and uniformly applied ratings of the inmate's behavior, adjustment, attitude, and program performance. During each rating period a proportionate amount of credit could be earned. In a similar manner, previously earned credit would be subject to forfeiture through the inmate disciplinary procedure should the offender's conduct warrant this action.

A 25% sentence enhancement table is presented as Attachment 1. Attachment 2 is a 33 1/3% enhancement table.

DELINEATION OF THE SENTENCE RANGE

Under the current system, the sentencing document does not include an explanation of the amount of time a defendant will be required to serve on a particular sentence. The Kansas Department of Corrections proposes that greater detail be included in the sentencing document to explain the parameters of the sentence. An example of such an explanation is set forth in Attachment 3.

The Department of Corrections also proposes that the sentencing court be responsible for determining the Behavior - Attitude Adjustment Time a defendant may receive for time incarcerated prior to commitment to the custody of the Secretary of Corrections.

ELIMINATION OF PAROLE BOARD AS THE RELEASING AUTHORITY

Under the current system, each offender's case is presented to the Parole Board for release determination. When an offender's case is first presented is determined by the deduction of good time credits from the minimum sentence expiration date. Irregardless of how much good time credit the inmate has earned or how much time the offender has served, release is based upon the Parole Board's assessment of the case. (i.e. Has the offender served a

sufficient amount of time in relation to the seriousness of the offense?) Having established the amount of time to be served in the sentencing grid, based upon crime seriousness and criminal history, assessment by the Parole Board for purposes of release determination is not necessary.

The system of Behavior - Attitude Adjustment Time proposed by the Kansas Department of Corrections has advantages over both the present indeterminate sentence system and a purely determinate system:

1. All concerned know the parameters of the sentence.
2. The system allows for behavioral control.

The proposed system will also allow the Kansas Department of Corrections and other criminal justice agencies to better predict and plan bed space and community supervision needs. Though this capability is not as precise as that which a purely determinate system would provide, there is far more certainty and less subjectivity; this will allow reliable statistical analysis. The importance of management control of inmate behavior is so critical that it outweighs the goal of a precise capability of determining inmate population needs.

Dear Senator Winter:

Enclosed is an article from the BNA Practice Manual, which your Committee Members may wish to consider upon the introduction of the Bill, which is intended to implement the sentencing guidelines proposed by the recent report.

Although the Kansas Sentencing Commission Report has tried very hard to avoid many of the pitfalls found in the federal guidelines, there remain vestiges of those problems which are inherent in guidelines in general.

The enclosed article also addresses the increased use of mandatory sentences, which seem to be propounded in numerous bills presently pending before both the House and the Senate Judiciary Committees. I share the concerns expressed by the judges in the article, and I know those concerns are also shared by the membership of the Kansas Association of Criminal Defense Lawyers and the public defenders across the State. While the KACDL and the public defenders across the State support the goals of reducing racial disparity in sentencing, we worry that the proposals of the Commission will not achieve that goal. The wide discretion left to the courts in determining whether to depart from the presumptive sentence has been cited as a defect through which the trial judges will plunge to continue disparate treatment. My personal concern is that a reduction in court discretion will be advocated to the discretion of the prosecutor. The enclosed article clearly shows that to be a well founded fear. I strongly urge the Committee to consider establishing prosecutorial guidelines regarding charging and plea negotiation at the same time they establish judicial sentencing guidelines.

I also hope the Committee and the Legislature as a whole will consider the hidden fiscal impact of the implementation of guidelines. My visits with defense lawyers across the State uniformly result in the comment that there are likely to be



more trials under a guideline system as proposed. I share that view and I note that the article also confirms the belief that such is the case. The indigent defense system, including public defenders and assigned counsel, in my view, is certain to see increased costs in the defense which result from more tried cases. It follows that additional trials will also stress the courts and prosecutor's offices.

If further hearings are held once a bill is introduced, I would appreciate the opportunity to address your Committee on behalf of the Kansas Association of Criminal Defense Lawyers and on behalf of the public defenders across the State.

Thank you for the opportunity to be heard.

The ACLU of Kansas has some concerns regarding the guidelines recommended by the Sentencing Commission.

First, it is important to remember that taking away an individual's physical freedom is one of the most severe deprivations of liberty that the state can impose. Imprisonment is harsh, frequently counter-productive, and costly. Therefore, there should be a heavy burden of justification on the imposition of any prison sentence.

Further, the ACLU believes non-incarcerative options should be available as alternatives to prison in every situation.

The ACLU opposes indeterminate sentences. We support sentencing guidelines as a way to have determinate sentencing. However, we support guidelines that allow the judge discretion to apply mitigating and aggravating factors equally. The general factors that could be taken into account as mitigating and aggravating factors should be set out as part of the guidelines. Also, probation, house arrest and community corrections should be available alternatives to incarceration in every situation. The guidelines by the Sentencing Commission do not have non-incarcerative options open for every situation, and do not appear to treat mitigating as well as aggravating circumstances with the same weight.

We applaud the Sentencing Commission for their attempts to reduce racial inequality in the system. However, racial bias exists in the whole society, and attempts to remove such discrimination by reducing judicial discretion alone may not be the answer. We believe the discretion is just moved into the hands of the prosecutor.

The ACLU agrees with the Sentencing Commission's report that incarceration should not be viewed as rehabilitation. (However, this is not a reason to exclude programs in the prison system to assist in rehabilitation.) We believe that the emphasis in the justice system should be on rehabilitation of convicted persons, not the imposition of mandatory sentences. It is important to remember that a link has not been established between harsher sentences and general deterrence.

We applaud the Commission in the changes made regarding when a person can have their parole revoked. Under our reading of the guidelines, a person may not be imprisoned more than 90 days for parole violation unless a trial is held on the additional alleged wrongdoing.

We are aware of the terrible pressure being brought on legislators to "do something" about crime. Numerous bills calling for mandatory sentences with no parole or probation have been introduced this session. But in this year of the anniversary of the Bill of Rights, the ACLU asks that you keep the broader picture in mind of the limitations on the government's right to incarcerate its citizens. We ask that you remember that rehabilitation, as opposed to mandatory lengthy incarceration, keeps a person in society, allows them to support their dependents, pay taxes, and have hope for a productive future.
