MINUTES OF THE HOUSE COMMITTEE ON ECONOMIC DEVELOPMENT

Chairperson Gjerstad called the meeting to order at 3:40 p.m.

The Chair opened discussion on **HB 2680**, an act establishing the adult basic literacy grant program. She stated the Senate appropriations subcommittee report acknowledged that the adult literacy organizations are providing a desperately needed service. Representative Chronister made a motion HB 2680 be passed. Seconded by Representative Dean. Motion carried.

Chairperson Gjerstad reopened discussion on **HB 2681**, the legislation concerning enterprise zones. The Chair called on Mark Burghart, Legal Counsel for Department of Revenue. Mr. Burghart distributed requested material pertaining to business and job development credits. Attachment 1.

Mr. Burghart responded to questions from committee members.

Representative Wempe made a motion to adopt an amendment that Page 1, line 18, be retained, deleting lines 19 through 21 and inserting non-manufacturing business, excluding retail, which create five or more positions to trigger benefit job credits. Seconded by Representative Bishop. Motion carried.

Representative Wempe made a motion to amend Page 2, starting at line 27 deleting all reference to "main street" designation as criteria for a qualifying city. Seconded by Representative Bishop. Motion carried.

Representative Wempe made motion to delete "revenue impact" on Page 3, line 32, of the local's report to Kansas Department of Commerce, and on Page 3, line 38 to add to provide a report by the Department of Revenue on county basis of the fiscal impact to include credits claimed and credits used. Seconded by Representative Chronister. Motion carried.

Representative Wagnon made motion to change name of this legislation to Kansas Enterprise Zone Act. Seconded by Representative Love. Motion carried.

Representative Bishop made motion to elevate the metropolitan job credit benefits to \$2000 and eliminate the distinction between metropolitan and non-metropolitan enhanced. Seconded by Representative Dean. Motion failed.
