The Kansas Corporation Commission would ask the House Energy and Natural Resources Committee to introduce legislation on behalf of the KCC. The legislation proposed for introduction has been approved by the Governor's office.

Attached please find a brief synopsis of each statutory change, proposed new statute, and a bill draft from the Revisor's office.

The attached legislation includes: 1) ~~Mandatory One Call Damage Prevention Program~~; 2) Unit Operations- Applicants Responsible for Notice; 3) Definition of Cathodic Protection Wells; 4) Elimination of Reports of Non-Concurrence with Commission Regulations by Secretary of Health and Environment; 5) Elimination of the Interagency Committee on Minimum Disposal Depths; 6) Dues and Donations, treatment in rate cases; 7) Oil and Gas Operator Licensing-Fee Exception; and 8) Utility Incentives for Energy Programs.
