The chairman called the meeting to order shortly after 1:30 p.m.

<u>SB-569</u> - Concerning the use of campaign contributions.

Tricia Thornton appeared before the committee and presented testimony from Senator Lana Oleen in support of $\underline{SB-569}$. This bill would allow candidates or candidate committees to share reimbursement of costs for surveys, or other related activities on a proporational share basis. Passage of the bill would better facilitate coordination of legislators who share joint constituencies. (Attachment 1)

Senator Bond, with a second from Senator Yost, moved to pass out SB-569 favorably. The motion carried.

Senator Yost requested introduction of a committee bill defining failure to act - meaning that if the legislature does not have a bill to the governor by April l on the issue of apportionment, Senate and House, that this would constitute "failure to act" and the court would be petitioned constitute "failure to act." Senator Bond seconded the motion.

Discussion noted concern that there appeared to be little progress dealing with apportionment and should either the House or the Senate fail to act and a bill is not presented to the governor by April 1, it would be considered failure to act. The suggestion was made to use a method used in arbitration where each side would present a map rather than have the court start from the very beginning. The courts could choose one of the submitted maps or one they felt best. It was noted the issue could end up in both state and federal court since there were specific requirements in the Kansas Constitution.

Senator Yost moved to amend the motion to read "If the Legislaure does not have a bill to the governor by April 1 on the issue of Senate, House and Congressional apportionment, it would constitute "failure to act. Senator Bond seconded the amendment. The motion carried.

The meeting adjourned at 2:05 p.m. and will convene at 1:30 p.m. on Februry 11, 1992.

TESTIMONY SB 569
