Vice Chairperson Moran brought the Committee to order by presenting reports from the Subcommittee on Criminal Procedure. (<u>ATTACHMENT 1</u>)

<u>SB 651</u> - notification to victims of application for pardon or commutation of sentence.

Senator Gaines moved to adopt the Subcommittee report to amend SB 651 as suggested by the Attorney General, make effective on publication in the Kansas Register, and to clarify "attempt of notification," and that the bill be recommended favorable for passage as amended. Senator Petty seconded the motion. The motion carried.

SB 668 - qualifications for holding office of attorney general

Senator Gaines moved to adopt the Subcommittee report to amend SB 668 to clarify the requirement of five-years legal practitioner experience does not have to be immediately prior to submittal of application, and that SB 668 be recommended favorable for passage as amended. Senator Bond seconded the motion. The motion carried.

SB 670 - providing for independent counsel

Senate Moran requested the Committee refrain from acting on <u>SB 670</u> until the return of Senator Winter as he was the primary sponsor of the bill. The Committee agreed.

<u>SB 688</u> - juvenile offenders not to include those charged or convicted as an adult in any other state or federal jurisdiction.

Senator Gaines moved to adopt the Subcommittee report to recommend SB 688 favorable for passage. Senator Kerr seconded the motion. Discussion followed whether it was appropriate to delegate Kansas discretion to an out-of-state authority who could have vastly differing criteria.

James Clark, Kansas County and District Attorneys Association, responded to questions from the Committee by stating that it is an action of full faith and credit. He concluded by stating that it is unfair to allow out-of-state residents to fall back into the juvenile system after being treated as an adult felon elsewhere when we do not allow Kansas residents that opportunity; it creates an unfair system of justice for Kansans.

<u>Senator Bond made a substitute motion to conceptually amend SB 688 to give Kansas courts the discretion for determination. Senator Rock seconded the motion.</u> After further debate on the issue, <u>Senator Bond withdrew his substitute motion and Senator Rock withdrew his second.</u>

Senator Parrish made a substitute motion to amend SB 688 by deleting Section 1(b)(5) "in Kansas or in any other state or federal jurisdiction." Senator Oleen seconded the substitute motion. The substitute motion to amend carried.

<u>Senator Oleen moved to recommend SB 688 favorable for passage as amended. Senator Morris seconded the motion. The motion carried.</u>

<u>SB 735</u> - retention of jurisdiction by court in murder cases when person is convicted of lesser, included offense.

Senator Gaines moved to adopt the Subcommittee report to recommend SB 735 favorable for passage. Senator Bond seconded the motion. The motion carried.
