It was suggested, on page 2, lines 11 and 12, the employers policy should be related to a specific safety standard.

Should the Committee wish to change repetitive use conditions from a scheduled injury to an occupational disease, page 23, lines 23 through 28, would need to be amended.

Representative O'Neal informed Committee members the provision in Section 17 pertaining to the approval of medical fees and Section 13 pertaining to vocational rehabilitation need to be worked out with the cooperation of the Director of Workers Compensation.

The Committee meeting was adjourned at 2:30 p.m.
