Chairperson Jennison directed the Committee to turn to **SB 281**.

**SB 281 - State officers and employees; claims for certain expenses.**

A motion was made by Representative Haulmark, seconded by Representative Wilk, to amend SB 281 relating to the way separation pay is calculated for law enforcement officers as shown on the attached balloon (Attachment 1). The motion carried.

A motion was made by Representative Wilk, seconded by Representative Dean, to pass as amended SB 281. The motion carried.

The Chair directed the Committee to turn to **SB 384**.

**SB 384 - Assessments to cover anticipated expense of maintaining health care data base.**

A motion was made by Representative Neufeld, seconded by Representative Farmer, to technically amend SB 384 on page 1 in line 42 to delete the word "secretary" and insert "commissioner of insurance" and on page 2, line 5 to strike the word "anticipated." The motion carried.

A motion was made by Representative Neufeld, seconded by Representative Minor, to pass as amended SB 384. The motion carried.

The Chair directed the Committee to turn to **SB 361**.

**SB 361 - Contracts between secretary of SRS and secretary of human services under KanWork program.**

A motion was made by Representative Neufeld, seconded by Representative Reinhardt, to recommend SB 361 for interim study. The motion carried.

PROPOSED AMENDMENT TO SENATE BILL NO. 281  
(AS AMENDED BY SENATE COMMITTEE)

Be amended:

On page 5, following line 35, by inserting the following material to read as follows:

"New Sec. 7. (a) Notwithstanding the provisions of K.S.A. 75-5515 and amendments thereto or any other statute relating to the computation of hourly compensation, each person who is serving as a state officer or employee on December 16, 1995, in a 207(k) position and who separates from such service as a state officer or employee in a 207(k) position on or after December 17, 1995, shall have such person's separation pay calculated on the basis of an hourly rate of compensation based on the equivalent of a forty-hour workweek.

(b) As used in this section, (1) "207(k) position" means a position of an employee performing law enforcement activities for which a work period has been established which complies with the provisions of section 207(k) of the federal fair labor standards act, 29 U.S.C.A. 207(k), as amended, and the federal regulations, policies and standards adopted or promulgated thereunder as of July 1, 1995, and (2) "separation pay" means the compensation for accumulated compensatory time, holiday credit, sick leave and annual leave as provided by statute and rules and regulations.";

And by renumbering the remaining sections accordingly;

On page 1, in line 10, following "to" by inserting "compensation and allowances;"; in line 11, preceding "amending" by inserting "method of computing separation pay in certain cases;";
