Chairman Don Myers asked if there were any bill introductions. He requested a motion for a bill regarding unbundling which was discussed last week. The Chairman recognized Representative Stone who made a motion to introduce a bill to unbundle electric bills. Representative Johnson seconded the motion. Motion carried.

The Chairman mentioned to the Committee that the Sub-committee on Retail Wheeling will meet three days next week beginning with Tuesday, January 27 in the West Lounge from 12:00 noon until 1:00 p.m.

The Chairman opened the meeting back up to bill introductions. The Chairman recognized Representative McKinney who made a motion to introduce a House Concurrent Resolution that would urge the Congress not to take action on retail wheeling and let the states handle the issue. Representative Kuether seconded the motion. Motion carried.

The minutes from the meetings of January 13, January 14 and January 15, 1998 were distributed and they will be discussed for approval or corrections next week.

The Chairman mentioned that Walker Hendrix of the Citizens' Utility Ratepayer Board (CURB) will give an overview regarding the pending litigation concerning the telecommunications act.

The Chairman introduced Lynne Holt, Staff, of the Legislative Research Department, who continued the review and discussion on the Retail Wheeling Task Force bill draft and policy. Topics discussed were: Divestiture/Affiliate Transactions, Consumer Information and Protection, Default Suppliers, Tax Implications of Retail Competition and the Nexus Issue. Staff distributed a copy of the Service Areas of the Electric Cooperatives of Kansas (Attachment #1). Questions and discussion followed.

The Chairman thanked Mary Ann Torrence, Revisor of Statutes Office, and Lynne Holt, Legislative Research Department, for their good job in reviewing the Retail Wheeling Task Force draft bill and policy.

The meeting was adjourned at 10:00 a.m.



The Electric Cooperatives in Kansas

RECs — There are 31 rural electric distribution cooperatives in Kansas. Also known as RECs, they operate as non-profit utilities and are governed by their membership. The coops all hold annual membership meetings to conduct business and elect a Board of Trustees which meets monthly to direct the activities of their utility. Most of these RECs have been faithfully serving the residents of rural Kansas for more than 50 years.

Statewide Association — The Kansas Electric Cooperatives, Inc., is a statewide association headquartered in Topeka that has provided a variety of activities and programs to these cooperatives since 1941. Its services include governmental relations, communications, and loss control and safety programs.

G&Ts — Kansas Electric Power Cooperative, Inc. (KEPCo) and Sunflower Electric Power Corporation are the two Generation and Transmission Co-ops (G&Ts) operating in Kansas. As the name implies, KEPCo and Sunflower generate and transmit electricity for their electric cooperative members. The G&Ts are also non-profit organizations.

Sunflower — supplies six distribution cooperatives serving 150,000 people in 34 western Kansas counties. Based in Hays, Sunflower owns 546 MW of generating capacity including the coal-fired Holcomb Station.

KEPCo — headquartered in Topeka, has 22 member cooperatives located in the eastern two-thirds of Kansas. KEPCo's generation resources consist of a six percent ownership share in the Wolf Creek Generating Station, hydropower allocations, and long-term contracts from area utilities.
