MINUTES OF THE SENATE ASSESSMENT AND TAXATION COMMITTEE.

The meeting was called to order by Chairperson Senator Audrey Langworthy at 11:10 a.m. on January 28, 1999, in Room 519-S of the Capitol.

The minutes of the January 26, 1999, meeting were approved.

Senator Praeger requested the introduction of a bill which would provide for a sales tax exemption for clinics for the medically underserved. It is estimated that those clinics currently pay sales taxes in the amount of approximately \$250,000 on the supplies they buy. Staff informed Senator Praeger that a bill with the same intent has already been introduced in the House.

Senator Praeger moved to introduce the bill for the purpose of determining if it is the same as the House bill, seconded by Senator Stephens. The motion carried.

Mark Beck, Director of the Division of Property Valuation, Department of Revenue, presented the annual reports compiling the valuations and in lieu of taxes to be collected on property exempted pursuant to K.S.A. 70-102a *Second* and section 13, article 11 of the Kansas Constitution as required by K.S.A. 79-1467b. The reports are separated by the subclasses of Economic Development (EDX) and Industrial Revenue Bonds (IRB). The first report of each subclass separates the market value of the real and personal property into rural and urban and indicates the total in lieu of collections. The last report combines the real and personal values for EDX and IRB properties to make the comparison of 1997 to 1998 valuation and the in lieu of tax collections. (Attachment 1)

SB 59—Sales taxation; concerning the religious organization purchase exemption.

Senator Les Donovan, author of the bill, explained that SB 59 would clarify that the sales tax exemption for personal property and services purchased by a religious organization would apply to items purchased by a contractor for the use of the exempt organization. Senator Donovan had confirmed with the Department of Revenue that the fiscal note on the 1998 sales tax exemption legislation included indirect as well as direct purchases. (Attachment 2)

Dr. Joe Hendrixson, Executive Director of Kansas Ecumenical Ministries, testified in support of SB 59. He noted that religious communities welcomed last year's passage of legislation exempting congregations and other nonprofit organizations from sales tax on purchases. However, the expectation that payments for exempt purchases be made directly by a congregation has proven to be an unreasonable burden on congregations that are building new facilities. Because the contractor must make the purchases of materials and supplies, the new building is not exempt from the sales tax. (Attachment 3)

Pastor Jim Darby, Old Mission United Methodist Church in Fairway, expressed his support of **SB 59** and his gratitude for tax exemption legislation passed in 1998. He informed the Committee that Old Mission is currently undergoing construction and renovation, thus, the tax exemption legislation is impacting them.

Pastor Darby introduced a member of his congregation, Bill Lynn, who is a former contractor and the current chairman of the church building committee. Mr. Lynn noted that situation in which Old Mission finds itself in the process of new church construction is a specific example of the effect of last year's legislation. The cost of the total project will be approximately \$3.5 million. The possible savings by virtue of being a tax exempt organization would be around \$75,000, a significant sum for a church in a building program. Unfortunately, in order to take advantage of the sales tax exemption and to realize \$75,000 in savings, the church must, in compliance with current law, write direct contracts to various contractors and make direct purchases of material and supplies incorporated into the construction. The church currently has identified six direct contracts which must be written by the church and at least twenty direct purchase orders for various pieces of equipment and materials that will be incorporated into the building program. The estimated cost to administer the purchase orders is about \$120 per purchase order or per contract. This means that Old Mission will expend around \$3,000 in administrative costs to take advantage of the sales tax exemption, a cumbersome way to deal with the exemption. Mr. Lynn further noted that, because the church will write direct contracts, it will be forced to deal with a number of contractors rather than dealing with one general contractor with responsibility for the entire project. In addition, Old Mission must establish accounts with twenty different suppliers of materials and pay them directly rather than paying one general contractor who already has accounts at the various material and equipment suppliers. Mr. Lynn urged the Committee to support **SB 59** which would allow tax exempt organizations to take advantage of the tax exemption for the entire project through a general contractor.

Mary Kay Culp, Kansas Catholic Conference, stood in support of **SB 59** and of the testimony given in support of the bill.

Shirley Sicilian, Department of Revenue, explained that when the original fiscal note was prepared in 1998, it was explained in the note that the data came from a 1970 report and that it included both direct and indirect costs. After the bill passed, the Department determined that indirect exemptions could not be read into the bill. The Department has received at least 100 calls from churches, and it has informed them that these purchases are exempt if they make the purchases directly. A lot of churches are making direct purchases even though it is a hassle to do so. Given the volume of calls and the time spent with these taxpayers to explain how to achieve the exemption, the Department believes the fiscal note would be minimal. With this, the hearing on **SB 59** was closed.

Senator Donovan moved that **SB 59** be amended to make it effective upon publication in *The Kansas Register* and that it be reported as favorable for passage as amended, seconded by Senator Goodwin. The motion carried.

The meeting was adjourned at 11:45 a.m.

The next meeting is scheduled for February 1, 1999.

Testimony on Senate Bill 59

Before the Assessment and Taxation Committee, Kansas Senate

Mr. Chairman, I am Rev. Dr. Joe Hendrixson, Executive Director of Kansas Ecumenical Ministries. Thank you for allowing me to speak in favor of Senate Bill 59. Kansas Ecumenical Ministries, known colloquially as the state council of churches, is made up of nine member denominations with congregations in our state, including the American Baptist Churches, the Christian Church (Disciples of Christ), the Church of the Brethren, the Episcopal Church, the Evangelical Lutheran Church in America, the General Conference Mennonites, the Presbyterian Church USA, the United Church of Christ and the United Methodist Church. I speak to you today as a representative of these church communions, which make up over 1,700 local congregations and 400,000 individual members in Kansas.

The positive impact of 1998 legislation

Senators, the religious communities of our state welcomed last year's passage of legislation (K.S.A. 1998 Supp. 79-3606) exempting congregations and other nonprofit organizations from sales tax on purchases that further our exempt purpose. We are grateful to this committee and the members of the Legislature who supported that law, which went into effect on July 1, 1998. That exemption has allowed untold dollars to be redirected to programs providing direct assistance and support to the citizens of our state. We understood from the beginning that further clarification would be necessary, and we support the bill you have before you as one step in that clarification process.

The need for clarification

We recognized early on that one weakness in last year's legislation is the expectation that payments for exempt purchases be made directly by the congregation. In and of itself that expectation seems a reasonable protection for the integrity of the purpose of the exemption. However, we have learned through the year that it places an unreasonable burden on congregations that are building new facilities. Because the building contractor must make the purchases of materials and supplies, the new building is not exempt from the sales tax. A modest, \$150,000 building to meet the needs of a 200-member congregation must pay over \$9,000 in sales taxes.

Why should religious organizations be exempt?

As you know, Senators, sales tax exemptions for nonprofit organizations are based on the philosophy that such institutions return to the communities and citizens of our state services which exceed in value the lost tax revenue. Religious organizations in Kansas support food and clothing banks, homeless shelters, safe places for the victims of domestic abuse, nursing homes, youth programs, and counseling, not to mention support and education for values that make our state a good place to live and raise our children.

Why Senate Bill 59 makes sense

Constructing a building may not seem at first glance to be of value to anyone but those who worship in it. However, the truth of the matter is that these programs cannot be effectively initiated or adequately maintained without a place to serve as a center of operations for them. The building serves a congregation as a rallying place, an inspirational point, an educational facility, and a center of mission from which to serve the people of our communities. I believe that Senate Bill 59 continues and expands the good purposes of sales tax exemptions for nonprofit organizations like ours, allowing more dollars to go to direct services and care for the citizens of Kansas.

We urge your support

On behalf of the member churches of Kansas Ecumenical Ministries, I extend our gratitude for your foresight in putting forth Senate Bill 59, and urge you to press for its passage in this 1999 session of the Kansas Legislature.
