#### MINUTES OF THE KANSAS 2000 SELECT COMMITTEE.

The meeting was called to order by Chairperson Kenny Wilk at 1:30 p.m. on April 8, 1999 in Room 526-S of the Capitol.

Chairperson Wilk opened the meeting to discussion of the minutes of March 18, 22, 23 and 30 which were distributed to the Representatives' offices on April 2.

Representative Osborne moved to approve the minutes. The motion was seconded by Representative Gatewood. The motion carried.

Chairperson Wilk explained that, since this is probably the last meeting, minutes of today's meeting will be sent to each Representative's office. He requested notification of any changes. If there are no changes, he will approve the minutes on behalf of the Committee.

Chairperson Wilk opened the hearing on **HB 2570 - Creating a task force on consolidation of public** safety agencies.

The Fiscal Note was distributed for **HB 2570** (Attachment 1).

Chairperson Wilk recognized Representative Shari Weber, proponent and sponsor, who explained that while the bill is quite simple, it asks for a task force to study a controversial issue: the feasibility and efficiency that might be achieved by consolidating public safety agencies. Representative Weber provided information on court services, community corrections, and parole office locations as an example of agencies that serve the same clientele but are not located in the same place indicating it might be good to consolidate some of their public safety functions (<u>Attachment 2</u>).

Representative Tim Carmody, proponent, was recognized by Chairperson Wilk and gave background information related to the bill. He emphasized that there is no guaranteed outcome from the task force but that the time is right to look at the idea of a task force as a vehicle to address ways to better provide public safety to citizens.

Chairperson Wilk recognized Paul Wilson, Executive Director, Kansas Association of Public Employees (KAPE), neutral, who provided information related to the creation of the task force (<u>Attachment 3</u>).

Representative Lynn Jenkins, opponent, was recognized by Chairperson Wilk and provided information on previously proposed legislation and documentation from several state agencies opposing consolidation (<u>Attachment 4</u>). Also provided was a list of agencies to be involved in the effort (<u>Attachment 5</u>). She expressed her concern about the message this Committee would be sending to organize another megaagency while there are similar efforts to break up a current State mega-agency because of inefficiency and poor response to the public's needs.

Chairperson Wilk closed the hearing on HB 2570.

Chairperson Wilk asked the Committee to keep their attention on **HB 2570**.

Representative Carmody moved to pass the bill favorably. The motion was seconded by Representative Gregory. The motion carried. Representative Jenkins was recorded as voting "no" on the motion.

Chairperson Wilk adjourned the meeting at 2:25 p.m.

SUBJECT: Fiscal Note for HB 2570 by House Committee on Appropriations

In accordance with KSA 75-3715a, the following fiscal note concerning HB 2570 is respectfully submitted to your committee.

HB 2570 would establish a task force of nine members to study the consolidation of public safety agencies into a cabinet level department. The task force would be entitled to compensation, travel expenses, and subsistence expenses and could meet at any time and place within the state at the call of the chairperson. The bill would require the task force to look at the feasibility of combining the Kansas Highway Patrol, the Office of the State Fire Marshal, the Ombudsman for Corrections, the Juvenile Justice Authority, the Parole Board, the Kansas Bureau of Investigation, the Board of Emergency Medical Services, the Division of Emergency Management of the Office of the Adjutant General, the Department of Corrections, the Kansas Sentencing Commission, and the Alcohol Beverage Control Program of the Department of Revenue. The task force would report its findings to the Joint Committee on Corrections and Juvenile Justice and to the Governor on or before November 1, 2000.

Good afternoon Chairman Wilk and members of the committee. My name is Paul Wilson and I am the Executive Assistant to the President of KAPE. I'm here today to talk to you about House Bill 2570.

KAPE is neutral on this bill to create a task force. If and when the task force is formed, KAPE will have a position to provide to them. For now, KAPE wishes to provide information to the committee in their consideration only of the creation of the task force.

Subsection (e) of the bill contains a non-exhaustive list of "public safety functions" which would come under review for consolidation by the task force. And while the bill acknowledges that the list is not all inclusive, there are many other public safety positions in state government which may or may not be intended for coverage. This lack of specificity may result in problems for the task force in determining if the exclusion of some groups was intentional or an oversight. This is especially true when considering significant unique groups such as the sworn university police stationed at all regent's institutions, and all the sworn law enforcement officers of the Department of Wildlife and Parks. There are other smaller unique groups that might also be included such as the Resource Protection Officers stationed at Forbes Field here in Topeka, the Capitol Area Police, and the agents of the lottery, securities, racing and gaming commissions.

In addition, many groups of "public safety" positions mentioned in the bill and above are represented by various unions in separate bargaining units, and are covered by different employment contracts covering their conditions of employment. This fact will almost certainly lead to difficulties in the consolidation effort to be considered by the task force. Some of that difficulty may be reduced if representatives of each of the various unions that represent these employees are included on the task force.

In summary, KAPE is not opposed to the formation of a task force to consider consolidation of public safety agencies. If such a task force is created, it should have a clear understanding of the agencies it is, and is not, being asked to review for possible consolidation. And finally, if such a task force is created, it should include representatives of the organizations that have been legally certified under K. S. A. 75-4321 et. seq. to speak for the employees affected.

Thank you for your consideration of my comments and I will try to answer any questions you may have.

(e) It shall be the duty of the task force to review the feasibility and efficiencies that would be achieved by consolidating all public safety func-tions of agencies including, but not limited to, the highway patrol, the office of state fire marshall, the ombudsman of corrections, the juvenile justice authority, the parole board, the Kansas bureau of investigation, the board of emergency medical services, the division of emergency man-agement of the office of adjutant general, the department of corrections, the Kansas sentencing commission, and the alcohol beverage control pro-gram of the department of revenue into a cabinet level department. 

- (f) If the task force recommends consolidation of some or all of the state agencies, or functions of state agencies specified in subsection (e), is feasible and would create efficiencies, the task force shall present recommendations on the proposed organization and budgetary ramifications of consolidating such agencies or functions of agencies into a cabinet level department.
- (g) The staff of the office of revisor of statutes, the legislative research department and the division of legislative administrative services shall provide such assistance as may be requested by the task force.
- (h) The task force shall submit a final report of its findings and recommendations to the legislative budget committee, the joint committee on corrections and juvenile justice and to the governor on or before November 1, 2000.
- Sec. 2. This act shall take effect and be in force from and after its publication in the Kansas register.

### Previous Proposed Legislation

During the 1984 Legislative Session, a bill was introduced which would have created a Department of Public Safety and Law Enforcement. 1984 H.B. 2721 was introduced by Representative Jayne Aylward; the bill was referred to the House Governmental Organization Committee. It was not reported out of that Committee.

The Department would have been supervised by the Secretary of Public Safety and Law Enforcement, who would have been appointed by the Governor, subject to Senate confirmation. The following state agencies would have been consolidated into the new department: the Division of Alcoholic Beverage Control; the Alcoholic Beverage Control Board of Review (no longer in existence); the KBI; the Law Enforcement Training Center (part of the University of Kansas); the Kansas Highway Patrol; and the State Fire Marshal. The bill would have transferred employees of the abolished agencies to the new department, along with all records and property. The bill provided that the new department would be housed in Saline County and such other locations as needed.

Similar bills were introduced in 1985, 1992, and 1995. 1985 H.B. 2231 (Representative Aylward) was identical to her 1984 bill. 1992 H.B. 3138 (House Governmental Organization Committee) and 1995 H.B. 2587 (Representative McKechnie) were essentially similar to Representative Aylward's bills, except that these two bills would have also made the Adjutant General's Department a part of the new Department of Public Safety. None of these bills received favorable legislative consideration.

#### Options for Committee Activity

In its study of this topic, the Committee may want to:

- receive testimony from officials from the various agencies involved in public safety;
- review any Legislative Post Audit Performance Audit Reports concerning law enforcement and public safety agencies; and
- review the Legislative Post Audit report on the Highway Patrol's staffing, salaries, and scheduling when it is released in September.

In the sub-committee report for my agency, item 4 required me to meet with the Kansas Bureau of Investigation, Kansas Highway Patrol and the Kansas Board of Emergency Medical Services regarding the feasibility of consolidating our agencies into one agency. I have completed the task and offer the following information.

After meeting with the appointing authority from each of the other agencies it is my opinion that consolidation would not be in the best interest of the people of the State of Kansas. In each meeting we agreed that the only good reasons to consolidate would be to improve services and cut costs. I was unable to see that any appreciable savings would result from consolidation, and in fact some costs may even increase. I was also unable to see that services to the public would be improved.

Currently the state office facilities cannot support housing all of the various units of the larger agencies in one location, take for example KDH&E who has offices in the LSOB, the Mills Bldg, and Forbes Field. Discussions we had on space requirements revealed that the KBI was already looking for additional space, while the Highway Patrol, Board of EMS and our agency were in situations that already economically provided for their needs. We assumed that part of the reason for considering consolidation would be convenience to our customers, a one-stop shop for public safety. However, finding a central location did not seem likely not to mention the expenses of moving each agency and the potential for rent increases as well as the fact that we did not identify any reasons why the average Kansan would have business with more than one of these agencies at a time, especially given the diversity in the services each of us provides. At this time none of our four agencies has adequate space to accommodate the other three agencies.

We also discussed whether consolidation would result in staff reductions, although we may be able to streamline some functions like accounting and personnel, the increased size and complexity of a single agency would probably not allow more than the savings of maybe one position. However, given the needs of each agency, more not less staff are needed. We agreed that workloads already required overtime or temporary staffing.

In my agency, as in others, staff generally wear more than one hat, my secretary also acts as our office manager, personnel officer, EEO, ADA coordinator, and more. I only have three additional clerical staff now to handle our workload, which results in most management and field staff handling many of their own support functions. Recently I had occasion to require transcription of a sensitive nature, my agency contacted the KBI to see about sharing support services, unfortunately, they were already on overtime status. Although they were not able to assist us at that time it was nice to know that we have the kind of working relationships that allow for such open communications.

There are simply many differences in our agencies, a look at our individual missions shows that the KBI provides professional investigative and laboratory services to criminal justice agencies with a great deal of emphasis on drug cases, the KHP enforces traffic and other laws of the state, the Board of EMS works to assure appropriate out-of-hospital care and transportation for sick and injured people regulating ambulance services and emergency care providers and the Fire Marshal works to insure fire and life safety in all places where people live, work and congregate through inspection, plan review and code interpretations as well as specialized criminal investigation of arson fires.

At a time when our emphasis is on smaller government and improved customer service I do not believe creating another large bureaucracy for the public to deal with would be in the state's best interest. I believe the key is for agencies to continue to work together, striving to provide the best service possible. Although this exercise was time consuming it did reaffirm to me just how strong our working relationships with other agencies are and when our work does have the occasion to cross boundaries how well we work together to coordinate activities that compliment each others efforts in meeting the needs of our state. I do not believe that given the exceptional working relationship I currently share with the appointing authorities of these other agencies that consolidation could enhance or improve our services.

Finally, I would point out that my agency and the KHP are under the jurisdiction of the Governor, while the KBI is under the attorney general and the Board of EMS answers to an appointed board, these issues in themselves would require a great deal of work at a time when I feel we have more pressing issues. As indicated in the House Budget Sub-Committee report, the State Fire Marshal's office and the KBI were to meet to discuss the feasibility of agency consolidation. We have met, along with various representatives of our respective staffs, for an in-depth discussion of this possibility. For many reasons, we have determined this is not in the best interests of the state of Kansas, in our opinion.

The Fire Marshal's office serves as a resource to cities and counties for services those jurisdictions are unable to provide themselves, for building/fire code inspections and regulation. They also conduct or assist in arson investigations. Nonetheless, their main focus of service is on inspection and prevention, not criminal investigations. As such, their primary focus of resources is toward fire prevention and inspection, again, not criminal investigations.

The KBI is also a resource to cities and counties for services those jurisdictions are unable to provide. However, these do not include regulatory functions, inspections or investigations concerning fires and/or arson. The KBI provides professional investigative and laboratory services to criminal justice agencies, including laboratory service to the Fire Marshal's office.

Even if we were able to absorb the criminal investigative function of their agency, there would not be a savings in terms of investigative personnel. Neither the KBI agents nor the fire investigators overlap in terms of training, duties or caseloads.

In general, the Fire Marshal's office and the KBI do not recruit from the same pools of applicants. For their inspection and regulatory functions, the Fire Marshal recruits from fire protection services and architects, as well as the construction trades. While they generally do recruit law enforcement personnel for the investigator jobs, they view this as a fairly small, albeit important, aspect of their agency. Frequently, when the KBI fills agent vacancies, the agency seeks agents to work narcotics investigations, which may or may not be the same type of applicant the Fire Marshal is considering. Otherwise, the KBI recruiting focus is towards scientists and clerical personnel, again, not duplicating the Fire Marshal's needs.

We also do not believe that there would be a savings in administrative costs if the agencies were combined. Both agencies are support-poor in terms of personnel. The Fire Marshal's office has only four (4) support functions, each of whom has a backlog. In fact, recently, the Fire Marshal's office was looking for rush clerical assistance; however, since KBI staff was currently working overtime, the KBI was unable to provide that assistance. Combining agencies would not have changed that scenario.

We also do not believe combining agencies would result in any positive difference for facilities management. As you are probably aware, the KBI is in desperate need of space. The KBI currently does not have adequate room in Topeka for our current employees and operations, much less for 18 additional employees. In addition, the Fire Marshal's field investigators, like many KBI special agents, often work out of their home, which would not result in a cost savings to the State.

In short, the objectives, responsibilities, duties and requirements of our two agencies do not lend themselves, logically, to consolidation. In a final analysis, we respectfully suggest that an agency consolidation between our two agencies would result in any savings to the state, either in dollars or in operational efficiencies. The Kansas Highway Patrol was requested by the Appropriations Public Safety Subcommittee to meet with members of the Kansas State Fire Marshal's Office to discuss the possible consolidation of some or all of the two programs. This meeting was held on November 21, 1997 with chief staff members present from both agencies.

A careful review of both agencies missions and goals, discussion of current staffing and programs and possible consolidation were the main issues addressed.

It was realized by both agencies that the potential savings in this type of consolidation would come from being able to co-locate into similar office space and the sharing of certain clerical support staff. On behalf of the Highway Patrol, our downsizing and restructuring has resulted in very cramped office space for our Topeka operations and our clerical staff is being held to a bare minimum. There is no reasonable expectation of them being able to take on more workloads.

It was determined by members of both agencies that the disadvantages of consolidating the Kansas Highway Patrol and the Kansas State Fire Marshal's Office outweigh the advantages. If further information is required, please let me know.

During the 1997 session, the Public Safety Sub-committee of the House Appropriations Committee requested that four public safety agencies meet and discuss possible consolidation. These agencies were the Board of EMS, the Kansas Highway Patrol, the Kansas Bureau of Investigation and the State Fire Marshal. The agency directors were asked to meet individually with each other to begin with, and expand the meetings if consolidation seemed desirable.

I met individually with Col. Lonnie McCollum of the Kansas Highway Patrol and with Gale Haag, the State Fire Marshal. Larry Welch, Director of the KBI, did not respond to my request for a meeting.

During each meeting, the agency heads reviewed the missions of the two agencies, discussed current staffing and programs, and carefully evaluated the extent to which consolidation of their respective agencies would improve programming and/or reduce costs or positions.

It became clear during the meetings that the mission of the Board of EMS is incompatible with the missions of the Kansas Highway Patrol and the Fire Marshal. There is no duplication, or even similarity, among programs. The board's primary emphasis is public health, specifically the regulation and improvement of the state's emergency medical services/trauma system. The missions of the Kansas Highway Patrol and the Fire Marshal do not address public health issues or pre-hospital emergency medical services.

If the Board of EMS were consolidated with the Fire Marshal or the Kansas Highway Patrol in spite of these differences and could be co-located, it might be possible to reduce one clerical position in the reception/clerical support area. In addition, the costs of the 13-member board could be saved, assuming the legislature did not want the consolidated agency to have an advisory emergency medical services panel.

In summary, the Board of Emergency Medical Services believes the disadvantages of consolidation with the Kansas Highway Patrol or the Fire Marshal are far greater than any advantages. Please contact me if you have any questions.
