Sub for Sub SB 54 - Tenant access to television service

Chairman Holmes opened the debate on **Sub for Sub SB 54**. Rep. Myers provided a proposed House substitute to the bill. The substitute would make a change to the residential landlord and tenant act by adding a provision for a written agreement between the owner and the communication/cable service. Rep. Myers moved to adopt the substitute bill. Rep. Dahl seconded the motion

Rep. Sloan provided a proposed House substitute for **Sub for Sub SB 54**. Rep. Sloan's substitute would define the procedure to resolve conflict between cable providers and multi-tenant dwellings after a tenant requests cable service.

Rep. Loyd presented a proposed amendment to the bill that addresses recourse for the tenant if certain services are not provided.

Upon closing of debate on Rep. Myers motion to adopt, motion failed.

Rep. Sloan moved to adopt his substitute bill. Rep. Klein seconded the motion. Motion carried.

Rep. Myers moved to table **Sub to Sub SB 54** and consider it for an interim study. Rep. Toelkes seconded the motion. Motion carried.

The meeting was adjourned at 10:44 a.m.
