<u>Discussion and action on HB 2572 - Unlawful entry by agricultural inspector, criminal and civil sanctions.</u>

Representative Schwartz moved to adopt a simplified version of **HB 2572**. (Attachment 1) Seconded by Representative Hutchins, the motion carried.

Gordon Self explained that the modified version of <u>HB 2572</u> would make it unlawful for any person to enter the premises of a confined animal feeding facility without maintaining compliance with bio-security protocol and standards submitted by the owner of such facility and filed by such owner with the Kansas Department of Health and Environment. A violation would be a misdemeanor punishable by a fine of at least \$100 but not exceeding \$500. The modified version removes the civil penalty provision.

The committee expressed numerous concerns. <u>Representative Schwartz moved to table **HB 2572** and request an interim study. Seconded by Representative Feuerborn, the motion carried.</u>

HOUSE BILL NO.

AN ACT concerning crimes, criminal procedure and punishment; creating the crime of unlawful entry of a confined feeding facility.

## Be it enacted by the Legislature of the State of Kansas:

Section 1. (a) Unlawful entry of a confined feeding facility is the entry of any person upon the premises of a confined feeding facility without maintaining compliance with bio-security protocol and standards submitted by the owner of such facility and filed by such owner with the Kansas department of health and environment.

- (b) As used in this section: (1) "Confined feeding facility" means the same as provided in K.S.A. 65-171d, and amendments thereto; and
- (2) "person" means the same as provided in K.S.A. 21-3110, and amendments thereto, and includes an employee of the United States environmental protection agency, the Kansas department of health and environment and the Kansas animal health department.
- (c) Unlawful entry of a confined feeding facility is a misdemeanor punishable by a fine of at least \$100 but not exceeding \$500.
- (d) The provisions of this section are part of and supplemental to the Kansas criminal code.
- Sec. 2. This act shall take effect and be in force from and after its publication in the statute book.
