The Committee took under consideration **HB 2396** - Property tax valuation increases limited, on which hearing was held on March 19, 2001.

Representative T. Powell moved to recommend **HB 2396** favorable for passage. Representative Palmer seconded.

Representative Findley moved a substitute motion to table **HB 2396**. Representative Sharp seconded. Motion failed.

Representative Larkin moved to substitute an amendment to change the add-on rate of the Director of Property Valuation which would result in lower agricultural land valuation. Representative Gatewood seconded and motion carried.

Representative T. Powell moved to recommend **HB 2396** favorable for passage as amended. Representative Osborne seconded and motion carried.

The Committee took under consideration **HCR 5026** - A proposition to amend sec 1 art 11 of the constitution of the state of Kansas, on which hearing was held on March 19, 2001.

Representative Palmer moved to recommend **HCR 5026** favorable for passage. Representative Findley seconded.

Representative Larkin moved a substitute motion to amend **HCR 5026** to require the approval of at least 50% of counties in the state of Kansas before it could become effective. Representative Wilson seconded. After discussion motion was withdrawn by Representative Larkin.

Representative Gatewood moved to table **HCR 5026** until clarification as to its constitutionality. Representative Flora seconded. Motion failed.

Representative Larkin moved a substitute motion to amend **HCR 5026** to include a homestead exemption of \$30,000. Representative Flora seconded. Motion failed.

Motion to recommend **HCR 5026** favorable for passage was adopted. Recorded as voting yes Representatives Mays, Powell, Tafanelli, Osborne, L. Powell, Cook, Palmer and Hutchins. Representative Flora was recorded as voting No.

The Committee took under consideration **HCR 5018** - Constitutional amendment requiring super majority vote for certain tax rate increases, on which hearing was held on March 19, 2001.

Representative Wilson moved recommend **HCR 5018** favorable for passage.

Representative Flora moved a substitute motion to report **HCR 5018** unfavorably.

Representative T. Powell moved a substitute to report **HCR 5018** favorable for passage. Representative Osborne seconded.

Representative Larkin moved to table **HCR 5018**. Representative Findley seconded. Motion failed.

Motion to report **HCR 5018** favorable for passage was adopted. Representative Osborne recorded as voting Yes. Representative Flora recorded as voting no.
