Rep. Dillmore moved to approved the minutes of the February 5, 6, 7, 8, 9 and 12 meetings. Rep. Dreher seconded the motion. Motion carried.

Chairman Holmes announced he would entertain a motion to remove <u>HB 2266</u> from the table. <u>Rep. Sloan moved to lift HB 2266</u> from the table and continue the debate, Rep. Myers seconded the motion. <u>Motion carried.</u>

HB 2266 - Independent power producers, coal-fired generation; exemption from regulation; bonds for pollution control devices; property tax

Chairman Holmes addressed each section of the balloon adopted on February 21, 2001 by explaining the individual changes, additions and deletions. Reps. Morrison and Merrick distributed a balloon with suggested amendments to Sections 1, 2, 6, and 7. Rep. Merrick moved to adopt the amendments. Rep. McLeland seconded the motion. A request to divide the motion was granted. On the first item to strike Section 1(e)(2), motion failed. On the second item to add new Section 2(c), motion failed. On the third item to add the words 'including pollution control devices' to Section 6(a) between the words 'facilities' and 'described', motion failed. On the fourth item to add new Section 7(c), motion failed. Rep. Myers distributed proposed amendments and moved the adoption thereof. Rep. Krehbiel seconded the motion. A request to divide the motion was granted. On the first item to add new subsection (C) to Section 1(e)(2), motion carried. On the second item to add new subsection (D) to Section 1(e)(2), motion failed. Rep. Sloan moved to adopt a conceptual motion that would use the same language as Rep. Myers new subsection (D) from the previous motion, but add that once on the tax roles, the plant could not come off and they would report to the corporation commission and if they exceed the 20% it would then be reported to the Department of Revenue. Rep. O'Brien seconded the motion. Motion failed. Rep. Myers distributed a second proposed amendment to add new Section 6(b) and moved the adoption thereof. Rep. Krehbiel seconded the motion. Motion carried. Rep. McClure moved to adopt a conceptual motion that would have the Corporation Commission report, annually, to the Department of Revenue. Rep. Dillmore seconded the motion, motion carried. Rep. Sloan moved to recommend HB 2266, as amended, favorable for passage. Rep. Myers seconded the motion. Motion carried. Chairman Holmes will carry the bill.

SCR 1607 - In support of the development of a federal energy policy

Chairman Holmes opened the debate on <u>SCR 1607</u>. <u>Rep. Kuether moved to recommend SCR 1607 favorable for adoption</u>. <u>Rep. O'Brien seconded the motion</u>. <u>Motion carried</u>. Rep. Williams will carry the resolution.
