Overview of Kansas Health Institute

Upon calling the meeting to order, Chairperson Wagle introduced Dr. Robert St. Peter, M.D., President of Kansas Health Institute who gave an overview of the institute. A copy of the testimony is (Attachment #1) attached and incorporated into the Minutes by reference. Dr. St. Peter said that the institute is an independent, nonpartisan, nonprofit health policy and research organization. He went on to explain the institute's vision, mission, priorities, activities, and projects concluding with the institute's funding sources. A handout "Kansas Health Institute" was also made available which included a copy of their institute's activity portfolio and their quarterly newsletter. A copy of the hand out is on file in the office of the Chairperson Wagle. Questions and comments followed from Senators Haley and Brungardt.

Continuing with more information on the institute, Chairperson Wagle introduced Ms. Billie Hall, Vice President for Public Affairs for the Kansas Health Institute who gave an overview of the Kansas Health Institute Forums 2001. A copy of the overview is (Attachment #2) attached and incorporated into the Minutes by reference. Questions and comments followed from Senators Haley, Harrington, Barnett, Salmans, and the Legislative Researcher, Ms. Emalene Correll.

Introduction of bills

The next order of business was bill presentation. The Chairperson recognized Ms. Trudy Racine, Director, Office of Planning and Policy Coordination, Kansas Department of Social and Rehabilitation Services. Ms. Racine asked that the Committee introduce legislation that would require a screening and a "ticket letter" from a Qualified Mental Health Professional (QMHP) employed by a Community Mental Health Center (CMHC) prior to admission to a state psychiatric hospital. The second legislative proposal amends current legislation requiring a written statement from a QMHP based upon the results of a Pre-Admission Screening and Annual Resident Review (PASARR) is obtained authorizing admission of a patient to a nursing facility for mental health. A copy of her presentation is (Attachment #3) attached and incorporated into the Minutes by reference. The proposed legislation (amendments) were placed before the Committee. Senator Praeger made the motion to hear the proposed legislation. Senator Barnett seconded the motion and the motion carried.

Adjournment

With no further bills or business, the meeting was adjourned. The time was 2:18 p.m.



RE: Bill Introductions

Madame Chair and members of the Committee, my name is Trudy Racine. I am here today to request two bills be introduced into your committee.

The first bill would require a screening and a "ticket letter" from a Qualified Mental Health Professional (QMHP) employed by a Community Mental Health Center (CMHC) prior to admission to a state psychiatric hospital. While screenings for civil commitments are already required, this legislation would apply to misdemeanor offenders, juvenile offenders, and children in need of care (CINCs). This is the last "phase" of the original 1990 plan of mental health reform. The CMHCs should be ready to perform these screens in addition to the screens they currently do for civil commitment patients.

The second bill amends current legislation requiring a written statement from a QMHP based upon the results of a Pre-Admission Screening and Annual Resident Review (PASARR) be obtained authorizing admission of a patient to a nursing facility for mental health. This legislation is necessary to achieve the savings proposed in the Governor's budget.

The concept behind both bills is to keep persons who could be better served in the community from being placed in a state hospital or nursing facility.
