

## MINUTES OF THE E-GOVERNMENT COMMITTEE.

The meeting was called to order by Chairperson Deena Horst at 3:39 p.m. on March 14, 2002, in Room 526-S of the Capitol.

All members were present except Representatives Williams and Cook, who were excused.

The Chair opened the hearing for **SB 605**. Staff Jim Wilson said the bill alters the statutory reporting requirements of certain agencies, directing them to submit annual reports to the Legislature electronically on the Internet rather than by paper. Tom Day, Legislative Liaison, Kansas Corporation Commission (KCC), said the bill was requested by Senator Brownlee when she realized how much paper was consumed by these reports. Members discussed the merits of eliminating paper reports and the process of finding a report through an Internet address. Representative Holmes noted that, for certain reports, the KCC issues reports electronically on a compact disk as well as in print. With no opponents or proponents speaking to the bill, the Chair closed the hearing on **SB 605**.

The Chair referred the bill to the State and Local Government and to the Technology sub-committees for further consideration. She suggested that the bill might be expanded to include electronic reports from other agencies as well.

The minutes for the February 26, 2002, meeting were approved as printed. (Motion, Representative Morrison; second, Representative Levinson)

Keith Meyers, Deputy Secretary, Department of Administration, reported on the Kansas Grants Clearinghouse, a centralized Internet site to allow Kansans more ready access to available federal grants and federal revenues, thus maximizing funds coming to Kansas. (Attachment 1) Patterned after a similar Illinois initiative, which increased federal funding by 16% after implementing its web site, the Kansas site provides consolidated links to online information about grant availability, training, and tutorials.

Duncan Friend, Manager of Internet Services for the Division of Information Services and Communications, provided a live demonstration of the website, Kansasgrants.org. Following links for Foundation Resources, Training, Tutorials, State Grant Information, and Federal Grant Information, a person can access a catalogue of Federal Domestic Assistance that offers a cornucopia of funds. As an example, Mr. Friend showed a Department of Agriculture initiative for rural development that provides grant funds for pilot broadband deployment. Mr. Meyers noted that Kansas is 39<sup>th</sup> of 50 states for use of grants, saying that Kansans are not maximizing their opportunity for bringing federal money to the state. Answering questions, Mr. Meyers said that the grants clearinghouse allows agencies one-stop access to grants information. He said the links are regularly updated to provide current information.

Robert Knapp, General Manager, Information Network of Kansas (INK), outlined the services provided by INK. (Attachments 2 and 3) He traced the organizational structure integrating INK, a private/public quasi-state agency, with state government (Chief Information Technology Officers, Information Technology Executive Council, Information Technology Advisory Board, Agency Chief Information Officers, including 83 planning agencies under in the Strategic Information Management plan) and the private sector (the Kansas Information Consortium [KIC], which serves as Network Manager). He said INK, a self-funding agency, operates as the official gateway to Kansas state government. He noted that,

following the e-Government Committee's recommendation, INK has placed all board records online. He said the KIC contract expires December 31, 2002, noting that according to the contract, 2% of gross revenue is retained by INK; 19% of gross revenue goes to KIC as Network Manager; and 79% of gross revenue is returned to state agencies. He said 90% of INK services is available at no cost to the public.

Tracing INK's services, Mr. Knapp said that in 2001 Kansas was ranked #1 in digital services by the Digital State Survey, noting that in 2001 61 different services and web sites were developed; as an example, he cited the Secretary of State's UCC filings are now 80% performed through the Internet. He said after initiating State Board of Nursing online verification, back-office calls were reduced by 90%. About 60% of Kansas trucking permits are now issued online. An INK goal now being realized is the integration of agency services, such as the Kansas Business Center, uniting applications from the Secretary of State, Kansas Department of Revenue, and Kansas Department of Human Resources into one access point for new businesses in Kansas. Another goal being implemented is "branding," developing consistent patterns for web sites.

Answering questions, Mr. Knapp said that, working with DISC, INK has addressed security issues. He said no barriers exist for state agencies to develop online applications; he noted most agencies want to proceed with initiatives faster than INK can develop applications. As one example, he said that INK has saved the Kansas Department of Agriculture \$100,000 through an online application form.

The Chair announced sub-committee meetings will be held on Tuesday, March 19, and the next e-Government Committee meeting will be Thursday, March 21, at which time the Kansas Information Technology Office will brief the committee on the Strategic Information Management plan. The meeting was adjourned at 4:53 p.m.

**“Update on Maximizing Federal Grants and Revenues in Kansas”  
Provided to the House e-Government Committee  
by Keith Meyers, Deputy Secretary of Administration  
March 14, 2002**

Madam Chair and Members of the Committee,

Thank you for the opportunity to provide you this update on Department of Administration activities regarding the recommendations of the Legislative Budget Committee on maximizing federal grants and revenues in Kansas.

The Department of Administration has been asked to further study how Kansas’ state agencies, local governments, non-profit organizations and private businesses could increase their take of available federal grants and other federal revenues. Part of the charge given the Department is to convene a working group of these stakeholders to discuss various options available to us. After discussions with House Appropriations Chairman Wilk and Representative Nichols, Acting Secretary Glasscock, as a preliminary step to establishing a working group, sent a survey to state agencies to determine interest in participating in the working group, and to determine if agencies have hired consultants or consulting firms for the purpose of seeking out and applying for federal grants. For your review, the survey results are attached.

The Legislative Budget Committee reviewed activities of the State of Illinois and its federal clearinghouse as a means for communicating via the Internet the availability of federal money. The State of Illinois reported a 16 percent increase in federal funding after implementing its clearinghouse. As a result of our research on this topic, we identified several states – Illinois, Texas and Iowa – that have developed web sites which provide consolidated links to online information about grant availability, training and tutorials. Given that information former Division of Information Systems and Communications (DISC) Director Don Heiman, asked the DISC Manager of Internet Services, Duncan Friend, to develop a Grants Clearinghouse for Kansas that Mr. Friend will demonstrate for you today.

Before I turn the presentation over to Mr. Friend, I would like to point out that our approach incorporates a Texas practice that involves notifying users of an opportunity for grant writing training. The State of Kansas will make this training available through the Department of Administration, Division of Personnel Services. The key training objective would be to have participants finish the course with an outline of a grant application in hand.

Former Director Heiman envisioned that we could partner with the Information Network of Kansas (INK) to communicate updates via e-mail on federal grant/fund opportunities to interested state agencies, local units of government, non-profits, and business. When interested parties access this information, they will also learn about the grant writing training that would facilitate the grant application process. The Department of Administration believes that the Kansas Grants Clearinghouse presents an outstanding opportunity to enhance access to federal funds throughout the State of Kansas.

The website, **Kansasgrants.org**, went live on February 11, 2002. As of March 12, 2002, the website has received 4,146 visits from a wide variety of customers including cities, counties, universities, non-profits, and private entities. Sixty-seven of these visitors have expressed an interest in signing up for the training that we plan to have in place by early May.

Yesterday, Acting Secretary Glasscock sent a memorandum to all legislators providing information regarding the website as well as the promotional pamphlet that we have provided to you this afternoon. Given the seriousness of the fiscal circumstances we face today, it is our expectation that this creative use of the available technology will increase competitiveness for federal grants and funds here in Kansas.

# Kansas Grants Clearinghouse Web Site

The primary purpose of the Kansas Grants Clearinghouse Web Site is to assist and support state agencies and local units of government in obtaining grants from the federal government and other sources by providing a central location from which to access accurate and timely information about such programs. In addition, the site provides links to information from state agencies about grant programs they offer to citizens, businesses, local units of government, and other parties. A section of the site is also devoted to funding available from private foundations. The site is hosted and maintained by the Department of Administration and accessible from the State home page at <http://www.accesskansas.org>. The address of the site is <http://www.kansasgrants.org/>

The current site uses a set of links connecting users to Federal and State grant sites. Each page of the site provides a brief statement soliciting suggestions and an email address to which suggestions can be sent. Over time, it is expected that state agencies will contribute additional links to be added to the site that they have found helpful, as well as links to information on grant programs they offer. When grant writing training sessions become available, a link will be provided to the Department of Administration's Learning Services online enrollment form. As part of the training offering, attendees will also be introduced to the resources available on the site and encouraged to provide feedback that will improve its usefulness to them.

## **Proposed Training Session: *Grant Proposal Writing***

As part of the development of the Kansas Grants Clearinghouse Web Site, we investigated the possibility of offering training to help grant seekers expand their skills in locating funding opportunities and preparing grant proposals. The objective would be for participants to leave the workshop with a clear understanding of how to begin the grant writing process, where to look for resources, and how to prepare a highly competitive grant proposal in order to obtain grant funds from public or private sources at the federal, state, and local levels.

The Department of Administration's Division of Personnel Services contacted several states, Kansas Regents universities, and private entities and found training available through both public and private sources. The State of Texas conducts a comprehensive two-day class and has shared their curriculum and training materials with us. The State of Illinois reports that they have patterned their class along the same lines as the Texas offering. After reviewing these materials, a request for proposal was created through the Division of Purchases to solicit experienced trainers to conduct similar classes. The RFP closes on March 25, 2002.

It is expected that the Division of Personnel Services will be able to coordinate up to four training sessions per year beginning late spring 2002. These sessions could be conducted in multiple locations as demand is identified. The estimated cost of a two-day session is \$250 per participant. The training would also be open to municipal, local and county government, non-profit, and private organizations. Employees who are responsible for either writing or evaluating grant proposals would benefit from this training. A preliminary outline of subjects that would be covered in the training is provided below:

- A description of the general grant process with a special focus on how grants are reviewed
- Information about the location of funding sources and the use of electronic media to find them, including an introduction to the Kansas Grants Clearinghouse Web Site
- Instruction on how to review an application to determine if it is appropriate for your agency
- Training on the use of planning tools for the creation of effective grant proposals
- Information on suggested approaches for identifying partners and creating coalitions
- Information on the budgeting process and how to maximize grant funding for your project
- Instruction on how to create an appropriate evaluation plan for your project
- Training on the most effective methods for producing your grant proposal
- A draft proposal-outlining exercise followed by peer critique

#### Preliminary Outline (subject to change)

This course is designed to give participants the practical skills they will need to begin the development of grant proposals. Participants will leave the workshop with a clear understanding of how to begin the grant writing process, where to look for resources, and how to prepare a highly competitive grant proposal in order to obtain grant funds from public or private sources at the federal, state, and local levels. All class participants will receive a Program Development and Grant Writing Manual that includes all of the information presented at the workshop. This manual can also serve as a reference guide for participants as they begin to develop their own grant proposals. The key training objective is to have participants finish the course with a completed grant application in hand.

Proposed material includes:

- a description of the general grant process with a special focus on how grants are reviewed
- information about the location of funding sources and the use of electronic media to find them, including an introduction to the Kansas Grants Clearinghouse site
- instruction on how to review an application to determine if it is appropriate for your agency
- training on the use of planning tools for the creation of effective grant proposals
- information on suggested approaches for identifying partners and creating coalitions
- information on the budgeting process and how to maximize grant funding for your project
- instruction on how to create an appropriate evaluation plan for your project
- training on the most effective methods for producing your grant proposal
- a draft proposal-outlining exercise followed by peer critique

Participants receiving the maximum benefit from the proposal writing seminar typically: 1) have little or no grant writing experience, or 2) have written some grant proposals but have no formal training. We encourage those working in all issue areas to attend. If participants are not actively working on a proposal to fund a project at this time, it may be helpful for them to think of a project they would like to develop in the future and bring a rough outline for the project design to the seminar with them.

Ten years ago the many members of Kansas government had a vision. This vision was created out of the need of the government associations in Kansas to deliver and access documents in Topeka – rather than drive to and from the state capital. The desire became to open up access to the state mainframes, databases and systems to provide ease of access for businesses and citizens of the state of Kansas without impacting the tax appropriations of the state. This desire led to the introduction of Senate Bill 682 which was subsequently approved and enacted in Kansas statute 74-9301 through 74-9308, proposing the creation of the Information Network of Kansas (INK) to serve the purpose of:

- a. Providing electronic access to public information of agencies;
- b. developing a electronic network for this access;
- c. providing appropriate oversight of any network manager;
- d. exploring ways of providing more public information and increasing the use of that information;
- e. exploring technological ways and means of improving citizen and business access to public information; and
- f. exploring options for expanding the network and its services to citizens and businesses through revenue-based applications

As outlined in statute, INK was tasked with:

- a. Serving in an advisory capacity regarding the provision of state data to the citizens and businesses of Kansas;
- b. seeking advice from the general public, its subscribers, professional associations, academic groups and institutions; and
- c. developing charges for the services provided to subscribers, which include the actual costs of providing such services.
