SB 259 - Testimony by Chief Judge Gary W. Rulon

Representative Neufeld thanked the members of the Committee, particularly the members of the Conference Committee, for their hard work during the Conference Committee meetings of the past two days.

Representative Landwehr moved to introduce legislation for a conceptual bill concerning the hospital closure and Olmstead Advisory Committee. The motion was seconded by Representative Howell. Motion carried.

## Hearing on SB 259--Delay of phased in increases of court of appeals to 14 judges.

Carolyn Rampey, Legislative Research Department, explained that the bill delays, because of the financial burden, the action of previous legislation that would have added one new judge each of the next three years for a total of 14 judges within the Court of Appeals. The bill would delay the addition of one new judge in January, 2004, to January, 2005,. Ms. Rampey stated that HB 2418 is an identical bill and was amended by the House Judiciary Committee by directing that the budget of the Judicial Branch be submitted directly to the Legislature without recommendations from the Governor through the Division of the Budget.

The Chair recognized the Honorable Gary Rulon, Chief Judge, Kansas Court of Appeals, who testified in favor of SB 259 (Attachment 1). Mr. Rulon responded to questions, indicating that the Court of Appeals actually favors the House bill as amended rather than the Senate bill.

Because the Senate Ways and Means Committee has scheduled a hearing on HB 2418 for Thursday, April 3, it was the consensus of the Committee to delay action on SB 259 until after the Senate Hearing.

The Hearing on SB 259 was closed.

# HB 2429-Limitation on expenditures by the Department of Wildlife and Parks for certain river access projects.

Representative Schwartz informed the Committee that the Agriculture and Natural Resources Budget Committee had held a public hearing on HB 2429, which limits expenditures by the Department of Wildlife and Parks for certain river access projects. The Budget Committee amended the bill by adding a balloon of amendments which state that no expenditure shall be made by the Department of Wildlife and Parks from State General Fund or any special revenue funds for construction of any new river access project on the Arkansas, Kansas or Missouri Rivers unless the Secretary of Wildlife and Parks has obtained prior written permission from adjacent property owners of parcels within 100' of the project.

Representative Schwartz moved to accept the Budget Committee's report, to amend the bill and to report a substitute bill for HB 2429 incorporating the balloon of proposed amendments. The motion was seconded by Representative Osborne.

Representative Schwartz renewed her motion to accept the Budget Committee report for a substitute bill which would incorporate the balloon of amendments to **HB 2429.** The motion carried.

The Chair announced a Conference Committee on **SB 223** will meet upon second recess of the House today; room to be announced. Conferees are Representatives Neufeld, Shultz and Nichols. A Conference Committee on **SB 43** will meet at 1:00 p.m. today in Room 123-S. Conferees are Representatives Neufeld, Schwartz and Gatewood.

The next meeting of the Appropriations Committee is scheduled for 9:00 a.m., April 3, 2003. A hearing on **HB 2463** will be held.
