HB 2106 - Membership of Council on Travel and Tourism

Ron Hein, representing the Kansas Restaurant and Hospitality Association, addressed the committee as a proponent of the bill (Attachment 1). He introduced the head of the Kansas Restaurant and Hospitality Association, Dennis Carpenter. Mr. Hein stated that the proposed bill simply updates and corrects the names of organizations which make nominations for membership on the Tourism Council. He also noted that the changes that the bill makes are merely technical, not substantive, so the bill should be non-controversial.

Chairperson Hutchins noted that according to the fiscal note, this bill would have no fiscal impact.

There were no questions from the committee, and there were no other proponents or opponents of the bill. Chairperson Hutchins closed the hearing.

Chairperson Hutchins mentioned Wednesday's plans to work this bill. On Wednesday there will also be a hearing on:

HB 2083 - Establishment of fund to use to advertise tourism opportunities in Kansas, use of certain income and sales tax revenues.

Chairperson Hutchins reminded the committee that a field trip to the Czars exhibit is planned for Wednesday, February 19. A sign-up sheet will be distributed at this Wednesday's meeting. The committee members will carpool, meeting on the first floor of the Capitol, at the south entrance, at 3:00 p.m.

**Testimony Re: HB 2106
House Tourism and Parks Committee

Madame Chairman, Members of the Committee:

My name is Ron Hein, and I am legislative counsel for the Kansas Restaurant and Hospitality Association. The KRHA is the Kansas professional association for restaurant, hotel, lodging and hospitality businesses in Kansas.

HB 2106 is a simple bill that updates and corrects names of organizations which make nominations for membership on the Tourism Council, which is an advisory council to the Secretary of Commerce and Housing.

The Kansas Lodging Association no longer exists, as it has merged into the Kansas Restaurant and Hospitality Association. So the KRHA will, in this bill, make nominations for both the lodging industry and the restaurant industry.

The Kansas Oil Marketers Association is now named the Petroleum Marketers and Convenience Store Association of Kansas.

Those are the only changes in the bill, which we consider to be technical only, and not substantive.
