Senator Schmidt moved to introduce a bill relating to establishing an indemnity program for deer damage. Senator Taddiken seconded the motion, and the motion carried with no opposition.

Senator Schmidt moved to introduce a bill moving all food-related programs to the Department of Agriculture. Senator Downey seconded the motion, and the motion carried with no opposition.

Senator Umbarger moved to introduce a bill to create state incentives for bio-diesel and ethanol production. Senator Lee seconded the motion, and the motion carried with no opposition.

Senator Umbarger moved to introduce a concurrent resolution to include the promotion and support of ethanol in Federal legislation. Senator Tyson seconded the motion, and the motion carried with no opposition.

Senator Huelskamp made a motion to introduce a bill concerning the slaughter of buffalo captured during sport hunting. Senator Taddiken seconded the motion, and the motion carried with no opposition.

Senator Morris made a motion to introduce a resolution urging ethanol production in Kansas. Senator Downey seconded the motion, and the motion carried with no opposition.

Senator Umbarger made a motion to approve the Minutes of the January 22 Committee meeting. Senator Schmidt seconded the motion, and the motion carried with no opposition.
