Senator Barnett introduced a bill concerning technical colleges; relating to the powers and duties of the governing bodies. Motion to introduce by Senator Teichman, seconded by Senator Emler. Motion carried.

Dale Dennis, Deputy Commissioner, State Board of Education, introduced the Kansas Teacher of the Year, Keil Hileman and the members of the Kansas Teacher of the Year Team. Each member shared personal information about their schools, their education background, their area of teaching and shared areas of concern.

During discussion, the team expressed challenges they are dealing with and concerns with No Child Left Behind (NCLB). Some of the concerns discussed was the education required for para professionals under NCLB; that all students do not learn at the same pace which will affect test results and grading of the schools under (NCLB); the number of teachers reaching retirement age; the need for more parental and community involvement; the number of students per class and the limited time the teachers have to spend with their students who need extra help.

The group expressed the importance of retaining quality teachers; teacher mentoring; the Professional Development Program; being a positive roll model for students; and involvement of parents and communities.

Meeting was adjourned at 2:30 p.m. The next meeting is scheduled for January 21, 2004 at 1:30 p.m.
