

MINUTES OF THE HOUSE FEDERAL AND STATE AFFAIRS COMMITTEE

The meeting was called to order by Chairman John Edmonds at 1:30 P.M. on February 6, 2006 in Room 313-S of the Capitol.

Chairman Edmonds opened the floor for bill introductions and requested a bill relating to qualifications for lobbyist. It specifies that anyone who is a convicted sexual predator cannot serve as a registered lobbyist.

With no objections, this bill was accepted for introduction.

The Chairman related that at the meeting of February 2nd he had appointed a subcommittee to look into **SB 62**, and he extended the subcommittee to also include Representative Burroughs and Representative Johnson.

From previous meetings there were question raised regarding **HB 2541** - a bill stating no marriage license for persons 15 and under; persons 16 and 17 may have a license with parent or judicial consent. Athena Andaya, Legislative Research briefed the committee addressing those questions. For committee review, Ms. Andaya, submitted information from the Bureau of Vital Statistics answering questions from the committee regarding ages of brides and grooms. (Attachment 1)

Chairman Edmonds directed attention to **HB 2727** - concerning state officers and employees; relating to certain payroll deductions, and opened the floor for public hearing.

Representative Nile Dillmore was recognized as endorsing **HB 2727** and related that Community Health Charities (CHC) is statewide federation and has a strong record of providing a cost-efficient fund-raising opportunity for employers, employees, and its member charities. He strongly urged the committee to pass this bill favorably. (Attachment 2) Representative Dillmore also called attention to testimony from Judy Keller, Executive Director, American Lung Association of Kansas who also supports **HB 2727**. Ms. Keller's testimony stated that they endorse the bill because 1) it provides additional options for the state's 37,000 employees, 2) it would offer encouraging charitable giving options to many established, reputable, voluntary health organizations that cannot currently participate, 3) it would create a level playing field for health federations. Also endorsing the passage of **HB 2727** was Robert L. Mackey, Division of Accounts and Reports, Kansas Department of Administration. In their opinion the bill amends existing laws concerning charitable organizations to which state employees may elect to contribute through payroll deduction. The bill also amends the term "United Way Organization" to include "other charitable federations which are eligible to be deducted from federal employees payroll pursuant to federal law." Community Health Charities was represented by the President, Sandra Vader who spoke on their behalf supporting **HB 2727**. Ms. Vader opined that this is a cost effective way for charities to raise funds, it benefits community health charities and is a distinctive way to make a difference. She also included a chart showing, in terms of the economy, the 2006 program grants for the March of Dimes. (Attachment 5)

Mari Tucker, Coordinator for the Topeka Area ALS Support Group and the Event Chairperson for the annual Walk to D'Feet ALS in Topeka delivered testimony in favor of **HB 2727**. Ms. Tucker related that her husband was a victim of ALS (amyotrophic lateral sclerosis) and since his passing, she has been committed to increasing awareness of ALS and generating funds to support the ALS Association. She appeared today to encourage the adoption of **HB 2727**. (Attachment 6)

Duane Bruce, Attorney, U.S. Department of Health & Human Services, delivered testimony supporting **HB 2727**. Mr. Bruce is a member of the boards of Community Health Charities, the National Sickle Cell Disease Association of America, and the Sickle Cell Disease Association of America. It is with these causes in mind that Mr. Bruce appeals to the committee to consider the passage of **HB 2727**. (Attachment 7)

Nancy Lindquist, patient coordinator for ALS also known as amyotrophic lateral sclerosis or "Lou Gehrig's disease" addressed the committee in support of **HB 2727**. Ms. Lindquist stated that there is little help for those individuals with ALS, however, their Chapter continues to provide all the patient services, education, awareness, and advocacy they can. They urge the passage of **HB 2727**. (Attachment 8)

With no other persons wishing to address **HB 2727**, Chairman Edmonds closed the public hearing.

The Chairman next directed attention to **HB 2541** - No marriage license for persons 15 and under; persons 16 & 17 may have license with parent or judicial consent.

Representative Myers made a motion to pass **HB 2541** favorable for passage. Representative Brunk seconded the motion.

Representative Miller made a substitute motion to increase the age 18 and anyone under 18 not to marry without permission. Representative Loganbill seconded the motion.

After committee discussion regarding increasing the age to 18, Representative Miller withdrew her motion.

Chairman Edmonds returned the original motion to move **HB 2541** our favorable for passage. Motion adopted.

With no further business before the committee, Chairman Edmonds adjourned the committee

Chairman Edmonds and Members of the Committee:

I appreciate the opportunity to appear before the Committee in support of House Bill 2727. The American Lung Association of Kansas is the oldest voluntary health organization in the state and a founding member of Community Health Charities. Your initiative is important to our organization and the clients we serve.

One of every seven people in Kansas suffers from lung disease. It is our job to underwrite research and patient education programs which will treat and cure asthma, allergies, and the host of illnesses and death initiated by tobacco use. HB 2727 will help us continue our work.

It revises Kansas Statute, permitting state employees to earmark payroll deductions for more than one organization. The move hits home: one of our most valuable volunteers, a board member and a nurse at KU Med Center, frequently complained about her inability to contribute to our organization in this way. HB2727 will not only solve her problem but facilitate contributions from other state employees.

We endorse your effort to improve the state's payroll deduction program for several reasons:

First, it provides additional options for the state's 37,000 employees, many of whom cannot currently make gifts to their favorite charities through payroll deductions.

Second, you will be encouraging charitable giving to many established, reputable, voluntary health organizations that cannot currently participate.

Third, you are creating a level playing field for health federations. Organizations that are currently excluded from the program—more than likely the unintended consequence of action taken long ago—will receive needed support.

Like so many of my colleagues, I am grateful that you have taken the initiative in addressing a long-neglected issue. We salute your efforts.

Good afternoon Mr. Chairman and members of the Committee. I appreciate the opportunity to discuss with you HB 2727.

The bill amends existing law concerning charitable organizations to which state employees may elect to contribute through payroll deduction. The bill amends the term “united way organization” to include “other charitable federations which are eligible to be deducted from federal employees payroll pursuant to federal law.”

The provisions of HB 2727 broaden the charitable organizations available in the state workplace to those considered to be “federations” by the federal employee program. HB 2727 would add additional organizations to which state employees could choose to make charitable contributions by payroll deduction. It is unknown how many or if any state employees would take advantage of this program. However if a significant number of the federally eligible charities were selected for payroll deduction it would become burdensome for the State.

Currently, there are 37 United Way organizations available to state employees for charitable deduction, of which 22 receive employee contributions. The Department of Administration, Division of Accounts and Reports is responsible for the voluntary payroll deduction plan for charitable deductions and for remitting the deductions to the various United Way organizations. The United Way groups in turn distribute to individual charities under their umbrella and are responsible for conducting the pledge campaigns at each agency. In calendar year 2005, statewide participation was very low, only about 4.8% of eligible employees. Annual contributions totaled nearly \$559,500, but many of the organizations received very little. One-half of the organizations received less than \$1,000 and 68% received less than \$10,000.

The Department of Administration supports efforts to increase every employee’s ability to contribute to charitable organizations, and we would welcome the opportunity to work with the committee to ensure Legislature intent for additional charitable organizations is met, and to avoid any potential burden on the State of Kansas.

Again, thank you for allowing me to appear before you. I welcome the opportunity to respond to any questions you may have.

The reason we are here today is that like every non-profit in Kansas, our member charities are in need of financial resources to provide medical research, patient services,

and health education. As we all know, the rising cost of health care and the ever-increasing number of Kansans suffering from illnesses has created an influx of requests to our members for funding, medical equipment, support groups and other services for Kansas' families. These member health charities provide a critical link not only in providing funding for new cures and treatments to individuals but also to the Kansas economy.

Fiscal Responsibility & Cost Effective Way for Charities to Raise Funds.

- CHC Overhead cost 1.4%
- Board of Directors - Volunteer board is comprised of corporate and labor representatives, health care professionals and member charities' staff. The board guides the mission, safeguards fiscal responsibility and governs in the public interest.
- CHC acts as fiscal agent for quarterly distribution of donor funds to member charities.

Benefits of Community Health Charities

- Annual member charity evaluation ensures the highest standards of performance and financial integrity.

Let me give you some brief facts about individuals and the level of health in Kansas and across the country.

- 1) There are approximately 20.8 million people in the United States, and 7% of the population have diabetes. While an estimated 14.6 million have been diagnosed, unfortunately, 6.2 million people (or nearly one-third) are unaware that they have the disease. The estimated number of Kansan's with diabetes is **48,189**.
- 2) Over 1,000,000 people died last year due to cardiovascular disease or stroke - that is one person every 33 seconds. The American Stroke Foundation is helping stroke survivor's reclaim their lives. The average stroke survivor spends eight hours a week in their programs. The cost to the American Stroke Foundation is \$2,750 per person yearly. The market value of these services is \$20,800. Providing affordable services is an underappreciated treasure. Many of the survivors share their stories of recovery with others in the program, allowing them to escape the plague of depression and isolation. Together they celebrate the job of drinking a cup of coffee, buttoning a shirt, relearning how to read and have a place to go where others understand.
- 3) An estimated one in 10 people in Kansas over the age of 65 are affected with Alzheimer's disease. The risk for developing the disease doubles every five years after the age of 65 year so that nearly one-half of people after the age of 85 have Alzheimer's. That number has more than doubled since 1980 and will continue to grow at a staggering rate, given the unprecedented growth of the aging population.

Good afternoon! I am the Coordinator for the Topeka Area ALS Support Group and the Event Chairperson for the annual Walk to D'Feet ALS in Topeka. I am also a State of Kansas employee and the surviving spouse of an ALS victim.

My late husband, Joseph "Doug" Kirkman was one of the victims of ALS. In the two years after his diagnosis, he transformed from a healthy, active individual with a successful dental practice into a man who sat in a wheelchair, who was unable to perform any of the activities of daily living (eating, dressing, etc) without assistance, and who relied upon a tube for feeding. As his caregiver, I became all too familiar with the vengeance of this fatal disease.

Since his passing, I have been committed to increasing awareness of ALS and generating funds to support the ALS Association. As you heard from Ms. Lindquist, the ALS Association provides many vital and valuable services to the ALS patients in Kansas and it is funded solely by contributions from individuals, corporations, and foundations. It receives neither funding from local, state or federal entities nor funding from The Jerry Lewis Telethon. Approximately two thirds of the revenue comes from special events and one third from grants, planned gifts, and memorials.

I'm here today to encourage you to adopt House Bill No. 2727 and to approve the ALS Association as an authorized State of Kansas charitable organization. Good afternoon

I am a member of the boards of Community Health Charities, the National Sickle Cell Disease Association of America and the Sickle Cell Disease Association of America, Uriel Owens Chapter of Kansas City, Kansas. It is in those capacities and not that of my position as an employee of the United States Department of Health and Human Services that I appear before you today.

Each year more than 1,000 babies are born in the United States with sickle cell disease and more than 2.5 million people in the United States carry the genetic trait for the disease. Although those with the trait need not fear the disease themselves, as a genetically inherited disease, it is possible that they may pass on the disease to their children. Although the disease primarily affects those of African descent, it is also present amongst the Portuguese, Spanish, French, mainland Italians, Greeks, Turks as well as those of Middle Eastern and Asian descent.

It is with that cause in my heart and that of the other 30 health charities of Community Health Charities that I appeal to you to consider the proposal before you. As a qualified federation under the federal workplace giving campaign, Community Health Charities is well qualified as a federated giving program.

To participate in the Combined Federal Campaign for federal employees' each federation certifies that their member charities meet federal Application guidelines. The following Qualification Guidelines have been revised from other states' guidelines for federation participation in state workplace giving campaigns.

State of Kansas Employees' Campaign
Qualification Guidelines

- Federation organization and each of its member charities must be registered as a non-profit charity according to Section 501©(3) of the Internal Revenue Code.
- Federation organization and all member charities must maintain an active license to solicit through the Attorney General's office for the State of Kansas.
- Federation organization shall be chartered to serve and campaign on behalf of a minimum of ten (10) autonomous charitable charities registered as non-profit charities with the IRS.

- Federation groups must be in existence at least one year before applying to be eligible to participate in campaign.
- Federation organization must supply the state with its most recent audit as well as its most recently completed IRS 990 form.
- Federated organization and each of its member charities must show proof that each has an anti-discrimination clause in regards to hiring practices as well as services offered.
- Participation in the campaign is limited to voluntary, charitable, health and welfare charities that provide support, direct health and welfare services to individuals or their families and which have a direct and substantial benefit to the residents of Kansas.
- Federation groups interested in participation must submit a letter of intent to participate by state deadline each year.
- Each Federation organization and its member charities must report total proceeds, and total administrative, management, general and fundraising expenditures for the prior fiscal year.
- All documentation must be submitted by state deadline each year.

You have heard the voices of compassion seeking for a level playing field in which to make their cause known throughout the Kansas State workplace campaigns. Recognizing Community Health Charities as a charitable federation eligible to participate in Kansas State workplace giving campaigns will give State of Kansas employees a way to support their local health charity of choice that are not included in traditional United Way campaigns. Giving them the ability to contribute to their specific health charity of choice will have a positive impact on their participation and campaign satisfaction as well as the health and health awareness of Kansas residents.

- Patient Services Coordinator for the ALS Association Keith Worthington Chapter
 - I use my training as an RN to coordinate services for those living with ALS, I'm one of 3 Patient Services Coordinators who provide services to individuals, their caregivers and families living in the state of Kansas
 - I've been with the ALS Association since 1999.

Amyotrophic lateral sclerosis (ALS), often referred to as "Lou Gehrig's disease," is a progressive neurodegenerative disease that attacks nerve cells in the brain and spinal cord resulting in muscle weakness and atrophy.

With voluntary muscle action progressively affected, patients in the later stages of the disease may become totally paralyzed. Yet, through it all, for the vast majority of people, their minds remain unaffected.

ALS occurs:

- In 2 out of every 100,000
- 5,600 diagnosed each year, 1 every 90 minutes
- Approximately the same number die each year
- 30,000 people in the US currently with ALS
- 1 in 50 families is affected by ALS

As most of you know, it was Lou Gehrig, a famous Yankee baseball player, the one they called the "iron man" who really brought awareness of the disease. Lou was just 35 when he was diagnosed and then died in 1941 when he was 37. Since that time, ALS has been referred to as Lou Gehrig's disease.

ALS can occur from 20 years of age to well into the 80's, although the most common age of the onset is the mid-50s.

90 – 95% – Sporadic - meaning that anyone can get it
5 – 10% – Familial – meaning that it is inherited

No two persons will experience ALS in exactly the same way.

ALS is a progressive disorder, which means that individuals with ALS will become weaker over time, gradually but steadily. The weakness will occur in new areas as well. The rate of progression varies from person to person and can be slow, moderate, or rapid.

- Between 15% and 25% of people with ALS are alive 10 years after they first notice symptoms – that is slow progression.
- Moderate or average progression is over 2 to 5 years.
- Rapid progression is respiratory failure within a year, which is unusual.

Specifically, ALS brings life to a close sooner than expected, because the diaphragm gradually becomes so weak that the lungs cannot work.

The ALS Association Keith Worthington Chapter provides services to individuals with ALS who live in Kansas, Nebraska and Western Missouri. The main office is in Mission Kansas, branch offices are in Wichita, Omaha and Springfield

Our Chapter is one of the oldest and largest of the 40 ALS Association Chapters nationwide. We have a hard-working, committed, and caring Board of Directors and hundreds of wonderful

To give you a little history –

- Named after Keith Worthington, a Kansas City business executive who was diagnosed with ALS in 1973 at age 40. Because there was so little help for those with ALS at that time, Keith, his wife and friends organized what eventually became this Chapter, providing services and raising funds for research.

The Chapter continues to “carry on the fight” or as we like to say “Cover all the bases” through its programs -- programs such as:

- Patient Services – providing support and resources to the ALS community
- Education - educating those touched by ALS thru a monthly newsletter, website, lending library, and in-services and presentations
- Awareness - raising awareness to the general public
- Advocacy - advocating for the rights of ALS patients, caregivers and families thru on-going visits with legislators

I want to take just a moment to tell you about our patient services. As I mentioned before, ALS is a progressive disease. Helping ALS patients, caregivers and families prepare for each stage of the disease progression allows them to **manage** the disease **instead of crisis reaction**. The physician may make the diagnosis, but we, as health care professionals, guide the patient in management of symptoms, referring and finding outside resources as necessary, and providing much needed support during the entire course of the illness.

- We make significant contact with ALS patients on a regular basis – every 4 to 6 weeks generally, usually more frequent, depending on particular needs. This past year, 2050 significant contacts made to approximately 200 patients in Kansas.
- Our Equipment and Adaptation Program offers 1) the evaluation of patients’ needs for everything from small items such as utensil grips, dressing aides, walkers and bath benches, to full body lifts, scooters, wheelchairs, assistive communication devices and adaptations*, and ramps and other home adaptations that can preserve energy and independence; 2) the identification of the best source of recommended devices and adaptations; and 3) a loan pool of primarily used equipment that can be used if other sources are not available. This year we were able to coordinate more than two hundred fifty pieces of equipment to those living with ALS in Kansas.
- We facilitate support groups for patients, their caregivers and families. This past year in Kansas, we held 7 support group meetings each month with a total of 1125 attending for the year.
- We provide comprehensive information for those newly diagnosed in the form of a New Patient Notebook and a Family and Friends packet. This past year we distributed 66 notebooks to our new Kansas patients and numerous packets to their families and friends.
- We partner with the University of Kansas Medical Center to provide a certified ALS Center. ALS Association Centers (and there are only 20 in the country) are recognized by ALSA as the best in the field with regard to knowledge about and experience in ALS. This past year, over 300 individuals attended the clinic and were seen by professional multidisciplinary team that provided them with comprehensive evaluation and treatment plans designed to maximize their physical function and quality of life. ALSA Centers are also involved in on-going research and drug trials.
