

MINUTES OF THE HOUSE TRANSPORTATION COMMITTEE

The meeting was called to order by Chairman Gary Hayzlett at 1:30 P.M. on February 19, 2007 in Room 519-S of the Capitol.

Chairman Hayzlett called the meeting to order. It was the Chairman's desire to work **HB 2042**.

Representative Swanson made a motion to amend **HB 2042** with **Substitute HB 2042**, Representative Vickrey seconded the motion and the motion to amend **HB 2042** with **Substitute HB 2042** carried. Representative Swanson made a motion to favorably pass **Substitute HB 2042** out of Committee. The motion was seconded by Representative Treaster and the motion carried. The substitute bill came out of a House Transportation subcommittee.

Chairman Hayzlett asked the Committee to work **HB 2119**. The Director of Motor Vehicles pointed out the difference between the registration fees charged to privately owned ambulances which would pay annual registration fees of at least \$40, while publicly owned ambulances would pay a one-time fee of \$6.00, thereby creating a special registration within a special registration type which would also cause law enforcement problems. After discussions a motion was made to strike corresponding language dealing with ambulances. Representative Menghini made a motion to amend **HB 2119**, seconded by Representative Ballard and the motion carried. Representative Long made a motion to favorably pass **HB 2119, as amended**, out of Committee, seconded by Representative Menghini and the motion carried.

The Chairman desired to work **HB 2374**. After a brief review of the bill Representative Humerickhouse made a motion to favorably pass **HB 2374** out of Committee, seconded by Representative King and the motion carried.

The Chairman drew the Committee's attention to Minutes of the February 12th and 13th, 2007 meetings. Representative Worley made a motion to approved the Minutes, seconded by Representative Burgess and the motion carried.

There being no further business to bring before the Committee, the meeting was adjourned. The next meeting will be on February 20, 2007, at 1:30 p.m. in Room 519-S.
