MINUTES OF THE HOUSE COMMERCE AND LABOR COMMITTEE

The meeting was called to order by Chairman Steve Brunk at 9:16 A.M. on January 30, 2008 in Room 784 of the DSOB.

The Chairman introduced Secretary Kerr. He presented some sheets showing an overview of the five divisions within the Kansas Department of Commerce and the Departments 2008 funding sources (Attachment 1).

Representative Grant asked about travel and tourism. Secretary Kerr mentioned a bill to be sponsored by the State Association of Travel Industry. They want to establish a quasi-governmental agency that will have responsibility for travel and tourism. They are suggesting that 4 to 4.5 million dollars be transferred from Commerce to this new agency. They would also be seeking 10 million dollars from other agencies to increase the funding from 5 million to a total to 15 million dollars a year.

Representative Goico mentioned the fact that the workforce in the aircraft industry in Kansas is ageing. What initiative is the Department of Commerce taking to ensure that the aircraft industry continues to have qualified workers? Secretary Kerr agreed that the workforce is an asset and that overall Kansas is very well perceived in regard to the workforce. The only problem we have is in western Kansas. Their unemployment rate is less that 3%. That means they have a labor shortage. We are working very closely with the aviation industry in regard to training the workforce.

Representative Tietze asked if the 5 million dollars for the 2008 Airfare Program was only for the Wichita area. Secretary Kerr indicated that it was primarily for south central and western Kansas. There has been one request for a Salina to Topeka route.

Representative Huntington asked how the money in the Wire Grant was going to be used. The first grant was a 15 million dollar bi-state grant with Missouri which was focused on workforce development and innovation, healthcare and the bio-sciences field. The second Grant of 5 million dollars was for the Wichita area 10 county region focused on composites.

Secretary Kerr returned to his presentation. He called attention to his overview of the Fiscal Year 2007 Highlights of the Department of Commerce (Attachment 2).

Representative Brunk asked about the guidelines for the use of the emergency funds. Secretary Kerr said they are under strict guidelines to use the funds only for employment to clean up the cities. They have been able to convince congress to allow them to expand the program to pay for city inspectors.

Secretary Kerr then presented an overview of the 2008 Legislative Proposal about the Impact Program Enhancements (Attachment 3).

Representative Brunk asked if the training for a company coming to Kansas can be done ahead of time. Secretary Kerr indicated that much of the training could be done before the factory was set up.

Representative Huntington asked how they would direct computer training within a company. They work with the company to develop a plan for internet based training. Are the MSA requirements being eliminated? Those requirements are still in there.

Representative Brunk asked how eliminating the 95% requirement would affect funding. It does not affect the amount of money that Commerce receives. It does affect how much can be given to a particular company. This would allow the Secretary of Commerce to increase the reward to a company where it is justified.

The Secretary continued with The Tax Incentive Package (Attachment 4). He said that it was a re-packaging of HB 2170 that was proposed last year. It involved the establishment of a Tax Credit Program, the creation of Opportunity Zones, replacing existing Tax Credit Programs with Streamlined Investment Tax Credit and Job Creation Credit Plans and Simplifying Qualified Investment Calculation for Investment Based Credits.

Representative Gordon asked how this package compared with the Kansas Inc. plan. The Kansas Inc. plan has included a way to reduce the total taxes paid for the business. Commerce is not opposed to that at all. Secretary Kerr indicated that he did not know what the fiscal note would be for depreciating assets in the first year compared to depreciating them over 5 or 10 years. The question is how expensive it is and how you pay for it.

Representative Huntington asked if Commerce was proposing eliminating 60% of the 452 million in outstanding credits that haven't been used. Secretary Kerr said no it could not be used for anything that was on the books through the end of last year.

Representative Brunk asked what would be the priority in this new legislation. The first priority would be the modifications to the Impact Program. It gives us the tools to make us competitive with other states. A further question was whether or not we have any requirement for the trainee to stay in the state. The packages have a requirement of how long they have to stay in the state. They tend to be 3 to 5 year programs. They are required to stay in the state two years past the end of the program.

The meeting was adjourned at 10:37 A.M. The next meeting is scheduled for January 31, 2008.

Fiscal Year 2007 Highlights

- Commerce was involved in 43 location/expansion/retention projects, which created 6,603 jobs created or retained at an average hourly wage of \$14.29, with \$505 million in capital investment. Commerce was also involved in 204 expansions of existing Kansas companies, which resulted in 6,831 new jobs at an average hourly wage of \$15.24, with \$1.4 billion in capital investment.
- Our training programs Kansas Industrial Training (KIT), the Kansas Industrial Retraining (KIR), and the
 Investments in Major Projects and Comprehensive Training (IMPACT) combined to fund 110 projects at
 \$18.3 million, involving 103 companies in 32 counties. These State funds leveraged \$12.5 million in
 private sector matching funds. Once training is complete, these projects will result in the training of
 9,769 individuals.
- Staff continued to recruit veterans, particularly disabled veterans, into state civil service positions.
 Kansas achieved a 93 percent "Entered Employment Rate" for Vocational Rehabilitation and Employment program participants.
- Kansas was selected as the North American headquarters location for four international companies, including biotech leader OncImmune of England, as well as firms from Germany, India and the Netherlands. Kansas companies took advantage of matching funds through the Kansas International Trade Show Assistance Program (KITSAP) that created opportunities for them to reach new international markets. Thirteen Kansas companies were funded for 13 international trade shows, with sales reported of over \$1.9 million, creating a return on investment of \$109 per dollar expended.
- Commerce continued to facilitate the development of alternative energy production facilities throughout Kansas, including: eight ethanol plants combining for 2,245 million gallons in total annual output; one biodiesel facility with an annual output of 72 million gallons; and two large-scale wind farms.
- Commerce awarded \$420,000 in Value Added Loans to nine Kansas companies, totaling \$147 million in sales, through Agriculture Marketing Development. The department also registered 26 new agritourism vendors, bringing the total number of licensed operators to 221.
- Commerce provided \$24.5 million in federal Community Development Block Grant funds to 95 projects producing \$61 million in private investments benefiting 79,000 Kansans and creating 358 jobs. The department also provided services to 22 designated Main Street cities, which resulted in 172 new or expanded businesses in downtown districts (64 more than last year), 272 new jobs (16 more than last year) and \$32 million in reinvestment in downtown districts (\$13 million more than last year).
- Seven tourism projects received \$120,350 in Attraction Development Grants, resulting in \$358,000 in matching contributions. The Tourism Division also worked with National Geographic magazine photographer Jim Richardson to create a traveling exhibit of 32 photos of the Flint Hills, including those featured in the April issue of the magazine.

2008 Legislative Proposal IMPACT Program Enhancement

> IMPACT - Current Law

- Utilized for Training and Cash Incentives for New or Retained Jobs
- Allows for Use of 2% of Overall Withholding Taxes Collected
- Capacity for Debt Service and Program Fees
 - 2007: \$1.9B of overall withholding taxes; \$39.3M available to service debt (bond payments)
 - 2007: \$13.5M paid for debt service; \$1.5M paid for program fees
- Awards Restricted to 95% of Estimated Withholding Tax for New or Retained Jobs

2008 Legislative Proposal IMPACT Program Enhancement

Recommendation for IMPACT Enhancement

Tax Incentive Package Objectives:

- 1. Establish a Selectively Applied Tax Credit Cash Refund Program
- 2. Establish the Creation of Opportunity Zones
- 3. Replace Existing Tax Credit Programs with Streamlined Investment Tax Credit and Job Creation Credit Plans
- 4. Simplify Qualified Investment Calculation for Investment-Based Credits

1. Establish a Selectively Applied Tax Credit Cash Refund Program

- Applied on a prospective basis only (12/31/07 and after)
- Total amount of appropriation capped at \$10M annually
- Companies may apply for a select number of a discounted cash refund of up to 40% of earned credits
- If awarded and a discounted cash refund is accepted, the remaining amount of company's tax credits would be forfeited
- Application made through Commerce with selection criteria developed through rules & regulations
- Commerce submits annual report to Legislature, detailing the company and total credit awarded

- 2. Establish the Creation of Opportunity Zones to Enhance Investment and Job Creation Credits
 - Mirrors Provisions of HB 2170
 - Established by Secretary of Commerce
 - Comprised of at least one county
 - Economically disadvantaged
 - Outside of designated metropolitan county or micropolitan statistical areas
 - Opportunity Zone Can Be Created in Response to a Disaster Area Designation

Tax Incentive Package

- 3. Replace Existing Tax Credit Programs with Streamlined Investment Tax Credit and Job Creation Credit Plans
 - Investment Tax Credit Set at 10% of qualified investment
 - For–profit businesses
 - Identified under specific NAICS codes or HQ /ancillary support operation
 - Qualified investment
 - Equal or exceeds \$50K for businesses in Opportunity Zones
 - Equal or exceeds \$300K for businesses outside of Opportunity Zones
 - Average wages must exceed regional NAICS code wages
 - Non-manufacturing worksites must generate more than 50% of revenues from Kansas manufacturers or out-of-state commercial or government customers unless an HQ or back-office operation

- 3. Replace Existing Tax Credit Programs with Streamlined Investment Tax Credit and Job Creation Credit Plans
 - Job Credit Creation
 - \$3,500 per new employee with a minimum of 2 new jobs created in an Opportunity Zone
 - \$1,500 per new employee with a minimum of 5 new employees outside of an Opportunity Zone
 - \$1,500 per new employee with a minimum of 20 employees for HQ / ancillary support operations outside of an Opportunity Zone
 - Investment Tax Credit and Job Creation Credit Plans Replace:
 - Enterprise Zone Incentives
 - High Performance Incentive Program (HPIP)
 - and the Business and Job Development credits

- 4. Simplify Qualified Investment Calculation for Investment-Based Credits
- Qualified investment placed in service during taxpayer's tax year
 - Investment must remain in service through the last day of the year
 - Recertification not required for investment or job credits
