The Chairman explained that Secretary of Revenue, Joan Wagnon, could not appear in person today, but we have a tape recording and written material regarding **House Substitute for SB 329**. In the information presented, the secretary requested the following changes by adding the following balloons:

Page 1, line 13 Description of Act. Removes references to K.S.A. 8-240 and K.S.A. 8-1324.

Page 2, line 3 New Sec 1. Specifically exclude driver's licenses from the definition of "License" used for this bill.

Page 2, line 41 New Section one. Specifically excludes driver's licenses and nondriver identification cards from the definition of "identification document," for purposes of this Act.

Page 6, line 25 New Sec 5. Specifically excludes driver's licenses and nondriver's identification cards from the sections' definition of "public benefit."

Pages 8, 9, 10, 11 Section 9 removed. Any reference and changes to K.S.A. 2007 Supp. 8-240 is removed.

Pages 11, 12, 13, 14 Section 10 removed. Any references and changes to K.S.A. 2007 Supp. 8-1324 is removed.

Pages 20, line 25-26 Section 18. References to K.S.A. 2007 Supp. 8-240 and K.S.A. 2007 Supp. 8-1325 are removed.

Representative Peterson moved the adoption of the balloon amendment for **House Substitute for SB 329** offered by the Secretary of Revenue and Representative Loganbill seconded the motion. Motion failed 12 to 11.

Representative Kinzer moved to divide the amendment and vote on each section separately to vote on Section 9 and 10 separately.

Representative Dillmore moved to strike lines 25-31 and 37 through 41 in Section 9 of **House Substitute for SB 329**. The motion was seconded by Representative Peterson. After a lengthy discussion by the Committee, the Chairman called the question. The motion passed by a vote of 14 yeas, 8 nays.

Representative Loganbill asked for a conceptual amendment to strike all of New Section 4, seconded by Representative Mah. After discussion, by a vote of 12 yeas and 9 nays, the motion failed.

Representative Mah moved that Sections 8 through 20 from **HB 2680** be placed in the House Substitute for **SB 329**. The motion was seconded by Representative McCray-Miller. Motion passed.

The meeting was adjourned until 5:30 p.m. on March 12, 2008.
